DECLARATION OF DAVID NEIER, ESQ. IN SUPPORT OF APPLICATION FOR ORDER AUTHORIZING EMPLOYMENT OF WINSTON & STRAWN LLP AS COUNSEL TO THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS EFFECTIVE AS OF JANUARY 5, 2010

- I, David Neier, hereby declare:
- I am an attorney at law admitted and in good standing to practice in the State of New York. I am a partner of Winston & Strawn LLP ("Winston & Strawn") and resident in its New York, New York office.
- 2. I make this declaration (this "Declaration") pursuant to section 1103 of title 11 of the United States Code, as amended (the "Bankruptcy Code"), Rule 2014 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules") and Rule 2014-1 of the Local Rules for the United States Bankruptcy Court for the District of Delaware (the "Local Rules") in support of the Application (the "Application") for an order authorizing the employment of Winston & Strawn as counsel to the Official Committee of Unsecured Creditors (the "Committee") of TLC Vision (USA) Corporation and certain of its affiliates, debtors and debtors-in-possession (collectively, the "Debtors"), effective as of January 5, 2010. Unless

otherwise stated, I have personal knowledge² of the facts set forth in this declaration. All capitalized terms used but not otherwise defined herein shall have the meaning assigned to them in the Application.

Qualifications of Professionals

- 3. Winston & Strawn was selected as Committee counsel on January 5, 2010, as set forth in the Application submitted herewith and signed by the Chair of the Committee.
- 4. Winston & Strawn, founded in 1853, is one of the nation's oldest and largest law firms. With over 900 attorneys, domestic offices in Charlotte, Chicago, Los Angeles, Newark, New York City, San Francisco, and Washington, D.C., and international offices in Geneva, Hong Kong, London, Paris, Shanghai, Beijing and Moscow, the firm provides a full range of legal services to clients throughout the United States and abroad, including Fortune 500 companies, major commercial and financial institutions, governments and governmental entities, as well as small and midsize companies, individuals and entrepreneurs in virtually every industry.
- 5. Winston & Strawn has an extensive restructuring and insolvency practice, representing committees, creditors, debtors and other parties-in-interest in cases under the Bankruptcy Code, state and federal insolvency and receivership proceedings, and out-of-court debt restructuring and workouts. Winston & Strawn's Restructuring and Insolvency Group has over 30 full- or part-time members. In addition to the attorneys who specialize in restructuring and insolvency law, Winston & Strawn has the resources to call upon attorneys with experience in areas of the law such as employment relations, tax, securities, intellectual property, corporate, finance, and litigation, to deal with issues that may arise in the Debtors' cases (the "Cases") and

under the Bankruptcy Code.

Prior Employment

6. Winston & Strawn did not provide the Committee or any other organized group of creditors of the Debtors with legal services related to this matter prior to

January 6, 2010. Winston & Strawn has not received any payment for services rendered to the Committee.

Services to be Rendered

- 7. The Committee has requested that Winston & Strawn render the following services in these Cases:
 - a. Provide legal advice to the Committee with respect to its duties and powers in the Cases;
 - b. Consult with the Committee and the Debtors concerning administration of the Cases;
 - c. Assist the Committee in its investigation of the acts, conduct, assets, liabilities, and financial condition of the Debtors, operation of the Debtors' businesses and the desirability of continuing or selling such businesses and/or assets, sales under 11 U.S.C. § 363, the formulation and confirmation of a chapter 11 plan, and any other matter relevant to the Cases;
 - d. Assist the Committee in evaluating claims against the estates, including analysis of and possible objections to the validity, priority, amount, subordination, or avoidance of claims and/or transfers of property in consideration of such claims;

- e. Assist the Committee in participating in the formulation of a chapter 11 plan, including the Committee's communications with unsecured creditors concerning any such plan;
- f. Assist the Committee with any effort to request the appointment of a trustee or examiner;
- g. Advise and represent the Committee in connection with matters generally arising in the Cases, including the obtaining of credit, the sale of assets, and the rejection or assumption of executory contracts and unexpired leases;
- h. Appear before this Court, any other federal court, state court or appellate court; and
- Perform such other legal services as may be required and which are in the interests of unsecured creditors or otherwise directed by the Committee.
- 8. Subject to this Court's approval of the Application, Winston & Strawn is willing to serve as the Committee's counsel and to perform the services described above.

 Based upon its experience and expertise, Winston & Strawn is well qualified to represent the Committee.

Parties Searched for Connections

9. In connection with the Application and this Declaration, Winston & Strawn took the following actions to ensure compliance with the requirements of the Bankruptcy Code, the Bankruptcy Rules, the Local Rules of this Court and other applicable rules, regulations and guidelines with respect to the retention and employment of professionals:

- a. Using information provided by the Debtors and their counsel, Winston & Strawn compiled a list of significant parties involved in the Debtors' Cases. The list includes all of the following: (a) Committee members; (b) the Debtors and their non-debtor affiliates; (c) secured lenders to the Debtors; (d) the thirty largest general unsecured creditors of the Debtors (other than Committee members); (e) current directors and officers of the Debtors; (f) utility providers to the Debtors; (g) professionals representing various constituents; (h) depository and disbursement banks used by the Debtors; (i) holders of the Debtors' equity securities; (j) judges for the United States Bankruptcy Court for the District of Delaware; and (k) trustees employed by the Office of the United States Trustee for the District of Delaware (collectively, the "Bankruptcy Parties List"). A copy of the Bankruptcy Parties List is attached as Schedule 1 to this Declaration.
- b. Winston & Strawn conducted a search of its client database (the "Client Database"), comprised of the names of each current client and certain former clients, the names of parties who are or were related or adverse to such current or former clients, and the names of the Winston & Strawn personnel who are or were principally responsible for the current or former matters for such clients to identify any potential match with a person or entity on the Bankruptcy Parties List.
- c. Winston & Strawn reviewed the matches between the Client Database and the persons or entities identified on the Bankruptcy Parties List and

- eliminated obvious name coincidences. The remaining client representations and connections were compiled for purposes of this Declaration and are attached hereto as Schedule 2.
- 10. Winston & Strawn sent an e-mail to all Winston & Strawn attorneys advising them of Winston & Strawn's intent to represent the Committee as described above and requesting that each attorney advise whether such attorney is aware of any client or representation of Winston & Strawn that is adverse to the parties on the Bankruptcy Parties List.
- 11. To the best of my knowledge and as qualified in its entirety by this

 Declaration (including Schedule 2 hereto), after the investigation described above, Winston &

 Strawn does not hold, or represent any entity holding, an interest adverse to its representation of
 the Committee in these Cases.

Connections of Winston & Strawn

- 12. To the best of my knowledge and based on the investigation described above, Winston & Strawn does not currently represent any clients (other than the Committee) in connection with the Debtors or these Cases.
- 13. Winston & Strawn in the past has represented or been adverse to, currently represents or is adverse to, and in the future likely will represent or be adverse to certain creditors of the Debtors and other parties-in-interest or affiliates thereof in matters wholly unrelated to the Debtors, the Debtors' Cases or such entities' claims against or interests in the Debtors. As of the date of this Declaration, I am aware that Winston & Strawn may represent or be adverse to, or may have represented or been adverse to and/or may in the future represent or be adverse to those entities (or affiliates) listed on Schedule 2 (each, an "Interested Party") regarding matters wholly unrelated to these Cases.

- 14. Winston & Strawn makes the following additional disclosures out of an abundance of caution. The following representations are unrelated to the Debtors' insolvency proceedings and occurred more than three (3) years prior to the Petition Date.
 - a. During 2005, Winston & Strawn represented NovaMed, Inc. in connection with a potential bid by TLC Vision Corporation to acquire NovaMed, Inc.; the matter was formally closed in October 2007 due to the cessation of active representation, and no services in connection with the representation were billed after August 2005.
 - b. Since June 1997 and continuing to the present, Winston & Strawn has represented JPMorgan Chase Bank, N.A. in connection with a loan transaction with Comdisco, Inc., over which period James J. Hyland, an officer of the Debtors, may have been an officer of Comdisco, Inc. In addition, between June 2005 and December 2006, Winston & Strawn represented JPMorgan Chase Bank, N.A. in a purported class-action securities lawsuit, in which a certain "James J. Hyland" was named as a potential litigant, and Winston & Strawn has been unable to determine whether such individual was the Debtors' officer. In any event, no services were billed in connection with this representation after December 2006.
- above, Winston & Strawn is not aware of any claims that the Debtors or Debtors' estates have against a client of Winston & Strawn which is an Interested Party arising out of an Interested Party's prepetition relationship with the Debtors. If Winston & Strawn should come into

possession of information that would suggest the existence of a potential claim against a Winston & Strawn client, Winston & Strawn will advise the Committee of such information to the extent it would not violate any ethical guidelines and, to the extent necessary or appropriate, either seek a waiver from the Interested Party or recommend that the Committee request that conflicts counsel represent the Committee exclusively as to the pursuit of such claims if such claims are to be pursued by the Committee.

- 16. Winston & Strawn will not provide any professional services to any of the Interested Parties respecting these Cases.
- 17. Accordingly, and except as set forth in the last sentence of this paragraph, Winston & Strawn has not obtained, and does not at this time intend to obtain, written waivers from any creditors of the Debtors or Interested Parties, whom Winston & Strawn currently represents on matters unrelated to the Debtors or their chapter 11 Cases. To the extent a waiver becomes necessary or is requested and obtained, Winston & Strawn will file a supplemental disclosure with the Court. In addition, Winston & Strawn's co-counsel may act as conflicts counsel for the firm if necessary in these Cases.
- above, no attorney of Winston & Strawn is related to any United States District Judge or United States Bankruptcy Judge in this District or to the United States Trustee for Region 3 or any employee in the office thereof. Winston & Strawn currently represents interested parties in various other bankruptcy proceedings before the United States Bankruptcy Court for the District of Delaware and its respective Judges and in which employees of the United States Trustee for Region 3 may be involved.

19. Notwithstanding the foregoing, and in addition to the disclosures set forth herein and on Schedule 2, Winston & Strawn has also in the past, presently, and/or may in the future represent, be adverse to, or work with many of the firms or individuals rendering professional services in these Cases or clients thereof in connection with matters wholly unrelated to these Cases, including, but not limited to, the following professionals: Conway Del Genio Gries & Co, LLC; Morris Anderson & Associates Ltd.; Torys LLP; Richards, Layton & Finger, P.A.; Bingham McCutchen LLP; Gordian Group LLC; Alvarez & Marsal LLP; and Morris James LLP.

Disinterestedness of Professionals

- 20. Winston & Strawn is a "disinterested person" as that term is defined in section 101(14) of the Bankruptcy Code, as modified by section 1107(b) of the Bankruptcy Code such that, to the best of my knowledge and belief, Winston & Strawn and each of its members, counsel and associates:
 - a. is not or was not a creditor, an equity security holder or an insider of the
 Debtors;
 - is not or was not within 2 years before the date of the filing of the petition,a director, officer, or employee of the Debtors; and
 - c. does not have an interest materially adverse to the interest of the estates or of any class of creditors or equity security holders, by reason of any direct or indirect relationship to, connection with, or interest in the Debtors or for any other reason.
- 21. In the event that the information disclosed herein requires modification, or additional information becomes available to Winston & Strawn with respect to any other

significant relationship, connection or conflict which may exist between Winston & Strawn, its partners, counsel and associates and the Debtors, a creditor or other party-in-interest or any other potentially adverse party, which may affect these Cases, Winston & Strawn will file a supplemental disclosure with the Court.

22. Based upon the foregoing, Winston & Strawn believes that it may act as counsel for the Committee pursuant to section 1103 of the Bankruptcy Code.

Professional Compensation

- 23. Winston & Strawn has not received any advance fee or retainer for legal services.
- 24. The customary hourly rates of Winston & Strawn in its United States offices, subject to periodic adjustment, are: for partners, from \$420.00 to \$1,075.00; for associates, from \$295.00 to \$610.00; and for legal assistants, from \$105.00 to \$310.00 in its United States offices. The hourly rates charged by Winston & Strawn professionals differ based upon, among other things, each professional's level of experience and the rates normally charged in the location of the office in which each professional resides. As of the date of this declaration, the customary hourly rates of Winston & Strawn for the persons most likely to be engaged in this matter are as follows:

- 25. Fees for professional services of Winston & Strawn are based, in part, on its guideline hourly rates, which are periodically adjusted in the normal course of the firm's business, often due to the increased experience of a particular professional.
- 26. Consistent with Winston & Strawn's policy with respect to its other clients, Winston & Strawn will continue to charge reasonable expenses incurred in the rendition of services, subject to the Bankruptcy Code, Bankruptcy Rules, and any local rules or guidelines applicable to these Cases. These expenses include, among other things, costs for telephone charges, photocopying, travel, business meals, computerized research, messengers, couriers, postage, witness fees and other fees related to trials and hearings.
- 27. Winston & Strawn intends to apply to the Court for allowance of compensation for professional services rendered and reimbursement of expenses incurred in these Cases in accordance with applicable provisions of the Bankruptcy Code, the Bankruptcy Rules, the Local Rules, the Guidelines of the Office of the United States Trustee and the orders of this Court.
- 28. Regardless of the time and manner of interim compensation, Winston & Strawn understands that, subject to this Court's orders, Winston & Strawn will be required to

follow the procedures for final allowance of fees at the end of the Cases, or the conclusion of its representation of the Committee, under section 330 of the Bankruptcy Code.

29. Winston & Strawn has agreed to accept as compensation such sums as may be allowed by the Court on the basis of the professional time spent, the rates charged for such services, the necessity of such services to the administration of the estates, the reasonableness of the time within which the services were performed in relation to the results achieved, and the complexity, importance, and nature of the problems, issues or tasks addressed in these Cases.

30. Other than as set forth above, no arrangement is proposed between the Committee, any creditor or other party-in-interest and Winston & Strawn for compensation to be paid in these Cases.

31. Except for arrangements among the members of Winston & Strawn and as permitted under section 504(b)(1) of the Bankruptcy Code, Winston & Strawn has no agreement with any other entity to share any compensation received, nor will any sharing be made.
