**ORDER SUSTAINING REORGANIZED DEBTORS' TWELFTH
OMNIBUS OBJECTION TO LATE FILED CLAIMS
(Relates to Dkt. Nos. 1239, 1435, and 1752)**

ON THIS DATE, the Court considered the *Reorganized Debtors' Twelfth Omnibus Objection to Allowance of Late Filed Claims* as modified by the *Reorganized Debtors' Motion (I) to Withdraw Objections to Certain Claims Identified on the Twelfth Omnibus Objection; and (II) for Rehearing on Balance of Claims Remaining on the Twelfth Omnibus Objection* (Dkt. No. 1435) and the *Order Granting Reorganized Debtors' Motion (I) to Withdraw Objections to Certain Claims Identified on the Twelfth Omnibus Objection; and (II) for Rehearing on the Balance of Claims Remaining on the Twelfth Omnibus Objection* (Dkt. No. 1752) (the "Objection"). The Court finds that (a) the Court has jurisdiction over the matters raised in the Objection pursuant to 28 U.S.C. §§ 157 and 1334; (b) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); (c) proper and adequate notice of the Objection has been provided and that no further notice is necessary; and (d) the Objection should be sustained. Therefore, it is

ORDERED that the Objection is **SUSTAINED**; it is further

ORDERED that all responses in opposition to the Objection, not withdrawn or otherwise resolved, are overruled; it is further

ORDERED that the claims listed on **Exhibit A**, attached hereto, (the "Claims") are hereby disallowed in their entirety for all purposes; it is further;

ORDERED that nothing in the Objection or Order shall be construed as a waiver of any rights that the Reorganized Debtors may have: (a) to bring any other actions against the claimants subject to the Objection; or (b) to exercise their rights of setoff against the holders of such Claims relating to avoidance actions; it is further

ORDERED that Epiq Bankruptcy Solutions, LLC, as the Debtors' notice and claims agent, is hereby directed to amend the Reorganized Debtors' register of claims to reflect the effect of this Order; and it is further

ORDERED that this Court retains jurisdiction with respect to all matters arising from, based upon, or related to the implementation of this Order.
