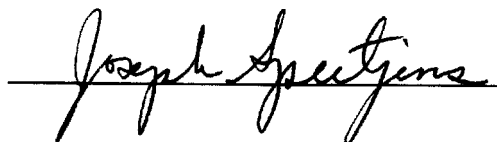

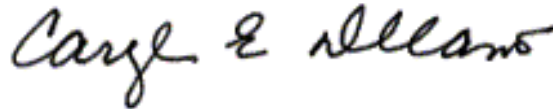
ORDERS as follows:
