support of the United States Trustee's Application For An Order Approving the Appointment of a Chapter 11 Trustee [Docket No. 380], and to demonstrate that I am eligible to serve as Chapter 11 Trustee in these cases under section 1104(d) of title 11 of the United States Code, 11 U.S.C. §§ 101-1532 (the "Bankruptcy Code") and Rule 5002 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), I filed my Declaration Regarding Eligibility for Appointment of Chapter 11 Trustee and Appointment of Shearman & Sterling as Trustee's Counsel, on January 7, 2011 (the "Initial Declaration"). - 3. I submit this third supplemental declaration (this "Third Supplemental Declaration") in furtherance of the representation I made in paragraph 20 of my Initial Declaration that "[i]f I. . . learn[] that [I have] a relationship with, or [have] represented, a party in interest in these cases, I will supplement this declaration immediately and promptly notify the United States Trustee."
- 4. To the best of my knowledge, I continue to be a "disinterested person" under section 101(14) and 327 of the Bankruptcy Code and sections 101(14) and 1104(d) of the Bankruptcy Code, respectively, and continue to satisfy Bankruptcy Rule 5002.
- 5. After submitting my Initial Declaration, my First Supplemental Declaration and my Second Supplemental Declaration, I joined Morgan Lewis.
