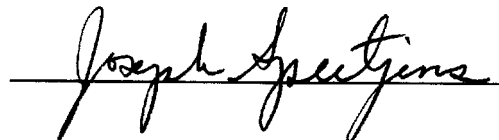

**ORDER ON MOTION FOR RECONSIDERATION OF ORDER DENYING
MOTION FOR ALLOWANCE OF ADMINISTRATIVE EXPENSE CLAIM
OF WELLS FARGO**

This matter is before the Court on the Motion for Reconsideration of Order Denying Motion for Allowance of Administrative Expense Claim of Wells Fargo ("Motion") filed by Wells Fargo Bank, N.A., Wells Fargo Equipment Finance, Inc., and Wachovia Financial Services, Inc. a/k/a First Union Commercial Corporation (collectively "Wells Fargo"). The Motion has been joined by KeyBank National Association, Key Equipment Finance Inc., AIG Commercial Equipment Finance, Inc., and Comerica Leasing (collectively "Secured Lenders"). The Court has reviewed the Motion and Joinder and finds that good cause exists to allow Wells Fargo and the Secured Lenders to present evidentiary support for the Motion and the Motion for Allowance of Administrative Expense Claim filed by Wells and the Secured Lenders on December 15, 2011 [Docket #2135] ("Administrative Expense Motion"). Since the Motion and the Administrative Expense Motion are uncontested, any evidence submitted by Wells or the Secured Lenders would not be subject to cross-examination. Accordingly, it is

ORDERED that Wells and the Secured Lenders shall file, by July 13, 2012, any affidavits, other sworn or verified statements or declarations, or authenticated exhibits in support of the Motion and the Administrative Expense Motion, which the Court will consider in the same manner as it would consider evidentiary material in support of a motion for summary judgment under Fed. R. Civ. P. 56(c)(4).
