FINAL DECREE

WHEREAS, on February 1, 2011, Southwest Georgia Ethanol, LLC (the “Reorganized Debtor”) filed a voluntary petition under Chapter 11 of Title 11 of the United States Code in the United States Bankruptcy Court for the Middle District of Georgia; and

WHEREAS, a Plan of Reorganization was proposed to the creditors, and said Plan of Reorganization was confirmed by Order of this Court on December 9, 2011; and

WHEREAS, the Reorganized Debtor has reported to this Court that it has substantially consummated the Plan of Reorganization; and

WHEREAS, Bankruptcy Rule 3022 provides for the entry of a Final Decree; it is therefore:

ORDERED that the Final Report of the Reorganized Debtor is approved, and the Application for Final Decree be and is hereby granted; and it is further

ORDERED that this Final Decree shall be effective twenty-eight days after the date of entry and the case closed without further order of this Court, unless prior to the effective date a party in interest files with the Court a motion objecting for cause to the Final Decree. Upon such filing, the objecting party shall immediately serve notice on the Reorganized Debtor and the case shall remain open pending a hearing on the motion. The Reorganized Debtor's Final Report and Application for Final Decree are on file with the Office of the Clerk of Bankruptcy Court and may be examined during normal business hours.


