PLEASE TAKE NOTICE OF THE FOLLOWING:

Executory Contracts and Unexpired Leases to be Assumed or Assumed and 1. **Assigned.** Pursuant to Section 10.2(a) of the Debtors' Joint Plan of Reorganization Under Chapter 11 of the Bankruptcy Code (the "Plan"), Pinnacle Airlines Corp. and those of its subsidiaries that are debtors and debtors in possession (collectively, the "**Debtors**") have filed a version of Schedule 10.2(a) to the Plan listing executory contracts and unexpired leases they currently intend to assume or assume and assign. Subject to the consent of Delta Airlines, Inc., the Debtors may amend Schedule 10.2(a) on or prior to 3:00 p.m. on the Business Day immediately prior to the commencement of the Confirmation Hearing in order to add, delete or reclassify any executory contract or unexpired lease and amend the Proposed Cure and proposed assignment with respect to any executory contract or unexpired lease to be assumed, subject to certain extensions, limitations and exceptions. - 2. **Proposed Cure Amounts.** Section 365(b)(1)(A) of the Bankruptcy Code requires that the Debtors cure or provide adequate assurance that they will promptly cure defaults under executory contracts and unexpired leases at the time of assumption. The Debtors have determined the amounts required to cure pre-petition defaults under the executory contracts and unexpired leases (collectively, the "**Proposed Cures**") based on the Debtors' books and records and related documents. Unless you properly file and serve a Treatment Objection by the Treatment Objection Deadline, and subject to the Debtors' right to amend Schedule 10.2(a), the executory contracts and unexpired leases identified on Annex A shall be deemed assumed (and, if applicable, assigned) effective as of the Assumption Effective Date specified on Annex A, and the Proposed Cure specified on Annex A shall be the Cure and shall be deemed to satisfy fully any pre-petition

obligations the Debtors might have with respect to such executory contract or unexpired lease under section 365(b) of the Bankruptcy Code. A Treatment Objection with respect to some, but not all, of your executory contracts or unexpired leases with the Debtors shall have no impact on the assumption, assumption and assignment or rejection of the other executory contracts and unexpired leases to which you are a party, and such executory contracts and unexpired leases may be deemed assumed, assumed and assigned or rejected notwithstanding such Treatment Objection in accordance with the provisions of the Plan.

- 4. **Consensual Resolution of Disputes.** The Debtors request that any party that disputes the assumption or assumption and assignment of an executory contract or unexpired lease, a proposed Assumption Effective Date or a Proposed Cure contact the Debtors prior to the Treatment Objection Deadline to attempt to resolve such dispute consensually. - 5. **Hearing.** If you timely file and serve a Treatment Objection and the parties are unable to resolve the dispute regarding the Proposed Cure, the proposed Assumption Effective Date or other matters pertaining to the assumption or assumption and assignment of your executory contract or unexpired lease after a reasonable period of time, a hearing will be scheduled in accordance with Section 10.5(c)(ii) of the Plan. If the Bankruptcy Court approves the assumption of your executory contract or unexpired lease notwithstanding a Treatment Objection, then unless the Bankruptcy Court expressly orders otherwise or the parties so agree, the assumption shall be effective as of the Assumption Effective Date specified on Annex A.
- 6. **Reservation of Rights.** If you file a Treatment Objection with respect to any executory contract or unexpired lease listed on Annex A, both the Debtors and the Reorganized Debtors reserve the right (i) to seek to reject such agreement at any time before the assumption or assumption and assignment or Cure with respect to such agreement is determined by Final Order and (ii) to the extent a Final Order is entered resolving a dispute as to Cure or the permissibility of assignment (but not approving the assumption of the executory contract or unexpired lease sought to be assumed), to seek to reject such agreement within 14 calendar days after the date of such Final Order.
- 7. **Payment of Cure Amount.** Unless otherwise agreed, any Cure shall be paid as soon as reasonably practicable following the Effective Date of the Plan or entry of a separate Final Order approving the relevant assumption (or, if applicable, assumption and assignment). Upon payment in full of the Cure, all Proofs of Claim based upon these assumed contracts or leases shall be deemed disallowed and expunged.
