**ORDER GRANTING TRUSTEE’S MOTION FOR AUTHORITY
TO SELL PROPERTY OF THE ESTATE FREE AND CLEAR OF ALL
LIENS, CLAIMS, INTERESTS AND ENCUMBRANCES
PURSUANT TO 11 U.S.C. §§ 363(b) AND (f)**

The Court has considered the Trustee’s *Motion for Authority to Sell Property of the Estate Free and Clear of all Liens, Claims, Interests and Encumbrances Pursuant to 11 U.S.C. §§ 363(b) and (f)* (the “*Motion*”). Based upon the representations of the Trustee, the Court is of the opinion that the Motion should be granted. The Court finds as follows:

1. The sale of the bankruptcy estate’s rights and interests, if any, in the 2011 Ortho Clinical Diagnostics Vitros 5600 Chemistry Analyzer (the “*Analyzer*”) to RRC Medical Real Estate, LLC (the “*Buyer*”) for the sum of \$10,000.00 is in the best interest of the Debtor, its estate, its creditors, and other parties in interest.

2. The notice of the Motion is proper and complies with applicable bankruptcy law and rules under the circumstances of this case, and no further notice is required.

Based upon the foregoing Findings of Fact, it is, therefore

ORDERED that the Trustee’s Motion is **GRANTED**. It is further

ORDERED that the terms of the sale to the Buyer are as follows:

- a. RRC Medical Real Estate, LLC will pay \$10,000.00 in good funds for the estate's rights and interest, if any, in the Analyzer.
- b. RRC Medical Real Estate, LLC shall purchase the estate's rights and interest, if any, in the Analyzer by bill of sale, on an "AS-IS WHERE-IS" with no representation or warranty of any kind, express or implied.
- c. Payment from RRC Medical Real Estate, LLC will be due no later than the fifteenth (15th) day after entry of an Order approving the sale.
- d. RRC Medical Real Estate, LLC will retrieve the Analyzer within ten (10) days thereafter.

It is further

ORDERED that the sale of the estate's rights and interest, if any, in the Analyzer shall be made by bill of sale, on an as-is where-is basis with no representation or warranty of any nature by the Trustee, free and clear of all liens, claims and other encumbrances of any kind or character, with any valid liens to attach to the net sales proceeds, subject to the Trustee's avoidance powers, to the extent necessary. The Buyer shall be responsible for all closing costs, if any. It is further


ORDERED that the Trustee is hereby authorized to execute all instruments and documents and to perform all other actions necessary to consummate the transaction contemplated under the Motion and this Order. It is further

ORDERED that any person or entity served with the Trustee's Motion who claims a lien on or interest in the Analyzer must file a written notice with the Court and serve it on the Trustee no later than 30 days after entry of this Order or be forever barred from asserting such lien or claim.

ORDERED that the terms and provisions of this Order shall be binding in all respects upon, and shall inure to the benefit of Montgomery County Management Company, PLLC, its estate, its creditors, the Buyer, and their respective successors and assigns, including without limitation, any subsequent Trustee appointed for the Debtors in their chapter 7 cases, and any affected third parties,


