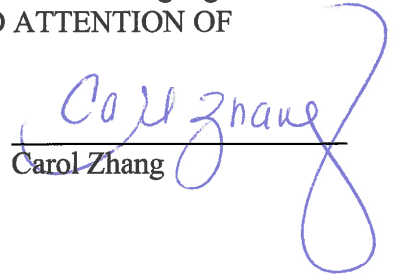

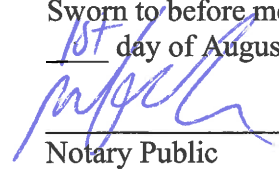

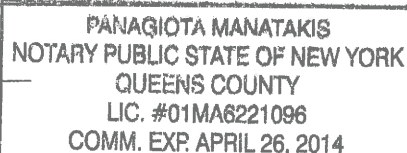

**NOTICE OF ASSUMPTION OF EXECUTORY CONTRACTS AND
UNEXPIRED LEASES OF NON-RESIDENTIAL REAL PROPERTY, CURE
AMOUNT, AND ADEQUATE ASSURANCE OF FUTURE PERFORMANCE**

PLEASE TAKE NOTICE OF THE FOLLOWING:

1. On June 13, 2013, Rotech Healthcare Inc. ("Rotech") and its title 11 subsidiaries, as chapter 11 debtors and debtors in possession (collectively, the "Debtors"), filed the *Debtors' Second Amended Joint Chapter 11 Plan* [Docket No. 512] (the "Plan").²

2. On June 14, 2013, the Bankruptcy Court entered that certain *Order (I) Approving Notice of Disclosure Statement Hearing, (II) Approving Disclosure Statement, (III) Fixing Voting Record Date, (IV) Scheduling Plan Confirmation Hearing and Approving Form and Manner of Related Notice and Objection Procedures, (V) Approving Solicitation Packages and Procedures for the Distribution Thereof, (VI) Approving Forms of Ballots and Voting Procedures, (VII) Approving Form and Manner of Notices to Non-Voting Plan Classes, (VIII) Fixing Voting Deadline, and (IX) Approving Vote Tabulation Procedures* [Docket No. 518] (the "Disclosure Statement Order"). Pursuant to the Disclosure Statement Order, the last date for holders of Claims entitled to cast a ballot to either accept or reject the Plan is August 8, 2013 at 5:00 p.m. (the "Voting Deadline")

3. On June 10, 2013, each of the Debtors filed their respective Schedules of Assets and Liabilities (collectively, the "Schedules") with the Bankruptcy Court [Docket Nos. 374 to 488]. Each of the Schedules contained a "Schedule G" which listed the individual Debtor's executory contracts and unexpired leases.

² Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the Plan.

4. Pursuant to section 13.8 of the Plan, the Debtors are required to file a “Plan Supplement” ten (10) days prior to the Voting Deadline (the “Plan Supplement”). Among other things, the Plan Supplement is to contain the exhibits and schedules to the Plan that are not served with the Disclosure Statement upon holders of Claims and Equity Interests in connection with the solicitation of votes to accept or reject the Plan and shall be in all respects in form and substance satisfactory to the Consenting Noteholders. See Plan at § 1.2.102.

5. On July 29, 2013, the Debtors filed the *Plan Supplement to Debtors’ Second Amended Joint Chapter 11 Plan* [Docket No. 770].

6. Schedule 7.1 of the Plan Supplement lists executory contracts and unexpired leases of non-residential real property (collectively, the “Assumed Contracts”) that will be assumed if the Plan is confirmed by the Bankruptcy Court, subject to certain limited exceptions expressly provided for in the Plan.

7. Pursuant to section 365 of the Bankruptcy Code, when a executory contract or unexpired lease is assumed, and if there has been a default under such contract or lease, the Debtors must cure the default and compensate for any actual pecuniary losses resulting from such default (collectively, the “Cure Obligations”), and provide adequate assurance of future performance under such contract or lease. Schedule 7.1 to the Plan Supplement sets forth the amount each Debtor shall pay to fulfill Cure Obligations and assume the Assumed Contracts (the “Cure Amount”).

8. You are receiving this notice because (i) your contract or lease is listed on Schedule G of one or more of the Debtors’ Schedules and (ii) you are listed as a counterparty to an Assumed Contract listed on Schedule 7.1 of the Plan Supplement. You should review Schedule 7.1 of the Plan Supplement, identify the Assumed Contract, and review the corresponding Cure Amount.

9. The procedures for disputes or objections to the assumption, proposed Cure Amount, adequate assurance of future performance, or other issues related to the assumption of the Assumed Contracts (each, a “Cure Amount/Assumption Objection”) are set forth in section 7.2 of the Plan. In general, a Cure Amount/Assumption Objection must be in writing and set forth with specificity the nature of the objection and the cure amount that the objecting party believes should be paid in connection with the assumption of the Assumed Contract (the “Claimed Cure Amount”) and be filed with the Bankruptcy Court and served upon Counsel to the Debtors listed below **within fifteen (15) days of the date of this notice**.³ If you fail to file a Cure Amount/Assumption Objection (i) your contract or lease will be assumed upon confirmation of the Plan, (ii) you will receive the Cure Amount listed in Schedule 7.1, and (iii) you will be deemed to have been provided adequate assurance of future performance under such contract or lease.

10. A copy of the Plan and Plan Supplement can be obtained by (a) contacting the Debtors’ voting and solicitation agent, Epiq Bankruptcy Solutions, LLC, by telephone at (646)

282-2400; or (b) downloading the Plan or Plan Supplement (i) without charge at <http://dm.epiq11.com/rotech> or (ii) for a fee at the Bankruptcy Court's website, located at www.nysb.uscourts.gov (a PACER login and password are required and can be obtained through the PACER Service Center at www.pacer.psc.uscourts.gov).

11. The Debtors reserve their rights under the Plan to amend Schedule 7.1 of the Plan Supplement, including their right to add or remove any executory contracts and/or unexpired leases of non-residential real property from Schedule 7.1 of the Plan Supplement up until the commencement of the Confirmation Hearing.
