ORDER CONFIRMING JOINT PLAN OF REORGANIZATION FOR
A HANDY CORPORATION
B HANDY CORPORATION
C HANDY CORPORATION

On June 20, 2013 (the "Petition Date"), A Handy Corporation, B Handy Corporation, and C Handy Corporation (collectively, the "Handy Debtors") filed voluntary petitions for relief under chapter 11, Title 11 of the United States Code (the "Bankruptcy Code") in the United States Bankruptcy Court for the Southern District of Texas (the "Court"). On March 26, 2014, the Handy Debtors filed their First Amended Plan of Reorganization [Dkt. No. 1261] (the "First Amended Plan") and, with the specific modifications referred to below that were orally agreed on the record, the "Plan"). On March 28, 2014, the Court conducted a hearing (the "Confirmation Hearing") to consider confirmation of the Plan and, after considering all objections, testimony, other evidence and oral arguments, confirmed the Plan as modified on the record and directed the Handy Debtors to file a written order consistent with such confirmation. This Order is such order and, to the extent there is any irreconcilable difference between the Court's oral confirmation of the Plan and this Order, the terms and provisions of this Order shall govern.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Jurisdiction; Venue; Core Proceeding. This Court has jurisdiction over the above-referenced chapter 11 cases (the "Chapter 11 Cases") pursuant to 28 U.S.C. §§ 157 and 1334. This matter is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2)(A), (L), and (O). Venue is proper in this Court pursuant to 28 U.S.C. §§ 1408 and 1409.

2. Adequate Notice. In accordance with the Bankruptcy Code and the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), timely and adequate notice of the time for filing objections to confirmation of the Plan and proper, timely and adequate notice of the Confirmation Hearing was provided to all holders of Claims¹ and Interests.

3. 11 U.S.C. § 1125(e). The Handy Debtors have solicited acceptances of the Plan in good faith and in compliance with the Bankruptcy Code. The Disclosure Statement, the Plan, the Ballots, the Order (I) Approving Handy Disclosure Statement, (II) Determining Dates, Procedures, and Forms Applicable to Solicitation Process, (III) Establishing Vote Tabulation Procedures, and (IV) Establishing Objection Deadline and Scheduling Hearing to Consider Confirmation of Plan [Dkt. No. 1169] ("Solicitation Order"), and the Confirmation Hearing Notice (as defined in the Solicitation Order) were transmitted and served in compliance with the Solicitation Order, the Bankruptcy Rules, and the Local Rules for the United States Bankruptcy Court for the Southern District of Texas. Such transmittal and service were adequate and sufficient and no other or further notice shall be required. The Handy Debtors and each of their agents, directors, officers, employees, financial advisors, attorneys, and other professionals are deemed to have participated in good faith and in compliance with the applicable provisions of

the Bankruptcy Code in the solicitation of the Plan, and, therefore, are not and shall not, on account of such issuance or solicitation, be liable at any time for the violation of any law, rule, or regulation governing the solicitation of acceptances or rejections of the Plan or the distribution or dissemination of any information contained in the Plan, the Disclosure Statement, and any and all related documents. The Debtors have complied with the Solicitation Order in all respects.

4. Burden of Proof. The Handy Debtors have met their burden of proving the elements of section 1129 of the Bankruptcy Code by a preponderance of the evidence. To the extent the applicable standard is clear and convincing evidence, the Court finds the Handy Debtors have met their burden of proving the elements of section 1129 of the Bankruptcy Code by clear and convincing evidence.

5. 11 U.S.C. § 1129(a)(1). The Plan complies with the applicable provisions of the Bankruptcy Code.

6. 11 U.S.C. § 1129(a)(2). The Handy Debtors are the proponent of the Plan and the Handy Debtors have complied with the applicable provisions of the Bankruptcy Code.

7. 11 U.S.C. § 1129(a)(3). The Plan has been proposed in good faith and not by any means forbidden by law. In determining that the Plan has been proposed in good faith, the Bankruptcy Court has examined the totality of the circumstances surrounding the formulation and solicitation of the Plan. Having done so, the Court finds and concludes that the Handy Debtors have acted, and are presently acting, in good faith in conjunction with all aspects of the Plan. All transactions contemplated by the Plan were negotiated and consummated at arm's length, without collusion, and in good faith. Furthermore, the Plan reflects the best interests of the Handy Debtors' estates and holders of Claims and Interests.

8. 11 U.S.C. § 1129(a)(4). All payments made or to be made by the Handy Debtors or by a person acquiring property under the Plan, for services or for costs and expenses in, or in

connection with, these Chapter 11 Cases, or in connection with the Plan and incident to these Chapter 11 Cases, have been approved by, or are subject to approval of, the Bankruptcy Court as reasonable, unless otherwise ordered by the Bankruptcy Court.

9. 11 U.S.C. § 1129(a)(5). In accordance with 11 U.S.C. § 1129(a)(5), (i) the Handy Debtors have disclosed (or will disclose prior to the Effective Date of the Plan) the identity and affiliations of the individuals proposed to serve, after the Effective Date of the Plan, as directors or officers of the Handy Debtors; (ii) the appointment of the individuals who serve as directors or officers of the Handy Debtors is consistent with the interests of creditors and equity security holders and with public policy; and (iii) the Handy Debtors have disclosed the identity of any insider that will be employed by the reorganized Handy Debtors and the nature of any compensation for such insider.

10. 11 U.S.C. § 1129(a)(6). Section 1129(a)(6) of the Bankruptcy Code is not applicable to the Handy Debtors because the Debtors are not subject to any governmental regulation of any rates.

11. 11 U.S.C. § 1129(a)(7). With respect to each impaired class of claims or interests under the Plan, each holder of a claim or interest of such class has accepted the Plan or will receive or retain under the Plan, on account of such claim or interest, property of a value, as of the Effective Date, that is not less than the amount that such holder would so receive or retain if the Handy Debtors were liquidated under chapter 7 of the Bankruptcy Code on such date.

12. 11 U.S.C. § 1129(a)(8). Each Class under the Plan (i) has accepted the Plan, (ii) is an empty class, or (iii) if it has rejected the Plan or is deemed to have rejected the Plan, the Court finds that pursuant to Bankruptcy Code §§ 1129(b)(1) and (2), the Plan does not discriminate unfairly, and is fair and equitable.

13. 11 U.S.C. § 1129(a)(9). The Plan's treatment of claims of a kind specified in Bankruptcy Code § 507 satisfies the requirements set forth in Bankruptcy Code § 1129(a)(9).

14. 11 U.S.C. § 1129(a)(10). At least one class of claims or interests that is impaired under the Plan has voted to accept the Plan, without including acceptances of the Plan by any insider.

15. 11 U.S.C. § 1129(a)(11). Confirmation of the Plan is not likely to be followed by the liquidation, or the need for further financial reorganization, of the Handy Debtors or any successor to the Handy Debtors under the Plan.

16. 11 U.S.C. § 1129(a)(12). To the extent that fees payable to the United States Trustee under 28 U.S.C. § 1930 have not been paid, the Plan provides for the payment of all such fees on the Effective Date of the Plan and as they come due after the Effective Date.

17. Other Provisions of 11 U.S.C. § 1129. The provisions of 11 U.S.C. §§ 1129(a)(13), (a)(14), (a)(15), and (a)(16) are not applicable to the Debtors.

18. Modifications to the Plan. All modifications made to the Plan after solicitation of votes on the Plan had commenced, as reflected in this Order, as set forth on the record at the Confirmation Hearing, or as reflected in the Plan, satisfy the requirements of Bankruptcy Code § 1127(a) and Bankruptcy Rule 3019, are not material, and do not adversely affect the treatment and rights of the holders of any Claim or Interest under the Plan who have not otherwise accepted such modifications. Accordingly, the Handy Debtors have satisfied Bankruptcy Code § 1127(c) and Bankruptcy Rule 3019 with respect to the Plan, as modified; and holders of Claims or Interests that have accepted or rejected the Plan (or are deemed to have accepted or rejected the Plan) are deemed to have accepted or rejected, as the case may be, the Plan as modified on the date of this Order, pursuant to Bankruptcy Code § 1127(d) and Bankruptcy Rule 3019.

19. Rule 9019 Settlement. Pursuant to Bankruptcy Rule 9019 and in consideration of the distributions and other benefits provided under the Plan, the provisions of the Plan constitute a good faith compromise and settlement of all Impaired Claims against and Interests in the Handy Debtors. Such compromises and settlements are made in exchange for consideration and are in the best interests of the holders of Impaired Claims and Interests, are within the range of possible litigation outcomes, are fair, equitable, reasonable, and are integral elements of the restructuring and resolution of the Chapter 11 Cases in accordance with the Plan.

20. Injunctions, Exculpation, and Releases. Failure to effect the injunctions, moratoriums, exculpations, limitations of liabilities, releases, and covenants not to sue as set forth in the Plan, including in Article X of the Plan, would impair the Handy Debtors' ability to confirm the Plan. Accordingly, the injunctions, moratoriums, exculpations, limitations of liabilities, releases, and covenants not to sue as set forth in the Plan, including in Article X of the Plan, are approved and authorized in their entirety.

21. Discharge. Pursuant to and to the fullest extent permitted by § 1141(d) of the Bankruptcy Code, and except as otherwise provided in the Plan or this Confirmation Order, the treatment of Claims and Equity Interests under the Plan shall be in full and final satisfaction, settlement, release, discharge, and termination, as of the Effective Date, of all Claims of any nature whatsoever, whether known or unknown, against, and Equity Interests in, the Handy Debtors, any property of their estates, the Reorganized Handy Debtors or any property of the Reorganized Debtors. Except as otherwise provided in the Plan, this Confirmation Order or such other order of this Court that may be applicable, all Persons and Entities shall be precluded from asserting against the Handy Debtors, their successors or assigns, including the Reorganized Handy Debtors, Holdco, their agents and employees, or their respective assets, properties or interests in property, any Claims based upon any act or omission, transaction or other activity of

any kind or nature that occurred prior to the Effective Date, whether or not the facts or legal bases therefor were known or existed prior to the Effective Date regardless of whether a Proof of Claim or Equity Interest was filed.

22. Release of Liens. All Liens, including, without limitation, and Liens securing the DIP Facility, existing as of the Effective Date against any of the Handy Debtors or any property of the Handy Debtors or their Estates shall be automatically canceled, extinguished, and released as of the Effective Date. To the extent requested by a Handy Debtor, a Reorganized Handy Debtor, or Holdco, (a) the DIP Lender shall promptly take such actions as are necessary to release any ship mortgage on a Vessel, and shall promptly take such other actions as are reasonably requested (or reasonably necessary or reasonably desirable) to effectuate a release of all DIP Liens, and (b) any other Person or Entity (besides the DIP Lender) that filed or recorded a Lien that exists (or is reflected in any registry or filing system) as of the Effective Date against any of the Handy Debtors or any property of the Handy Debtors or their Estates shall promptly take any steps necessary or desirable to document the cancellation, extinguishment and release of such Lien. Any costs and fees incurred by the DIP Lender with respect to any such steps undertaken by the DIP Lender in connection with the foregoing shall be paid and reimbursed by the Associated Debtors that are DIP Debtors (as defined in the Final DIP Order) in accordance with paragraph 4(f) of the Final DIP Order.

23. Securities Law Exemption. The solicitation of acceptances and rejections of the Plan was exempt from the registration requirements of the Securities Act and applicable state securities laws, and no other non-bankruptcy law applies to the solicitation. Pursuant to Section 1145 of the Bankruptcy Code and all other applicable exemptions from the securities laws, the offering, issuance and distribution of the Holdco Common Stock are exempt from the registration requirements of Section 5 of the Securities Act and any State or local law requiring

registration for offer or sale of a security. In addition, under Section 1145 of the Bankruptcy Code and any other applicable exemption from the securities laws, such Holdco Common Stock shall be freely tradable in the United States, subject to compliance with any securities laws and any rules and regulations of the Securities and Exchange Commission, applicable at the time of any further offer, sale or transfer of such securities and instruments and subject to any restrictions set forth in the Shareholders Agreement.

24. Plan Provisions Valid and Binding. The terms of the Plan and the other Plan Documents, each as may be modified, are incorporated by reference into, and are an integral part of, the Plan and this Confirmation Order. Upon entry of this Order, each term and provision of the Plan is valid, binding, and enforceable pursuant to its terms.

25. Compliance with Bankruptcy Rule 3016. In accordance with Bankruptcy Rule 3016(a), the Plan is dated and the entities that submitted it, and filed it, are identified.

26. Plan is in Best Interests. Confirmation of the Plan is in the overall best interests of the Handy Debtors, their Estates and all holders of Claims and Interests.

27. Hearing Modifications. At the Confirmation Hearing, the Court proposed, and the Handy Debtors agreed, to modify the Plan provisions relating to the F3-VTG Shares (the “Share Provisions”) pursuant to a separate order of this Court (the “F3-VTG Shares Disposition Order”) that will address the Share Provisions consistent with the comments, modifications, and agreements at the Confirmation Hearing. For the avoidance of doubt, this shall not modify any of the Conditions to Confirmation or the Effective Date set forth in Article VIII of the Plan.

28. Findings of Fact and Conclusions of Law. The foregoing findings and conclusions satisfy the requirements of Bankruptcy Rule 7052. All findings of facts shall also be deemed to be conclusions of law hereunder and vice versa. All findings of fact and conclusions of law

announced by this Court on the record in connection with confirmation of the Plan or otherwise at the Confirmation Hearing are incorporated herein by reference.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, it is hereby ORDERED, ADJUDGED AND DECREED THAT:

29. Confirmation. The Plan, with the modifications and clarifications embodied in this Order, IS HEREBY CONFIRMED. The failure specifically to include or to refer to any particular article, section, or provision of the Plan or any related document in this Order shall not diminish or impair the effectiveness of such article, section, or provision, it being the intent of the Court that the Plan and any related documents be confirmed in their entirety.

30. Objections Overruled. All (a) objections that have not been withdrawn, waived, or settled; and any reservation of rights contained therein or (b) other responses to Confirmation of the Plan that are not addressed by the relief granted herein are OVERRULED in their entirety and on the merits. All objections that have been withdrawn are hereby deemed WITHDRAWN with prejudice.

31. Approval of Plan Documents. The form and substance of the Plan Documents, as reflected in the Plan Supplements or otherwise (including all exhibits and attachments thereto and documents referred to therein) are hereby APPROVED. The execution, delivery, and performance by the Handy Debtors (or the Designee as provided) of the Plan Documents are authorized and approved without the need for further corporate or other organizational action or further order or authorization of the Bankruptcy Court. The Handy Debtors (or the Designee as provided) are authorized and empowered to make any and all modifications to any and all documents included as part of the Plan and Plan Supplements that are consistent with the Plan and the terms of this Confirmation Order. The final versions of the Plan Supplement Documents,

which shall be in form and substance acceptable to the Majority Secured Facility Lender, shall be filed on the docket in accordance with paragraph 40(b) hereof.

32. Distributions of Holdco Common Stock. In order to receive a distribution of Holdco Common Stock, a party must execute the Shareholders Agreement and the Shareholder Proxy in the final form filed on the docket (in accordance with paragraph 40(b) hereof) and the irrevocable voting proxy referred to in the Plan. Additionally, in order to become a holder of Holdco Common Stock, or a lender under the Exit Facility or New Facility, a party must provide all required “know your customer” or similar information required by the administrative agent for the Exit Facility, the account bank for Holdco, or any other third party entity lawfully requesting such information.

33. Binding Effect. The Plan, its provisions and this Order shall be, and hereby are, binding upon the Handy Debtors and any creditor or equity security holder of the Handy Debtors, whether or not the Claim or Interest of such creditor or equity security holder is impaired under the Plan and whether or not such creditor or equity security holder has accepted the Plan.

34. Plan Classification Controlling. The terms of the Plan shall solely govern the classification of Claims and Interests for purposes of distributions to be made thereunder. The classifications set forth on the ballots tendered to or returned by the holders of Claims or Interests in connection with voting on the Plan: (a) were set forth on the ballots solely for purposes of voting to accept or reject the Plan; (b) do not necessarily represent, and in no event shall be deemed to modify or otherwise affect, the actual classification of such Claims and Interests under the Plan for distribution purposes; (c) may not be relied upon by any holder of a Claim or Interest as representing the actual classification of such Claim or Interest under the Plan

for distribution purposes; and (d) shall not be binding on the Handy Debtors except for voting purposes.

35. Authorization for Handy Debtors. All of the distributions and transactions required to be made under the Plan are authorized and the Handy Debtors (or the Designee on behalf of the Handy Debtors) are further authorized to undertake all lawful actions, reasonably necessary, or otherwise in accordance with section 9.01(1) of the Plan, to carry out the provisions and purposes of the Plan.

36. Authorization for the Designee. The Designee's authority granted in this Court's order on March 19, 2014 (Dkt. No. 1232) is confirmed and, in addition, the Designee shall have all of the additional authority set forth in Section 5.24 of the Plan. For avoidance of doubt this means that the Designee is duly authorized on behalf of Holdco and each of the Handy Debtors, in accordance with all applicable law, including any state law corporate governance rule, to execute the Plan and each of the other Plan Documents, each of the Plan Supplement documents, and any other documents, security agreements, filing statements, perfection documents, lien granting documents, resolutions, powers, certificates and proxies, papers and other materials and to take any other action as may be requested by the Majority Secured Facility Lenders to aid in the furtherance of the occurrence of the Effective Date. Each reference in this Order or in Section 5.24 of the Plan, to "Holdco" and the "Handy Debtors" shall be deemed to constitute references to each such Person both before and after each of the Confirmation Date and the Effective Date. Without limiting the forgoing, the Designee is authorized to take the following actions and to execute all related documents:

(a) Convene a shareholder and board meeting of each of the Handy Debtors, appoint a new director and effect the resignation of Mr. Su as director, each as provided for in the Plan,

(b) Cancel A Handy's shares in the recently formed Handy Corporation and reissue 100% of the capital shares in Holdco as provided in the Plan;

(c) Transfer all currently issued shares in each of the Handy Debtors to Holdco or cancel such shares and issue new shares to Holdco;

(d) Execute all documents as the act of F3 Capital in connection with the breakdown and reissuance of the pledged F3-VTG Shares by the transfer agent.

37. Reliance and Further Court Orders. The Designee shall be entitled conclusively to assume that all documents presented to him are true, correct, appropriate, and reasonably necessary or desirable to effect the purposes and requirements of the Handies Plan, regardless of their title or contents and regardless of whether drafted by counsel to the Majority Secured Facility Lenders or counsel to the Handy Debtors. In no event shall the Designee or Bracewell & Giuliani LLP (the law firm in which the Designee is a partner) be responsible for the truth, correctness, appropriateness, necessity, desirability or, once signed and recorded, the effectiveness of any documents authorized to be executed hereunder. At any time the Designee shall be entitled in his sole discretion to seek a further order of the Court before carrying out any such further actions which relief shall be sought on an emergency basis with a request to be heard as soon as the Court's calendar permits, including via a telephonic hearing.

38. Cooperation of Holdco and Handy Debtors. Holdco and the Handy Debtors and their respective officers, employees and agents are authorized and directed promptly to take, or refrain from taking, such acts as may be requested to assist the Designee to comply with this directions given herein.

39. Release and Indemnification of the Designee. As provided in the Plan, the Designee shall be released as a Release Person. Additionally, to the maximum extent permissible at law, neither the Designee nor his law firm shall have any liability of any kind or nature for

taking any action related to the Plan or that the Designee is required or authorized to take in accordance with this Order, including the execution of any documents and the carrying out of further actions to implement the Plan. The Handy Debtors shall indemnify and hold harmless the Designee to the fullest extent lawful, from and against all costs, fees, expenses, damages, and liabilities, joint or several (including defense costs), associated with any claim relating to or arising as a result of the execution of any document authorized hereunder, or any actions taken or omitted to be taken by the Designee in connection with the Designee's compliance with this Order (collectively called the "Losses"). This provision is intended to apply regardless of the nature of any claim (including contract, statute, any form of negligence, whether of the Handy Debtors, the Designee, or others, tort, strict liability or otherwise), except to the extent such Losses are finally judicially determined by a court of competent jurisdiction to be the result of the gross negligence or willful misconduct of the Designee. In no event shall the Designee have any responsibility for any special, consequential, incidental or exemplary damages or loss (nor any lost profits, savings or business opportunity). This paragraph shall apply regardless of the nature of any claim(s) (including contract, statute, any form of negligence, tort, strict liability or otherwise), regardless of any failure of the essential purpose of any remedy and whether or not the Designee was advised of the possibility of the damage or loss asserted, but shall not apply to the extent finally determined to be prohibited by applicable law. This indemnity shall be in addition to any obligation or liability that the Handy Debtors or the Debtors may otherwise have to the Designee, and shall survive after the Effective Date of the Plan. Holdco and the Handy Debtors shall not, without the Designee's prior written consent, settle, compromise, or consent to the entry of any judgment in any pending or threatened claim, action, or proceeding in respect of which indemnification could be sought hereunder (whether or not the Designee is an actual or potential party to such claim, action, or proceeding), if such settlement, compromise, or consent

does not include an unconditional release of the Designee from all liability arising out of such claim, action, or proceeding.

Promptly after receipt by the Designee claiming the benefit of this provision of notice of its involvement in any action, proceeding, or investigation, the Designee shall, if a claim in respect thereof is to be made or is threatened against the Handy Debtors and Holdco, notify Holdco and the Handy Debtors in writing of such involvement; provided, however, that failure by the Designee to so notify the Handy Debtors or Holdco shall not relieve the Handy Debtors or Holdco from any liability hereunder, except to the extent that the Handy Debtors or Holdco are prejudiced thereby, and shall not in any event relieve the Handy Debtors or Holdco from any other obligation or liability that they may have to the Designee otherwise than under this Plan. The Handy Debtors or Holdco (as the case may be) and their counsel, who shall be reasonably satisfactory to the Designee, shall be entitled to participate therein with the Designee and its counsel. To the extent they wish, the Handy Debtors or Holdco shall be entitled to assume the defense of any action that is the subject of the preceding sentence with counsel reasonably satisfactory to the Designee, and, if they elect to do so, the Handy Debtors and Holdco shall be thereafter relieved of any further obligation for the payment of the fees and expenses of the Designee's counsel; provided, however, that the Designee shall be entitled to continued separate counsel at the Designee's own expense.

Upon the conclusion of all of the Designee's services as described herein and in the Plan, Holdco and the Handy Debtors will issue to the Designee a general release, without qualification.

40. Specific Plan Provisions. In addition to the Plan modifications referred to in paragraph 27 above, the Plan is hereby modified by the following non-material changes, none of which adversely affect the treatment of the Holders of any Claim or Interest under the Plan:

- (a) Section 1.02(74) is amended by replacing the words “organized by the Handy Debtors” with “to be organized by one or more Handy Debtor or another party acceptable to the Majority Secured Facility Lenders”
- (b) Section 1.02(107) is amended by replacing the proviso in the first sentence with the following “provided that the Plan Supplement documents may be updated and revised (including to change the domicile of Holdco) until three days prior to the Effective Date, so long as the revised version of such document is filed with the Court at least three days prior to the Effective Date.”
- (c) Section 1.02(118) of the Plan is replaced with “[Reserved]”.
- (d) All references to “Second Distribution Date” in the Plan shall be replaced with “First Distribution Date”.
- (e) Section 5.06(6) of the Plan is amended by replacing the words “on an annual basis” with the words “in accordance with the Holdco governance documents”.
- (f) Section 8.02 of the Plan is amended by adding a new paragraph at the end thereof as follows:

“(8) It shall be an additional condition to the occurrence of the Effective Date that a separate Final Order, in form and substance satisfactory to the Majority Secured Facility Lenders, shall have been entered with respect to the pledge of the F3-VTG Shares to secure the F3 Capital Guarantee on a first lien basis and providing for a second lien in favor of the Debtors’ estates.”

41. Payment of Shanghai Commercial & Savings Bank, Ltd. The Claim of Shanghai Commercial & Savings Bank, Ltd. against C Handy Corporation in the amount of \$1.00 shall be paid in cash by C Handy Corporation on the Effective Date in full and final satisfaction of such claim.

42. Dismissal of Certain Litigation. Within 5 Business Days after the Effective Date, the relevant parties shall take all action reasonably necessary to cause all litigation in respect of

the Order Pursuant to Sections 105(a), 362 and 365 of the Bankruptcy Code Enforcing and Restating Automatic Stay and Ipso Facto Provisions (*M/V B Handy*) [Dkt. No. 297], including, all appeals in respect thereof, to be dismissed or withdrawn with prejudice. Further, the Handy Debtors shall take all action reasonably necessary to cause *C Whale Corp. et al. v. Active Tankers Shipmanagement S.A. et al.*, Adv. Pro. 13-03141 (Bankr. S.D. Tex.) to be dismissed with prejudice to all claims (i) held by any of the Handy Debtors and (ii) asserted against Shanghai Commercial & Savings Bank, Hua Nan Commercial Bank, Ltd., and Chang Hwa Bank, Ltd.

43. Exemption from Certain Taxes. In accordance with Bankruptcy Code § 1146(a), none of the issuance, transfer or exchange of any securities under the Plan, the release of any mortgage, deed of trust or other Lien, the making, assignment, filing or recording of any lease or sublease, the vesting or transfer of title to or ownership of any of the Handy Debtors' interests in any property, or the making or delivery of any deed, bill of sale or other instrument of transfer under, in furtherance of, or in connection with the Plan, including the issuance and delivery of any Holdco Common Stock, shall be subject to any document recording tax, stamp tax, conveyance fee, sales or use tax, bulk sale tax, intangibles or similar tax, mortgage tax, stamp act, real estate transfer tax, mortgage recording tax, Uniform Commercial Code filing or recording fee or other similar tax or governmental assessment in the United States. Federal, state and/or local governmental officials or agents shall forgo the collection of any such tax or governmental assessment and to accept for filing and recordation any of the foregoing instruments or other documents without the payment of any such tax or governmental assessment.

44. Vesting of Assets. Except as otherwise provided in the Plan, as of the Effective Date, pursuant to the provisions of sections 1141(b) and (c) of the Bankruptcy Code, all assets

shall vest in the Debtors free and clear of all Claims, liens, encumbrances, charges, and other interests, except as otherwise expressly provided in the Plan, this Confirmation Order, or the separate Order Regarding Disposition of F3-VTG Shares In Conjunction with the Confirmation of the Plan (the “F3-VTG Shares Disposition Order”) and subject to the terms and conditions of the Plan, this Confirmation Order, and the F3-VTG Shares Disposition Order.

45. DIP Claims, Rights and Remedies Against the Associated Debtors. The agreements and treatment under the Plan and this Confirmation Order in respect of the DIP Claim against the Handy Debtors shall not affect any of the DIP Lender’s claims, rights or remedies with respect to the Associated Debtors as set forth in the Final DIP Order and the DIP Term Sheet.

46. Payment of Statutory Fees. On or before the Effective Date, the Handy Debtors shall have paid in full, in Cash (including by check or wire transfer), in U.S. dollars, all fees payable pursuant to section 1930 of title 28 of the United States Code. Post-confirmation, the Handy Debtors shall be responsible for the payment of accruing United States Trustee quarterly fees for each of the Handy Debtors until each case is closed, converted or dismissed by the Court. The Handy Debtors shall file with the Court and serve on the United States Trustee quarterly financial reports for each quarter (or portion thereof) that any of the cases remain open or have not been converted or dismissed, in a format prescribed by the United States Trustee.

47. Notice of the Effective Date. On or before ten (10) Business Days after the occurrence of the Effective Date, the Handy Debtors shall mail or cause to be mailed to all record holders of Claims and Interests a notice that informs such holders of: (i) entry of the Confirmation Order; (ii) the occurrence of the Effective Date; (iii) the deadline established under this Plan for the filing of Administrative Expense Claims; and (iv) such other matters as the Handy Debtors deem to be appropriate; provided, however, that failure to file such notice shall

not affect the effectiveness of the Plan or the rights and substantive obligations of any entity hereunder. The notice described herein is adequate under the particular circumstances and no other or further notice is necessary.

48. Non-Occurrence of Effective Date. In the event that the Effective Date under the Plan does not occur:

- (a) this Order shall be vacated;
- (b) the Plan shall be null and void in all respects;
- (c) no distributions under the Plan shall be made;
- (d) Holdco, the Handy Debtors and holders of Claims and Interests, including the DIP Lender, shall be restored to the status quo as of the day immediately preceding the Confirmation Date as though this Order had never been entered;
- (e) any settlement or compromise embodied therein (including the fixing or limiting to an amount any Claim or Class of Claims), assumption or rejection of executory contracts or leases effected by the Plan, and any document or agreement executed pursuant to the Plan shall be deemed null and void;
- (f) the Handy Debtors' obligations with respect to Claims and Interests shall remain unchanged;
- (g) Debtors' counsel and/or the Designee shall return to the Clerk of Court any F3-VTG Shares released to the Designee in anticipation of the occurrence of the Effective Date; and
- (h) nothing contained in the Plan or this Order shall constitute or be deemed a waiver or release of any Claims or Interests by or against the Handy Debtors or any Person or governmental entity or to prejudice in any manner the rights of the Handy

Debtors or any Person or governmental entity in any other or further proceedings involving the Handy Debtors.

49. Notice of Non-Occurrence of Effective Date. If the Designee on behalf of the Handy Debtors determines in his reasonable judgment that the conditions precedent to the occurrence of the Effective Date provided in sections 8.02 and 8.05 of the Plan cannot be met or are not otherwise waived as provided in Section 8.03 of the Plan, the Handy Debtors shall file with this Court a notice of the non-occurrence of the Effective Date and shall serve such notice on holders of Claims and Interest, parties-in-interest entitled to such notice and the United States Trustee by first-class mail, postage prepaid. Upon the filing of such notice with the Court, the provisions of this paragraph shall become effective.

50. Reversal. If any or all of the provisions of this Confirmation Order are hereafter reversed, modified, or vacated by subsequent order of this Bankruptcy Court or any other court, such reversal, modification, or vacatur shall not affect the validity of the acts or obligations incurred or undertaken under or in connection with the Plan prior to the Debtors' receipt of written notice of any such order. Notwithstanding any such reversal, modification, or vacatur of this Confirmation Order, any such act or obligation incurred or undertaken pursuant to, and in reliance on, this Confirmation Order prior to the Effective Date of such reversal, modification or vacatur shall be governed in all respects by the provisions of this Confirmation Order and the Plan or any amendments or modifications thereto.

51. Administrative Claims Bar Date. Each Holder of an Administrative Expense of the type referred to in Section 11.02(1) of the Plan must file a request for payment in compliance with the timing and other requirements of Section 11.02(1) of the Plan or forever be barred from doing so.

52. Professional Fee Claims. All final requests for allowance of Professional Fee Claims must comply with Section 11.02(4) of the Plan, and the Professionals shall be entitled to file final fee applications as Allocated to the Handy Debtors, but such applications shall not be deemed to be final as to any other Debtor.

53. Conflicts between Plan and Confirmation Order. If there is any irreconcilable conflict between the Plan (as supplemented by the Plan Supplement) and this Confirmation Order, the terms of the Plan shall control except to the extent that the Plan is modified by this Order including, without limitation, paragraphs 27 and 40.

54. Order Nonseverable. The provisions of this Order are nonseverable and mutually dependent.

55. Captions and Headings. Captions and headings herein are inserted for convenience of reference only and are not intended to be a part of, or to affect the interpretation of, this Order.

56. F3-VTG Share Disposition Order Controls. This Order does not modify the F3-VTG Shares Disposition Order. If there is a conflict between this Order (or the Plan) and the F3-VTG Shares Disposition Order, the F3-VTG Shares Disposition Order governs.

57. Order Effective and Enforceable After 4 Business Days. Notwithstanding Bankruptcy Rule 3020(e) or otherwise, and based on the circumstances described in the Disclosure Statement, this Order shall be effective and enforceable upon the expiration of 4 business days following its entry.
