**ORDER GRANTING DEBTORS' EIGHTH OMNIBUS
OBJECTION TO THE ALLOWANCE OF CERTAIN CLAIMS**

Upon the *Debtors' Eighth Omnibus Objection to the Allowance of Certain Claims* (the "Objection")² of the debtors and debtors-in-possession in the above-captioned cases (the "Debtors"), seeking entry of an order, pursuant to section 502(b) of title 11 of the United States Code (the "Bankruptcy Code") and rules 3003 and 3007 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), disallowing and expunging the claims listed on Exhibits A, B, and C annexed to the Objection; and notice of the Objection having been provided as set forth in the Objection, and it appearing that no other or further notice is required; and a hearing on the Objection having been held before this Court (the "Hearing"); and upon the Marchese Declaration; and the Court having reviewed the Objection and the Marchese Declaration and it appearing that the relief requested therein is in the best interests of the Debtors and their estates, creditors and other parties in interest; and upon the full record of the Hearing; and after due deliberation and sufficient cause appearing therefor, it is hereby

ORDERED, ADJUDGED, AND DECREED that:

1. The Objection is GRANTED to the extent provided herein.
2. The No Liability Claims identified in the column entitled “Objectionable Claims” on Exhibit A attached hereto are disallowed and expunged in their entirety.
3. The Satisfied Claims identified in the column entitled “Objectionable Claims” on Exhibit B attached hereto are disallowed and expunged in their entirety.
4. The Reduced and Reclassified Claims identified in the column entitled “Objectionable Claims” on Exhibit C attached hereto are hereby reduced and/or reclassified, in whole or in part, to the classifications and amounts set forth in the column entitled “Modified Amount” on Exhibit C.
5. This Order is without prejudice to the rights of the Debtors and other parties in interest to object to the Claims on grounds other than those stated in the Objection, and is without prejudice to the Debtors’ rights to object, on any basis, to any other claims held by the claimants whose Claims the Debtors are seeking to disallow and expunge hereby.
6. This Court shall retain jurisdiction over the Debtors and the claimants whose Claims are subject to the Objection with respect to any matters related to or arising from the implementation of this Order.
