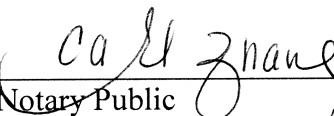

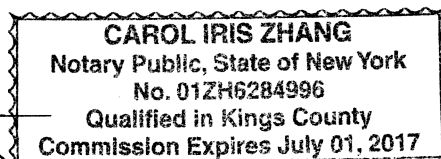

CURE NOTICE AND ASSUMPTION AND ASSIGNMENT NOTICE

PLEASE TAKE NOTICE that:

1. On April 7, 2014, James River Coal Company and its subsidiaries, as debtors and debtors in possession in these proceedings (collectively, the “**Debtors**”), filed the *Debtors’ Motion for Entry of an Order (i) Approving the Strategic Transaction Bidding Procedures, (ii) Scheduling Bid Deadlines and the Auction, (iii) Approving the Form and Manner of Notice Thereof and (iv) Granting Related Relief* [ECF No. 27] (the “**Motion**”) with the United States Bankruptcy Court for the Eastern District of Virginia (the “**Court**”).

2. On May 9, 2014, the Court entered an order approving the Motion [ECF No. 254] (the “**Strategic Transaction Bidding Procedures Order**”) and granting certain relief sought in the Motion, including, among other things, approving (a) the Strategic Transaction Bidding Procedures (as defined in the Strategic Transaction

Bidding Procedures Order)² and (b) procedures for the assumption and assignment of executory contracts and unexpired leases (collectively, the “**Assumed and Assigned Contracts**”).³

3. Pursuant to the Strategic Transaction Bidding Procedures, on August 16, 2014, the Debtors filed notice that the Debtors, in consultation with the DIP Agent and the UCC, selected JR Acquisition, LLC, a wholly owned subsidiary of Blackhawk Mining, LLC, as a Stalking Horse Bidder (the “**Stalking Horse Bidder**”) for substantially all of the Debtors’ assets (the “**Stalking Horse Bid**”). The Debtors have determined to conduct an Auction on **August 18, 2014 at 10:00 a.m. (prevailing Eastern Time)**. If the Stalking Horse Bid is selected as the Successful Bid, the Debtors intend to seek approval of the Stalking Horse Bid at a hearing presently scheduled to take place on **August 20, 2014 at 1:00 p.m. (prevailing Eastern Time)** (the “**Sale Hearing**”).⁴

4. **You are receiving this notice (the “Counterparty Notice”) because you are listed on Exhibit A hereto as a counterparty to one or more contracts or leases that the corresponding Debtors intend to assume and assign to the Stalking Horse Bidder if the Stalking Horse Bid is selected as the Successful Bid and approved at the Sale Hearing.**⁵

5. In connection with the assumption and assignment of the Assumed and Assigned Contracts to either the Stalking Horse Bidder, or a Successful Bidder if the Stalking Horse Bid is not selected as the Successful Bid at the Auction, the Debtors will pay the amount that the Debtors’ records reflect is owing for prepetition, as well as any post-petition, arrearages as set forth on Exhibit A (the “**Cure Amount**”). The Debtors believe that any and all defaults (other than the filing of these chapter 11 cases) under the Assumed and Assigned Contracts can be cured by the payments of the Cure Amount.

6. Pursuant to section 365 of the Bankruptcy Code, there is adequate assurance that the Cure Amount(s) set forth on Exhibit A shall be paid in accordance with the terms determined at the Sale Hearing. Further, if the Stalking Horse Bid is approved

at the Sale Hearing, there is adequate assurance of the future performance of the Stalking Horse Bidder under the executory contract or unexpired lease to be assumed and assigned because of the significant resources of the Stalking Horse Bidder.

7. Objections to the assumption and assignment of any Assumed and Assigned Contract, including to any Cure Amount, must (a) be in writing; (b) conform to the applicable provisions of the Bankruptcy Rules, the Local Bankruptcy Rules and the *Notice, Case Management and Administrative Procedures* approved by the Court on April 10, 2014 [ECF No. 77]; (c) state with particularity the legal and factual basis for the objection and the specific grounds therefor, including the additional cure amount that the objecting party believes should be paid in connection with the assumption of the Assumed and Assigned Contract (the “**Claimed Cure Amount**”) and, if the objection to the proposed assumption and assignment is based on issues related to adequate assurance of future performance, what information with respect to the Stalking Horse Bidder such Contract Counterparty requires to satisfy its adequate assurance concerns; and (d) be filed with the Court and served, so as to be actually received **no later than 12:00 p.m. (prevailing Eastern Time) on August 25, 2014**, on: (i) the Debtors, 901 East Byrd Street, Suite 1600, Richmond, Virginia 23219, Attn: Andrew B. Hampton, email: andrew.hampton@jamesrivercoal.com; (ii) counsel to the Debtors, Davis Polk & Wardwell LLP, 450 Lexington Avenue, New York, New York 10017, Attn: Marshall S. Huebner and Brian M. Resnick, email: jrcc.service@davispolk.com; and (iii) local counsel to the Debtors, Hunton & Williams LLP, Riverfront Plaza, East Tower, 951 East Byrd Street, Richmond, Virginia 23219, Attn: Tyler P. Brown, email: tpbrown@hunton.com.

8. If no Cure Amount is due under the Assumed and Assigned Contract, and you do not otherwise object to the Debtors’ assumption and assignment of the Assumed and Assigned Contract, no further action need be taken on your part.

9. If any objection is timely filed in accordance with this Counterparty Notice with respect to the assumption and assignment of any Assumed and Assigned Contract, including with respect to a Cure Amount, and is not withdrawn or resolved, a hearing with respect to such objection will be held before the United States Bankruptcy Court for the Eastern District of Virginia, Honorable Kevin R. Huennekens, United States Bankruptcy Court for the Eastern District of Virginia, 701 East Broad Street, Courtroom 5000, Richmond, Virginia 23219, on a date to be fixed by the Court. A hearing regarding an objection may be continued until after the closing of the Sale.

10. Objections that object solely to the Cure Amount may not prevent or delay the Debtors’ assumption and assignment of any Assumed and Assigned Contract. If a party objects solely to a Cure Amount, the Debtors may, in their sole discretion, hold the Claimed Cure Amount in reserve pending further order of the Court or mutual agreement of the parties. So long as the Debtors hold the Claimed Cure Amount in reserve, and there are no other unresolved objections to assumption and assignment of such Assumed and Assigned Contract, the Debtors can, without further delay, assume and assign the Assumed and Assigned Contract that is the subject of the objection. Under such

circumstances, the objecting party's recourse is limited to the Claimed Cure Amount held in reserve.

11. Each Debtor's decision to assume and assign to the Stalking Horse Bidder an Assumed and Assigned Contract is subject to Court approval and the closing of the Sale. Accordingly, absent such closing, none of the Assumed and Assigned Contracts shall be deemed assumed or assigned, and shall in all respects be subject to further administration under the Bankruptcy Code. Notwithstanding anything herein, this Counterparty Notice does not require or guarantee that the Assumed and Assigned Contracts listed herein will be assumed by the Debtors at any time or assumed and assigned, and all rights of the Debtors with respect to such Assumed and Assigned Contracts are reserved.

12. If the Debtors determine to assume and assign any of the Assumed and Assigned Contracts in connection with a Sale to an entity other than the Stalking Horse Bidder, the Debtors shall serve on each counterparty thereto an additional Counterparty Notice. Any counterparty wishing to object to assumption and assignment on any basis other than the proposed Cure Amount will have an opportunity to object at that time.

13. Nothing herein (i) alters in any way the prepetition nature of the Assumed and Assigned Contracts or the validity, priority or amount of any claims of a Contract Counterparty against the Debtors that may arise under such Assumed and Assigned Contract, (ii) creates a postpetition contract or agreement or (iii) elevates to administrative expense priority any claims of a Contract Counterparty against the Debtors that may arise under such Assumed and Assigned Contract.

Consequences of Failing To Timely File and Serve an Objection

If no objection is timely filed and served, (x) the Assumed and Assigned Contract shall be deemed assumed and assigned to the Stalking Horse Bidder upon the closing of the Sale and payment of the Cure Amount (if any), and (y) the Cure Amount set forth on Exhibit A shall be final and binding upon all Contract Counterparties whether the Assumed and Assigned Contract is assigned to the Stalking Horse Bidder or to a Successful Bidder that is not the Stalking Horse Bidder. Additionally, any Contract Counterparty to an Assumed and Assigned Contract who fails to timely file and serve an objection to the proposed assumption and assignment of an Assumed and Assigned Contract, including in respect of the Cure Amount, in accordance with this Counterparty Notice shall be forever barred from asserting any objection thereto, including (i) making any demands for additional cure amounts or monetary compensation on account of any alleged defaults against the Debtors or their estates, (ii) asserting that the Stalking Horse Bidder has not provided adequate assurance of future performance and (iii) asserting that the assignment is subject to any anti-alienation provision or other restriction on assignment.
