NOTICE OF MOTION FOR RELIEF FROM STAY

Creditor Brian S. Thomas, Bankruptcy Trustee for the matter of In re Michael P. Sullivan and Kristen A. Sullivan, Case No.: 12-25363 (GMB) in the United States Bankruptcy Court for the District of New Jersey (“Thomas”), by his attorneys, Subranni Zauber LLC, filed a Motion for Relief from Stay in the above captioned bankruptcy proceeding P. 9019 (the “Motion”).
