**UNOPPOSED ORDER CONSOLIDATING (i) LIQUIDATING TRUSTEE’S  
OBJECTION TO PROOFS OF CLAIM FILED BY GAVIN WILSON [DOC. NO. 822]  
AND (ii) COMPLAINT TO AVOID AND RECOVER PREFERENTIAL TRANSFERS  
PURSUANT TO 11 U.S.C. §§ 544, 547, 548 AND 550  
AGAINST GAVIN WILSON (Docket No. 875)**

On this date came on to be considered the Motion (the “Subject Motion”) to Consolidate (i) Liquidating Trustee’s Objection to Proof of Claim filed by Gavin Wilson [Doc. No. 822] (the “Wilson Claim Objection”) and (ii) J.A. Compton, Liquidating Trustee of the Buccaneer Liquidating Trust’s Complaint to Avoid and Recover Preferential Transfers Pursuant to 11 U.S.C. §§ 544, 547, 548 and 550 [Doc. No. 1 in Adversary Proceeding No. 16-06007] (the “Adversary Proceeding”), and the Court having considered the pleadings and official records on file in this cause, finds that J.A. Compton, Liquidating Trustee of the Buccaneer Creditors’ Liquidating Trust, (the “Trustee”) is unopposed by Gavin Wilson (“Wilson”), but reserves all rights, claims and defenses with regard to any aspect of the Wilson Claim Objection with the Adversary Proceeding and, therefore, finds that good cause exists to enter this Order, it is therefore:

**ORDERED, ADJUDGED and DECREED** that the Subject Motion is GRANTED and that Wilson Claim Objection is consolidated with the Adversary Proceeding; it is further
