

**NOTICE REGARDING EXECUTORY CONTRACTS
 AND UNEXPIRED LEASES TO BE REJECTED PURSUANT TO THE PLAN**

PLEASE TAKE NOTICE THAT on June 28, 2016, the United States Bankruptcy Court for the Eastern District of Virginia (the “Court”) entered an order [Docket No. 371] (the “Disclosure Statement Order”): (a) authorizing Penn Virginia Corporation and its affiliated debtors and debtors in possession (collectively, the “Debtors”), to solicit acceptances for the *First Amended Joint Chapter 11 Plan of Reorganization of Penn Virginia Corporation and its*

Debtor Affiliates (as may be modified, amended, or supplemented from time to time, the “Plan”);² (b) approving the *Disclosure Statement for the Joint Chapter 11 Plan of Reorganization of Penn Virginia Corporation and its Debtor Affiliates* (the “Disclosure Statement”) as containing “adequate information” pursuant to section 1125 of the Bankruptcy Code; (c) approving the solicitation materials and documents to be included in the solicitation packages; (d) approving the rights offering procedures and related materials; and (e) approving procedures for soliciting, receiving, and tabulating votes on the Plan and for filing objections to the Plan.

PLEASE TAKE FURTHER NOTICE THAT as contemplated by the Plan and the Disclosure Statement Order approving the Disclosure Statement, the Debtors filed the Plan Supplement with the Court on July 22, 2016 [Docket No. 460].

PLEASE TAKE FURTHER NOTICE THAT the Debtors filed an amendment to the Plan Supplement with the Court on August 3, 2016 [Docket No. 500] (the “Amended Plan Supplement”), modifying the *Schedule of Rejected Executory Contracts and Unexpired Leases* (the “Amended Rejection Schedule”). The determination to reject the additional agreements identified on the Amended Rejection Schedule was made as of such date, and is subject to revision in accordance with the terms of the Plan.

PLEASE TAKE FURTHER NOTICE THAT YOU ARE RECEIVING THIS NOTICE BECAUSE THE DEBTORS’ RECORDS REFLECT THAT YOU ARE A PARTY TO AN EXECUTORY CONTRACT OR UNEXPIRED LEASE THAT WILL BE REJECTED PURSUANT TO THE PLAN. THEREFORE, YOU ARE ADVISED TO REVIEW CAREFULLY THE INFORMATION CONTAINED IN THIS NOTICE AND THE RELATED PROVISIONS OF THE PLAN.³

PLEASE TAKE FURTHER NOTICE THAT the hearing at which the Court will consider Confirmation of the Plan, including the Plan Supplement (the “Confirmation Hearing”) will commence on **August 11, 2016, at 11:00 a.m.**, prevailing Eastern Time, before the Honorable Keith L. Philips, in the United States Bankruptcy Court for the Eastern District of Virginia, located at 701 East Broad Street, Courtroom 5100, Richmond, Virginia 23219-1888.

PLEASE TAKE FURTHER NOTICE THAT all proofs of Claim with respect to Claims arising from the rejection of Executory Contracts or Unexpired Leases, if any, must be filed with the Bankruptcy Court within the earliest to occur of (1) thirty days after the date of entry of an order of the Court (including the Confirmation Order) approving such rejection or (2)

thirty days after notice of any rejection that occurs after the Effective Date. **Any Claims arising from the rejection of an Executory Contract or Unexpired Lease not filed within such time will be automatically disallowed, forever barred from assertion, and shall not be enforceable against the Debtors or the Reorganized Debtors, their Estates, or their property without the need for any objection by the Reorganized Debtors or further notice to, or action, order, or approval of the Bankruptcy Court.**

PLEASE TAKE FURTHER NOTICE THAT all Proofs of Claim with respect to Claims arising from the rejection of Executory Contracts or Unexpired Leases, if any, must be filed using a modified proof of claim form, substantially in the form attached hereto as **Exhibit A** (the “Modified POC Form”), which form has been modified to permit the holders of such Claims to (a) elect to have such Claim treated as a Convenience Claim in accordance with Section 3.2(g) of the Plan or (b) if the holder of such Claim is an Accredited Investor, elect to receive Subscription Rights to purchase its Pro Rata Share of the Rights Offering Shares in accordance with the Rights Offering Procedures and Section 3.2(f)(3) of the Plan.

PLEASE TAKE FURTHER NOTICE THAT to the extent a Proof of Claim was previously filed in connection with a potential Claim arising from the rejection of an Executory Contract or Unexpired Lease, such previously submitted Proof of Claim shall be superseded by any Proof of Claim filed in accordance with this notice via the Modified POC Form.
