**APPLICATION OF CS MINING, LLC FOR ENTRY OF AN ORDER AUTHORIZING

GENERAL BANKRUPTCY COUNSEL TO CS MINING, LLC, *NUNC PRO TUNC* TO  
THE INVOLUNTARY PETITION DATE**

Involuntary debtor CS Mining, LLC (“CS Mining”) files this application (the “Application”) seeking the expedited entry of an order authorizing the employment and retention of Pepper Hamilton LLP (“Pepper Hamilton”) as counsel to CS Mining *nunc pro tunc* to June 2, 2016. In support of this Application, CS Mining relies on the Declaration of Donald J. Detweiler, a partner of Pepper Hamilton (the “Detweiler Declaration”), attached hereto as **Exhibit A**. In further support of this Application, CS Mining respectfully states as follows:

### **JURISDICTION**

1. The bases for the relief requested herein are sections 327(a) and 328(a) of title 11 of the United States Code (11 U.S.C. §§ 101 *et seq.*, the “Bankruptcy Code”) and Rules 2014(a) and 2016 of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”).

### **BACKGROUND**

2. On June 2, 2016 (the “Involuntary Date”), purported creditors R.J. Bayer Professional Geologist, LLC; Minerals Advisory Group, LLC; Rollins Construction & Trucking, LLC; Rollins Machine, Inc.; and Oxbow Sulphur, Inc. (“Petitioning Creditors”) filed the Involuntary Petition (Docket No. 1) (the “Involuntary Petition”).

3. The summons to the Involuntary Petition was served on June 7, 2016 (Docket No. 3). CS Mining has twenty-one days from service (*i.e.*, up to and including June 28, 2016, the “Response Date”) of the summons to submit its response (the “Response”) to the Involuntary Petition.

4. CS Mining is presently engaged in an ongoing analysis of various legal and business issues for purposes of determining the proper Response to the Involuntary Petition. Therefore, by agreement with the Petitioning Creditors, CS Mining is concurrently with the

filing of this Application, seeking an extension of the deadline to file a Response to at least until July 7, 2016.

5. No trustee, examiner, creditors' committee, or other official committee has been appointed in this chapter 11 case.

### **RELIEF REQUESTED**

6. By this Application, CS Mining seeks the entry of an order, pursuant to Bankruptcy Code sections 327(a) and 328(a) and Bankruptcy Rules 2014(a) and 2016, authorizing the employment and retention of Pepper Hamilton as its counsel, *nunc pro tunc* to the Involuntary Date.

7. By separate application, CS Mining will seek to employ and retain, pursuant to Bankruptcy Code section 327(a), the law firm of Snell & Wilmer L.L.P. ("Snell & Wilmer") as local bankruptcy counsel to CS Mining. Pepper Hamilton and Snell & Wilmer will make every effort to avoid and/or minimize duplication of services in this case.

8. CS Mining submits that expedited relief is necessary so that it will have appropriate representation in the immediate preparation of its Response and therefore requests that this Application be set for hearing on an expedited basis.

### **RETENTION OF PEPPER HAMILTON**

#### **Necessity For Employment**

9. CS Mining seeks to retain Pepper Hamilton as its counsel because of Pepper Hamilton's extensive experience and knowledge in the field of debtors' and creditors' rights and business reorganizations under the Bankruptcy Code. Pepper Hamilton has familiarity with CS Mining's business and affairs as well as many of the potential legal issues that may arise in this

bankruptcy case. Accordingly, CS Mining believes that Pepper Hamilton is both well-qualified and uniquely able to represent it in this chapter 11 case in an efficient and timely manner.

**Services To Be Rendered**

10. The professional services that Pepper Hamilton will render to CS Mining may include, but shall not be limited to, the following:

- (a) advising CS Mining with respect to preparing its Response to the Involuntary Petition and taking all actions necessary to prepare and prosecute the Response;
- (b) advising CS Mining with respect to its rights, powers and duties as a potential debtor and debtor-in-possession in the continued management and operation of its business and properties;
- (c) attending meetings and negotiating with representatives of creditors and other parties-in-interest;
- (d) advising and consulting CS Mining regarding the conduct of this case, including potential legal and administrative requirements of operating in chapter 11;
- (e) advising CS Mining on matters relating to the evaluation of the assumption, rejection or assignment of unexpired leases and executory contracts;
- (f) taking all necessary action to protect and preserve CS Mining's estate, including the prosecution of actions on its behalf, the defense of any actions commenced against the estate, negotiations concerning all litigation in which CS Mining may be involved and objections to claims filed against the estate;
- (g) appearing before this Court, any appellate courts, and the Office of the United States Trustee for the District of Utah (the "U.S. Trustee"), and protecting the interests of CS Mining's estate before such courts and the Office of the United States Trustee; and
- (h) performing all other necessary legal services and providing all other necessary legal advice to CS Mining in connection with the Involuntary Petition.

11. Pepper Hamilton has agreed to act on behalf of, and to render such services to, CS Mining.

**DISINTERESTEDNESS OF PEPPER HAMILTON**

12. To the best of CS Mining's knowledge, and as more fully set forth in the Detweiler Declaration, Pepper Hamilton, its partners, counsel and associates (a) are not creditors, equity security holders or insiders of CS Mining, (b) are not and were not, within two years before the Involuntary Date, directors, officers or employees of CS Mining, (c) do not hold or represent any interest materially adverse to the interest of CS Mining's estate and (d) are not related to any judge of this Court, the U.S. Trustee or any employee of the U.S. Trustee in this District.

13. Accordingly, CS Mining believes that Pepper Hamilton, its partners, counsel and associates are "disinterested persons" within the meaning of Bankruptcy Code section 101(14), as modified by Bankruptcy Code section 1107(b), and that Pepper Hamilton's representation of CS Mining is permissible under Bankruptcy Code section 327(a) and 328(a) and is in the best interests of parties-in-interest.

14. Pepper Hamilton is conducting a continuing inquiry into any matters that would affect its disinterested status. In the event additional disclosure is necessary, Pepper Hamilton will file a supplemental verified statement setting forth any facts and circumstances relevant thereto.

**PRE-INVOLUNTARY DATE PAYMENTS RECEIVED**

15. Pepper Hamilton was first retained by CS Mining on or about May 25, 2016 in connection with a state court receivership action filed against CS Mining and its majority

member Skye Mineral Partners, LLC, in the Court of Chancery in and for the State of Delaware, Civil Action No. 12381-VCS (the “Chancery Court Action”). Pepper Hamilton received a retainer totaling \$75,000 for services to be rendered in connection with the Chancery Court Action. The legal services provided in the Chancery Court Action included advising CS Mining on potential restructuring alternatives. Approximately \$56,000 of the \$75,000 retainer received by Pepper Hamilton in connection with the Chancery Court Action was exhausted prior to the Involuntary Petition Date, and Pepper Hamilton held approximately \$19,000 on retainer at the time of the Involuntary Petition Date.

16. Following the Involuntary Petition Date, CS Mining retained Pepper Hamilton to represent CS Mining as lead bankruptcy counsel to the Company in connection with the Involuntary Petition. Pepper Hamilton has continued to advise CS Mining during the Involuntary Gap period. On or about June 25, 2016, Pepper Hamilton received the sum of \$250,000 for work to be performed during the Involuntary Gap period on behalf of CS Mining. The \$250,000 retainer received by Pepper Hamilton after the Involuntary Petition Date, and the approximate \$19,000 held on retainer by Pepper Hamilton prior to the Involuntary Petition Date have not been applied and remain subject to Court approval for the legal services provided to CS Mining during the Involuntary Gap period.

### **PROFESSIONAL COMPENSATION**

17. Pursuant to Bankruptcy Code section 328(a), CS Mining may retain Pepper Hamilton on any reasonable terms and conditions. CS Mining submits that the most reasonable terms and conditions are those charged by Pepper Hamilton to CS Mining and other clients on an hourly basis in a competitive market for legal services. Therefore, CS Mining and Pepper

Hamilton have agreed that Pepper Hamilton shall be paid its customary hourly rates for services that are in effect from time to time, as set forth in the Detweiler Declaration, and shall be reimbursed according to Pepper Hamilton's customary reimbursement policies and in accordance with the applicable provisions of the Bankruptcy Code and Bankruptcy Rules, for all services performed and expenses incurred after the Involuntary Date.

18. The Pepper Hamilton attorneys and paraprofessionals staffed on this case, subject to modification depending upon further development, are as set forth below:

19. Pepper Hamilton categorizes its billings by subject matter, in compliance with the Office of the United States Trustee's *Guidelines for Reviewing Applications for Compensation (Appendix A)* (the "U.S. Trustee Guidelines"). Pepper Hamilton agrees to charge, and CS Mining has agreed to pay, subject to this Court's approval under Bankruptcy Code sections 330 and 331, the U.S. Trustee Guidelines and Bankruptcy Rule 2016, Pepper Hamilton's hourly rates, as of the Involuntary Date, which are adjusted from time to time, and range from \$415 to \$1,040 for partners and counsel, \$250 to \$595 for associates and \$105 to \$330 for paraprofessionals. Pepper Hamilton is customarily reimbursed for all expenses it incurs in connection with its representation of a client in a given matter. Such expenses include, without

limitation, travel costs, telecommunications, express mail, messenger service, photocopying costs, document processing, computerized research charges, court fees and transcript costs.

20. CS Mining understands that, from time to time, it may be necessary for professionals and paraprofessionals employed by Pepper Hamilton, other than those set forth above, to provide services to CS Mining. CS Mining further understands that the hourly rates set forth above are subject to periodic adjustments to reflect economic and other conditions, which adjustments typically occur on January 1 of each year, but may also occur during the calendar year.

21. Pepper Hamilton acknowledges that all amounts paid to Pepper Hamilton during the case are subject to final allowance by this Court. Pepper Hamilton therefore intends to apply to this Court for allowance of compensation and reimbursement of expenses in accordance with applicable provisions of the Bankruptcy Code, Bankruptcy Rules, the U.S. Trustee Guidelines and any orders relevant thereto for all services performed and expenses incurred after the Involuntary Date.

22. No arrangement is proposed between CS Mining and Pepper Hamilton for compensation to be paid in this case other than as set forth above and in the Detweiler Declaration.

### **BASIS FOR RELIEF**

23. Bankruptcy Code section 327(a) provides that a debtor, subject to court approval:

[M]ay employ one or more attorneys, accountants, appraisers, auctioneers, or other professional persons, that do not hold or represent an interest adverse to the estate, and that are disinterested persons, to represent or assist the [debtor] in carrying out the [debtor]'s duties under this title.



11 U.S.C § 327(a). Moreover, Bankruptcy Rule 2014 requires that an application for retention include:

[S]pecific facts showing the necessity for the employment, the name of the [firm] to be employed, the reasons for the selection, the professional services to be rendered, any proposed arrangement for compensation, and, to the best of the applicant's knowledge, all of the [firm's] connections with the debtor, creditors, any other party in interest, their respective attorneys and accountants, the United States Trustee, or any person employed in the office of the United States Trustee.

Fed. R. Bankr. P. 2014.

24. The terms of this engagement were negotiated by CS Mining and Pepper Hamilton at arm's-length and in good faith. CS Mining and Pepper Hamilton respectfully submit that the terms of Pepper Hamilton's retention are customary and reasonable for similar engagements, both out-of-court and in comparable chapter 11 cases, and in the best interests of CS Mining's estate, its creditors and all parties-in-interest.

### **NOTICE**

25. Notice of this Application has been provided to: (a) the Office of the United States Trustee for the District of Utah, (b) the Petitioning Creditors, and (c) any other parties-in-interest who have filed a notice of appearance and request for service in this case to date. In light of the nature of the relief requested, CS Mining submits that no other or further notice is necessary.


26. No prior motion or application for the relief requested herein has been made to this or any other court.

WHEREFORE, CS Mining respectfully requests that the Court enter an order (i) approving CS Mining's employment and retention of Pepper Hamilton as counsel pursuant to

11 U.S.C. §§ 327(a) and 328(a) and Fed. R. Bankr. P. 2014(a) *nunc pro tunc* to the Involuntary Date and (ii) granting such further relief as this Court deems just and proper.



**DECLARATION OF DONALD J. DETWEILER IN SUPPORT OF APPLICATION OF CS MINING, LLC FOR ENTRY OF AN ORDER AUTHORIZING THE EMPLOYMENT AND RETENTION OF PEPPER HAMILTON LLP AS COUNSEL TO CS MINING, LLC, NUNC PRO TUNC TO THE INVOLUNTARY DATE**

I, DONALD J. DETWEILER, under penalty of perjury, states as follows:

1. This declaration (the “Declaration”) is being submitted in support of the application (the “Application”) of involuntary debtor CS Mining, LLC (the “CS Mining”) for entry of an order authorizing the employment and retention of Pepper Hamilton LLP (“Pepper Hamilton”) as counsel to CS Mining.

2. I am a partner in the law firm of Pepper Hamilton. I make this Declaration pursuant to sections 327, 328, 329 and 504 of title 11 of the United States Code (11 U.S.C. §§ 101 *et seq.*, the “Bankruptcy Code”) and Rules 2014 and 2016(b) of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”).

3. Unless otherwise stated, I have personal knowledge of the facts set forth herein. To the extent that any information disclosed herein requires amendment or modification upon Pepper Hamilton’s completion of further analysis or as additional party-in-interest information becomes available to me, Pepper Hamilton will submit a supplemental verified statement to this Court.

**SERVICES TO BE RENDERED**

4. CS Mining is seeking to employ and retain, pursuant to Bankruptcy Code section 327(a), the law firm of Snell & Wilmer L.L.P. (“Snell & Wilmer”) as local bankruptcy counsel to CS Mining. Pepper Hamilton will make every effort to avoid and/or minimize duplication of services with Snell & Wilmer in this case.

5. The professional services that Pepper Hamilton will render to CS Mining may include, but shall not be limited to, the following:

- (a) advising CS Mining with respect to preparing its Response to the Involuntary Petition and taking all actions necessary to prepare and prosecute the Response;
- (b) advising CS Mining with respect to its rights, powers and duties as a potential debtor and debtor-in-possession in the continued management and operation of its business and properties;
- (c) attending meetings and negotiating with representatives of creditors and other parties-in-interest;
- (d) advising and consulting CS Mining regarding the conduct of this case, including potential legal and administrative requirements of operating in chapter 11;
- (e) advising CS Mining on matters relating to the evaluation of the assumption, rejection or assignment of unexpired leases and executory contracts;

6. Pepper Hamilton has agreed to act on behalf of, and to render such services to, CS Mining.

**PEPPER HAMILTON'S PROCEDURES**

7. In preparing this Declaration, I utilized a set of procedures established by Pepper Hamilton to ensure compliance with the Bankruptcy Code and the Bankruptcy Rules regarding the employment of professionals by debtors-in-possession under the Bankruptcy Code.

8. In that connection, I caused to be submitted the names of the significant parties-in-interest in this case that are known to me after inquiry for review under the conflict check system maintained by Pepper Hamilton. Using information provided by CS Mining, I compared the names of CS Mining and potential parties-in-interest to the names that Pepper Hamilton has compiled into its conflict check system and adverse party index. A list of the Searched Parties is attached to this Declaration as **Exhibit 1**.

9. Pepper Hamilton maintains and systematically updates this conflict check system in the regular course of its business, and it is the regular practice of Pepper Hamilton to make and maintain these records. The conflict check system maintained by Pepper Hamilton is designed to include (i) every matter for which Pepper is now or has been engaged; (ii) the entity by which Pepper is now or has been engaged; (iii) the identity of related parties; (iv) the identity of adverse parties; and (v) the attorney in Pepper Hamilton that is knowledgeable about the matter. It is the policy of Pepper Hamilton that no new matter may be accepted or opened within Pepper Hamilton without completing and submitting to those charged with maintaining the conflict check system the information necessary to check each such matter for conflicts, including the identity of the prospective client, the matter and related and adverse parties.

Accordingly, the database is regularly updated for every new matter undertaken by Pepper Hamilton. The scope of the system is a function of the completeness and accuracy of the information submitted by the attorney opening a new matter. Any matches between Pepper Hamilton's conflict check system and the Searched Parties were identified and reviewed (the "Client Match List"). The Client Match List is attached hereto as **Exhibit 2**. As additional parties-in-interest appear in this case, Pepper Hamilton will submit their names to its conflict check system and update its disclosures, as necessary.

#### **DISINTERESTEDNESS OF PEPPER HAMILTON**

10. To the best of my knowledge, information and belief, except as otherwise disclosed herein, neither I nor Pepper Hamilton, its partners, counsel and associates (a) are not creditors, equity security holders or insiders of CS Mining, (b) are not and were not, within two years before the Involuntary Date, directors, officers or employees of CS Mining, (c) do not hold or represent any interest materially adverse to the interest of CS Mining estate and (d) are not related to any judge of this Court, the U.S. Trustee or any employee of the U.S. Trustee in this District.

11. To the best of my knowledge, information and belief, except as otherwise disclosed herein, neither I nor Pepper Hamilton, its partners, counsel or associates have any connection with Cs Mining or any other parties-in-interest in this chapter 11 case, except that Pepper Hamilton represented in the past five years, currently represents, and may represent in the future those entities listed on **Exhibit 2**. Certain of the entities listed on **Exhibit 2** are dormant or inactive clients at this time. In the case of each of the entities listed on **Exhibit 2**, the revenues derived from such client during the past calendar year represents less than 1% of the

firm's revenues. Except to the extent disclosed above, Pepper Hamilton has not in the past represented, does not currently represent, and will not in the future represent, any of the entities listed on **Exhibit 2** in connection with these cases or in any matter adverse to CS Mining CS Mining.

12. As part of its everyday practice, Pepper Hamilton appears in numerous bankruptcy, litigation and other cases, proceedings and transactions, in which it has worked and is working with and against numerous attorneys, accountants, financial consultants, investment bankers and other professionals who represent or may in the future represent creditors or other parties-in-interest in this case. Pepper Hamilton has not and will not represent any of such entities in relation to CS Mining and this chapter 11 case or have any relationship with any such entity, attorneys, accountants, financial consultants and investment bankers which would be adverse to CS Mining or its estate.

13. Accordingly, I submit that, to the best of my knowledge, information and belief, both myself and Pepper Hamilton, its partners, counsel and associates are "disinterested persons" within the meaning of Bankruptcy Code section 101(14), as modified by Bankruptcy Code section 1107(b), and Pepper Hamilton's representation of CS Mining is permissible under Bankruptcy Code sections 327(a) and 328(a) and is in the best interests of parties-in-interest.

#### **PRE-INVOLUNTARY DATE PAYMENTS RECEIVED**

14. Pepper Hamilton was first retained by CS Mining on or about May 25, 2016 in connection with a state court receivership action filed against CS Mining and its majority member Skye Mineral Partners, LLC in the Court of Chancery in and for the State of Delaware, Civil Action No. 12381-VCS (the "Chancery Court Action"). Pepper Hamilton received a

retainer totaling \$75,000 for services to be rendered in connection with the Chancery Court Action. The legal services provided in the Chancery Court Action included advising CS Mining on potential restructuring alternatives. Approximately, \$56,000 of the \$75,000 retainer received by Pepper Hamilton in connection with the Chancery Court Action was exhausted prior to the Involuntary Petition Date and Pepper Hamilton held approximately \$19,000 on retainer at the time of the Involuntary Petition Date.

15. Following the Involuntary Petition Date, CS Mining retained Pepper Hamilton to represent CS Mining as lead bankruptcy counsel to the Company in connection with the Involuntary Petition. Pepper Hamilton has continued to advise CS Mining during the Involuntary Gap period.

16. On or about June 25, 2016, Pepper Hamilton received the sum of \$250,000 for work to be performed during the Involuntary Gap period on behalf of CS Mining. The \$250,000 retainer received by Pepper Hamilton after the Involuntary Petition Date, and the approximate \$19,000 held on retainer by Pepper Hamilton prior to the Involuntary Petition Date, have not been applied and remain subject to Court approval for the legal services provided to CS Mining during the Involuntary Gap period.

### **PROFESSIONAL COMPENSATION**

17. Pepper Hamilton categorizes its billings by subject matter, in compliance with the Office of the United States Trustee's *Guidelines for Reviewing Applications for Compensation (Appendix A)* (the "U.S. Trustee Guidelines"). Pepper Hamilton agrees to charge, and CS Mining has agreed to pay Pepper Hamilton's normal hourly rates, subject to this Court's approval pursuant to Bankruptcy Code sections 330 and 331, the U.S. Trustee Guidelines and

Bankruptcy Rule 2016.

18. The Pepper Hamilton attorneys and paraprofessionals staffed on this case, subject to modification depending upon further development, are as set forth below:

19. The hourly rates set forth above are subject to periodic adjustments to reflect economic and other conditions and are typically reviewed by Pepper Hamilton at the beginning of the calendar year. Other attorneys and paralegals may from time to time serve CS Mining in connection with the matters herein described.

20. Pepper Hamilton is customarily reimbursed for all expenses it incurs in connection with its representation of a client in a given matter. Such expenses include, without limitation, travel costs, telecommunications, express mail, messenger service, photocopying costs, document processing, computerized research charges, court fees, and transcript costs.

21. Pepper Hamilton acknowledges that all amounts paid to Pepper Hamilton during this chapter 11 case are subject to final allowance by this Court. Pepper Hamilton therefore intends to apply to this Court for allowance of compensation and reimbursement of expenses in accordance with applicable provisions of the Bankruptcy Code, Bankruptcy Rules, U.S. Trustee

Guidelines and any orders relevant thereto for all services performed and expenses incurred after the Involuntary Date.

22. No arrangement is proposed between CS Mining and Pepper Hamilton for compensation to be paid in this case other than as set forth herein.


23. Based on the statements contained herein, I believe that Pepper Hamilton is eligible for employment and retention by CS Mining.
