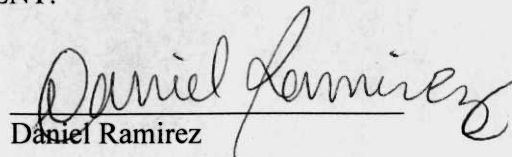

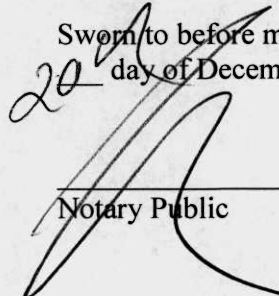

**NOTICE OF SALE PROCEDURES,

PLEASE TAKE NOTICE that on November 15, 2016, the above-captioned debtors and debtors in possession (the “Debtors”) filed the *Motion of the Debtors and Debtors in Possession Pursuant to Section 105(a), 363, and 365 of the Bankruptcy Code for Entry of Orders (I)(A) Approving Procedures in Connection with the Sale of Substantially All of the Debtors’ Assets; (B) Scheduling Related Auction and Hearing to Consider Approval of Sale; (C) Approving Procedures Related to the Assumption of Certain Executory Contracts and Unexpired Leases; (D) Approving the Form and Manner of Notice Thereof; (E) Approving Bid Protections; and (F) Granting Related Relief; and (II)(A) Authorizing the Sale of the Substantially All of the Debtors’ Assets Free and Clear of Liens, Claims, Encumbrances, and Other Interests; (B) Approving the Assumption and Assignment of Certain Executory Contracts and Unexpired Leases; and (C) Granting Related Relief* (the “Motion”).² The Debtors seek, among other things, to sell their Assets to the successful bidder (the “Successful Bidder”) at an auction free and clear of all liens, claims, encumbrances, and other interests pursuant to sections 363 and 365 of the Bankruptcy Code.

PLEASE TAKE FURTHER NOTICE that on December 6, 2016, the Court entered an order (the “Bidding Procedures Order”) approving certain aspects of the Motion and the proposed bidding procedures (the “Bidding Procedures”).
