STIPULATION AND AGREED ORDER RESOLVING
PROOF OF CLAIM NUMBERS 1630, 1637, 1638, 1639, 1640, 1641, 1642
FILED BY THE DEPARTMENT OF THE INTERIOR

The Reorganized Debtors in the above-captioned chapter 11 cases and the United States Department of the Interior ("Interior"; collectively with the Reorganized Debtors, the "Parties"), by and through their respective undersigned counsel, respectfully submit this Stipulation and Agreed Order Resolving Proof of Claim Numbers 1630, 1637, 1638, 1639, 1640, 1641 and 1642 (the "Stipulation"), and hereby agree and state as follows:

RECITALS

WHEREAS, on April 14, 2016 (the "Petition Date"), each of the Reorganized Debtors filed voluntary petitions for relief under chapter 11, title 11 of the United States Code, 11 U.S.C. §§ 101 *et seq.* in the United States Bankruptcy Court for the Southern District of Texas (the "Court");

WHEREAS, on or about October 10, 2016, the Office of Natural Resources Revenue ("ONRR"), an agency of Interior, filed Proof of Claim No. 1630 (the "ONRR Claim") against debtor, Energy XXI GOM, LLC, in the amount of \$975,734.28 for unpaid federal oil and gas royalties and civil penalties;

WHEREAS, on or about October 11, 2016, the Bureau of Safety and Environmental Enforcement ("BSEE"), an agency of Interior, filed protective Proofs of Claim Nos. 1637, 1638, 1639, 1640, 1641 and 1642 (collectively, the "BSEE Claims"; together with the ONRR Claim,

the “Interior Claims”) in the *estimated* amounts of \$1,025,206,411.00, \$1,247,332,078.00, \$2,898,833.00, \$5,719,486.00, \$350,709.00 and \$584,088,792.00, respectively, against debtors, EPL Oil and Gas, Inc., Energy XXI GOM, LLC, Energy XXI Pipeline, LLC, Energy XXI Pipeline II, LLC, EPL Pipeline LLC and M21K LLC, respectively, for performance of the debtors’ and Reorganized Debtors’ decommissioning obligations under The Outer Continental Shelf Lands Act, 43 U.S.C. §§ 1331 *et seq.* (“OCSLA”) and its implementing regulations found in, among other places, 30 C.F.R. Part 250;

WHEREAS, on December 13, 2016, the Court entered Findings of Fact, Conclusions of Law, and Order Confirming the Debtors’ Second Amended Joint Chapter 11 Plan of Reorganization (ECF No. 1809) (the “Confirmation Order”), which annexed the Debtors’ Second Amended Proposed Joint Chapter 11 Plan of Reorganization (the “Plan”) as Exhibit 1 thereto and a schedule of documents that were required to be produced to ONRR as Exhibit 2 thereto, and the Plan went effective as of December 30, 2016;

WHEREAS, in paragraphs 155 through 163 of the Confirmation Order, the Reorganized Debtors assumed and succeeded to all regulatory obligations applicable to their respective Federal Lease Interests (as defined in the Confirmation Order), along with any contractual obligations set forth in the applicable federal leases, grants of rights-of-way and rights-of-use-and-easement, which included, among other obligations, any and all: (i) financial assurance obligations, (ii) decommissioning obligations, (iii) maintenance and monitoring obligations and (iv) monetary obligations that may be owing by the Reorganized Debtors to Interior, while fully preserving Interior’s rights to demand any additional payments that may come due to Interior pursuant to the Reorganized Debtors’ Federal Lease Interests after an audit or compliance review has been performed, without those rights being adversely effected by the Reorganized Debtors’

bankruptcy cases and with those rights preserved as if no bankruptcy had been filed;

WHEREAS all mandatory performance obligations and monetary obligations that may be owing to Interior pursuant to the Interior Claims are preserved and remain intact pursuant to paragraphs 155 through 163 of the Confirmation Order and all such obligations are expressly reaffirmed by the Reorganized Debtors in this Stipulation and, therefore, there is no need for any distribution to Interior on account of the Interior Claims;

WHEREAS the Parties have reached an agreement on the terms set forth herein with respect to the Interior Claims;

NOW, THEREFORE, in consideration of the mutual covenants contained herein, and other good and valuable consideration, the Parties hereby stipulate and agree as follows:

AGREEMENT

1. The Stipulation resolves the Interior Claims in accordance with the terms hereof.
2. All of the foregoing recitals are incorporated into the terms of this Stipulation as if fully set forth herein.
3. This Stipulation shall become effective upon the date in which the Court enters an Order approving the Stipulation and such Order becomes final and no longer subject to appeal.
4. The Reorganized Debtors have assumed and succeeded to all of the regulatory and contractual obligations set forth in paragraphs 155 through 163 of the Confirmation Order and Interior expressly reserves all of its rights set forth therein. Nothing in this Stipulation shall be construed, applied, or interpreted to change the terms of the Confirmation Order or the Plan in any respect or provide the Parties with any greater rights or obligations than are set forth in paragraphs 155 through 163 of the Confirmation Order.
5. In reliance on the Reorganized Debtors' assumption of, and succession to, all

regulatory and contractual obligations set forth in paragraphs 155 through 163 of the Confirmation Order including, without limitation, the Reorganized Debtors' agreement to pay all monetary obligations owing to Interior in the ordinary course of business as if no bankruptcy had been filed, Interior agrees to withdraw the Interior Claims and no distributions need be made to Interior pursuant to the Interior Claims.

6. The Interior Claims shall be deemed withdrawn pursuant to the terms of this Stipulation with no further action being required of Interior, and the Reorganized Debtors' claims and noticing agent is authorized to take all actions necessary to effectuate the terms of this Stipulation.

7. The Court shall retain jurisdiction to resolve any disputes or controversies arising from, or related to, this Stipulation or paragraphs 155 through 163 of the Confirmation Order.

8. This Stipulation may be executed in counterparts, each of which shall be deemed an original, but all of which together will constitute one and the same agreement.

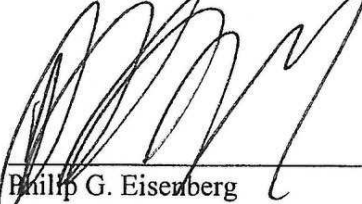
9. This Stipulation is binding upon the Parties and any of their respective successors and assigns.

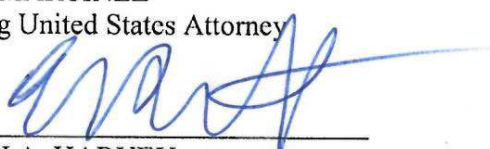

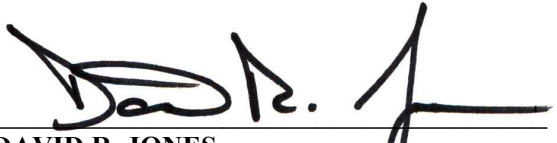
