STIPULATION AND AGREED ORDER RESOLVING
OBJECTION OF U.S. SECURITY ASSOCIATES, INC. TO
THE NOTICE OF PROPOSED CURE AMOUNT WITH RESPECT TO EXECUTORY
CONTRACT TO BE ASSUMED AND ASSIGNED UNDER THE THIRD AMENDED
JOINT CHAPTER 11 PLAN OF REORGANIZATION OF CERTAIN AFFILIATED
DEBTORS OF EMAS CHIYODA SUBSEA LIMITED AND RESOLVING
PROOF OF CLAIM NO. 231 FILED BY U.S. SECURITY ASSOCIATES, INC.

EMAS CHIYODA Subsea Inc. and certain of its affiliates, as debtors (collectively, "Debtors") in the above-captioned chapter 11 cases, U.S. Security Associates, Inc. ("U.S. Security"), and Subsea 7 Marine (US), Inc. ("Assignee," and collectively with the Debtors and U.S. Security, the "Parties"), stipulate and agree, by and through their respective undersigned counsel, as follows:

Recitals:

- A. WHEREAS, on February 27, 2017, Debtors filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code, 11 U.S.C. § 101 *et seq*.
- B. WHEREAS, prepetition, U.S. Security and EMAS AMC, Inc. (now known as EMAS CHIYODA Subsea Inc.) ("EMAS") entered into that certain Master Services Agreement

dated March 17, 2016 (as amended or supplemented, the "Contract"), pursuant to which U.S. Security provided security services to EMAS at the EMAS Marine Base in Ingleside, Texas.

- C. WHEREAS, on April 4, 2017, the Debtors filed the Summary of Assets and Liabilities Schedules for EMAS Chiyoda Subsea Inc. [Docket No. 233], in which it scheduled a nonpriority claim of U.S. Security in the amount of \$88,204.84 (the "Scheduled Claim").
- D. WHEREAS, on April 28, 2017, U.S. Security filed proof of claim number 231 (the "Filed Claim," and together with the Scheduled Claim, the "Claims") asserting a general unsecured claim against EMAS Chiyoda Subsea Inc. in the amount of \$85,551.55 on account of amounts owed under the Contract.
- E. WHEREAS, on June 16, 2017, Debtors served their Notice of Cure Amount with respect to the Contract, wherein Debtors proposed to pay U.S. Security \$41,392.00 as the cure amount and proposed to assign the Contract to Subsea 7 Marine (US), Inc. ("Assignee");
- F. WHEREAS, on June 26, 2017, U.S. Security filed its Objection [Docket No. 539] to the Notice of Cure (the "Objection");
- G. WHEREAS, Debtors and U.S. Security have agreed to the proposed assumption and assignment of the Contract to Assignee subject to entry of an order, as set forth herein.

Stipulation and Order

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED BY THE PARTIES, THROUGH THEIR UNDERSIGNED COUNSEL, AND IT IS HEREBY ORDERED AND ADJUDGED THAT:

1. The recitals set forth above are true and correct and are incorporated herein by reference as if restated in full.

- 2. The Parties stipulate, affirm and agree that, as conditions to the assumption and assignment of the Contract to Assignee and to fully and finally resolve the Objection and the Claims:
 - (a) Within five (5) business days of entry of this Order, the Assignee shall pay U.S. Security the sum of \$56,000.00 (the "Cure Amount") on account of prepetition amounts owed by Debtors to U.S. Security in full and final satisfaction of any and all prepetition amounts owed by the Debtors to U.S. Security, including the Claims;
 - (b) Within five (5) business days of entry of this Order, the Assignee shall pay U.S. Security the sum of \$2,667.29 (the "Postpetition Amounts") on account of postpetition services rendered by U.S. Security to Debtors through and including June 29, 2017; and
 - (c) Upon payment of the Cure Amount, U.S. Security will be deemed to release and waive any and all other prepetition claims that Claimant may have against the Debtors, their estates, or their successors or assigns. Upon payment of the Post-Petition Amounts, U.S. Security will be deemed to release and waive any and all postpetition administrative expense claims that Claimant may have against the Debtors, their estates, or their successors or assigns on account of claims arising prior to June 29, 2017.
- 3. Assignee shall be liable for amounts owed on account of all services rendered on or after June 29, 2017 by U.S. Security pursuant to the Contract.

- 4. The claims agent is hereby authorized and directed to modify and update its claims register to reflect the relief granted in this Stipulation and Order upon payment of the Cure Amount.
- 5. This Stipulation and Order may not be modified, altered or amended except in writing signed by the parties hereto.
- 6. The Debtors are authorized and empowered to take all actions necessary to implement the relief granted in this Stipulation and Order.
- 7. The Court shall retain exclusive jurisdiction to interpret, implement and enforce the provisions of this Stipulation and Order.
