**ORDER (I) APPROVING MARKETING PROCESS PROCEDURES,
(II) AUTHORIZING THE DEBTORS TO PAY THE FEES AND EXPENSES
OF THE NOTEHOLDER ADVISORS, AND (III) GRANTING RELATED RELIEF**

Upon the motion (the “Motion”),² of the above-captioned debtors and debtors in possession (the “Debtors”) for the entry of an order (this “Order”), (a) approving the marketing process procedures attached to this Order as Exhibit 1, whereby the Debtors will attempt to identify

potential purchasers for certain of their assets or equity interests (the “Marketing Process Procedures”), (b) authorizing the Debtors to pay the reasonable documented fees and expenses of Davis Polk & Wardwell, LLP, Ducera Partners LLC, Carmen L. Gentile, PLLC, Quinn Emanuel Urquhart & Sullivan, LLP, Richards, Layton & Finger, PA, Ropes & Gray, LLP, Couch White, LLP, Porter Hedges, LLP, and one additional local bankruptcy counsel in Texas (collectively, the “Noteholder Advisors”), as the professional advisors to the Ad Hoc GenOn Notes Committee and the Ad Hoc GAG Notes Committee (collectively, the “Noteholder Groups”), and (c) granting related relief, all as more fully set forth in the Motion; and this Court having jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334 and the Amended Standing Order; this Court having found that this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); and this Court having found that it may enter a final order consistent with Article III of the United States Constitution; and this Court having found that venue of this proceeding and the Motion in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and this Court having found that the relief requested in the Motion is in the best interests of the Debtors’ estates, their creditors, and other parties in interest; and this Court having found that the Debtors’ notice of the Motion and opportunity for a hearing on the Motion were appropriate under the circumstances and no other notice need be provided; and this Court having reviewed the Motion and having heard the statements in support of the relief requested therein at a hearing before this Court (the “Hearing”); and this Court having determined that the legal and factual bases set forth in the Motion and at the Hearing establish just cause for the relief granted herein; and upon all of the proceedings had before this Court; and after due deliberation and sufficient cause appearing therefor, it is HEREBY ORDERED THAT:

1. The Motion is granted as provided herein.
2. The Marketing Process Procedures, substantially in the form attached hereto as Exhibit 1, are approved in their entirety. The Debtors are authorized to take any and all actions

reasonably necessary or appropriate to implement the Marketing Process Procedures. The failure to specifically include or reference a particular provision of the Marketing Process Procedures in this Order shall not diminish or impair the effectiveness of such provision.

3. The Debtors are authorized, in accordance with the Marketing Process Procedures, to require Bidders to submit Bids specifying, among other things, the Assets proposed to be acquired, the amount and type of consideration to be offered, and any other material terms to be included in a Bid by such party.

4. For the avoidance of doubt, the Debtors reserve their rights, following consultation with their advisors, to modify the Marketing Process Procedures in any manner that they determine will best promote the goals of the bidding process or impose additional customary terms and conditions on the Transaction, including, without limitation, modifying the Bid Requirements, extending the deadlines set forth in the Marketing Process Procedures, and rejecting any or all Bids, in the Debtors' business judgment.

5. The Debtors are authorized, but not directed, to pay the Fees and Expenses on a current basis as they become due in the ordinary course and in accordance with the RSA; *provided* that Noteholder Advisors who request payment pursuant to this Order shall submit invoices for Fees and Expenses incurred each month no later than the day that is twenty (20) days after the end of such month (which invoices shall include the number of hours billed and a reasonably detailed description of the services provided and the expenses incurred by the applicable professional; *provided*, however, that any such invoice (i) may be redacted to protect privileged, confidential or proprietary information and (ii) shall not be required to contain individual time detail) to the Debtors and the U.S. Trustee in connection with such requests (each, a "Restructuring Expense Statement"). On, or as soon as reasonably practicable after, the 30th day of the month following receipt of a monthly Restructuring Expense Statement, the Debtors shall file a notice (each, a "Fee

Notice") that discloses the Fees and Expenses on an aggregate basis, per professional, requested pursuant to such Restructuring Expense Statements and advises parties in interest of the opportunity to object as set forth herein. Any objections raised by the Debtors or the U.S. Trustee with respect to the reasonableness of such requests shall be made within ten (10) days of filing the applicable Fee Notice (the "Fee Notice Period") and the Court will have jurisdiction to determine the disputed portion of such Restructuring Expense Statement if the parties are unable to resolve the dispute or any issues the Court raises sua sponte. If any other party in interest wishes to object to the reasonableness of any Fees and Expenses disclosed in a Fee Notice, such party should contact the Debtors or the U.S. Trustee to request a copy of the applicable Restructuring Expense Statement and file with the Court and serve on the applicable Noteholder Advisor an objection prior to expiration of the Fee Notice Period (each, a "Fee Objection") limited to the issue of the reasonableness of such Fees and Expenses. Pending resolution of any Fee Objection, the undisputed portion of any such invoice will be paid promptly by the Debtors in accordance with the terms of this Order and the Court will have jurisdiction to determine the disputed portion of such Restructuring Expense Statement if the parties are unable to resolve the dispute or any issues the Court raises sua sponte.

6. The payment of the Fees and Expenses is hereby approved as reasonable and shall not be subject to any avoidance, reduction, setoff, recoupment, offset, recharacterization, subordination (whether contractual, equitable, or otherwise), counterclaims, cross-claims, defenses, disallowance, impairment, or any other challenges under any applicable law or regulation by any person or entity.

7. The Fees and Expenses shall not be discharged, modified, or otherwise affected by any chapter 11 plan of the Debtors, dismissal of these cases, or conversion of these chapter 11

cases to chapter 7 cases, nor shall any of such amounts be required to be disgorged upon the reversal or modification on appeal of this Order.

8. The Debtors are authorized to take all actions necessary to effectuate the relief granted pursuant to this Order in accordance with the Motion.

9. This Order shall be binding on and inure to the benefit of the Debtors, including any chapter 7 or chapter 11 trustee or other fiduciary appointed for the estates of the Debtors.

10. To the extent this Order is inconsistent with any prior order or pleading with respect to the Motion in these cases, the terms of this Order shall govern.

11. To the extent any of the deadlines set forth in this Order do not comply with the Local Rules, such Bankruptcy Local Rules are waived and the terms of this Order shall govern.

12. Notwithstanding the possible applicability of Bankruptcy Rules 6004(h), 6006(d), 7062, 9014, or otherwise, this Court, for good cause shown, orders that the terms and conditions of this Order shall be immediately effective and enforceable upon its entry.

13. This Court shall retain exclusive jurisdiction with respect to all matters arising from or related to the implementation or interpretation of this Order, including, but not limited to, any matter, claim, or dispute arising from or relating to the Marketing Process Procedures and the implementation of this Order.

MARKETING PROCESS PROCEDURES

On [____], 2017, the United States Bankruptcy Court for the Southern District of Texas (the “Bankruptcy Court”) entered an order approving these Marketing Process Procedures (these “Marketing Process Procedures,” and such order, the “Marketing Process Procedures Order”),² in the jointly-administered chapter 11 cases (the “Chapter 11 Cases”) of GenOn Energy, Inc. (“GenOn”) and certain of its affiliates (collectively, the “Debtors”). The Bankruptcy Court will have jurisdiction with respect to any dispute that may arise with respect to these Marketing Process Procedures.

These Marketing Process Procedures set forth the process by which the Debtors are

authorized to solicit proposals (“Bids” and, the persons or entities submitting such Bids, “Bidders”) for an investment, in any form, to acquire any or all of the assets, or equity interests in, GenOn or one or more of its direct and indirect subsidiaries (or any successor entities thereof) (collectively, the “Assets”) to be sold or issued (as applicable) in accordance with title 11 of the United States Code (the “Bankruptcy Code”).

Under these Marketing Process Procedures, the Debtors will run a two-stage marketing process (the “Marketing Process”), beginning with an initial bidding process to evaluate interest in the Assets. If the Debtors determine, in consultation with NRG, the steering committee of the Ad Hoc GenOn Notes Committee and, with respect to Assets of any direct and/or indirect subsidiaries of GenOn Americas Generation, LLC, the steering committee of the Ad Hoc GAG Notes Committee (collectively, the “Reviewing Parties”), that sufficient interest in the Assets exists, the Debtors may elect to proceed to a second phase in which select Bidders will have an opportunity to conduct additional due diligence and the parties will negotiate definitive documentation and work toward the consummation of one or more sales of the Assets pursuant to a separate court order, which may include approval through their plan of reorganization [Docket No. 141] (as may be amended, modified, or supplemented from time to time, the “Plan” and, each such sale, a “Transaction”).

Copies of the Marketing Process Procedures Order or other documents related thereto are available on the website of the Debtors’ claims and noticing agent at <http://dm.epiq11.com/GenOn>.

A. Submissions to the Debtors.

All submissions to the Debtors required to be made under these Marketing Process Procedures must be directed to each the following persons unless otherwise provided (collectively, the “Debtors’ Representatives”):

(shubi.arora@kirkland.com), and Kim Hicks (kim.hicks@kirkland.com); and
2. **Financial Advisor.** Financial advisor to the Debtors, Credit Suisse Securities (USA) LLC, 11 Madison Avenue, New York, New York 10010, Attn.: Jonathon R. Kaufman (jonathon.kaufman@credit-suisse.com) and Pierre Bosse (pierre.bosse@credit-suisse.com).

B. Participation Requirements.

To participate in the Marketing Process or otherwise be considered for any purpose under these Marketing Process Procedures, a person or entity interested in consummating a Transaction (a “Potential Purchaser”) must deliver or have previously delivered, if determined to be necessary

by the Debtors in their sole discretion, an executed confidentiality agreement on terms acceptable to the Debtors (a “Confidentiality Agreement”), to the extent not already executed. Each Potential Purchaser who has executed a Confidentiality Agreement may submit a Bid (each, an “Acceptable Bidder”).

C. The Marketing Process.

Under the two-stage Marketing Process, in the initial stage (“Phase I”), Acceptable Bidders may submit preliminary materials to the Debtors (each an “Indicative Bid”), and the Debtors may select certain Acceptable Bidders (the “Phase II Parties”), based on the Bid Criteria (as defined below), to advance to the second phase (“Phase II”). During Phase II, Phase II Parties will be given an opportunity to conduct additional due diligence and will prepare and submit definitive documentation (each a “Final Bid”). At the conclusion of this process, the Debtors will, in consultation with the Reviewing Parties, select the highest or otherwise best Final Bid submitted by a Phase II Party to execute a purchase and sale agreement.

D. Phase I.

Acceptable Bidders will receive a teaser and a confidential information package, including certain diligence information about the Debtors and the Assets.

Acceptable Bidders must deliver to each of the Debtors’ Representatives an executed non-binding letter of intent complying with each of the applicable Bid Requirements set forth below (collectively, the “Indicative Bid Documentation”) so that it is **actually received** no later than **12:00 p.m. (prevailing Eastern Time) on October 6, 2017** (the “Phase I Bid Deadline”), unless such date is extended by the Debtors.

The Indicative Bid Documentation should be submitted as an executed PDF. Indicative Bid Documentation may not be submitted or modified after the Phase I Bid Deadline except as otherwise agreed by the Debtors.

As soon as reasonably practicable after the Phase I Bid Deadline, the Debtors will determine, in consultation with the Reviewing Parties, and notify each Acceptable Bidder, if such Acceptable Bidder, based on the Bid Criteria, has been selected to advance to Phase II.

Depending on the Indicative Bids received, the Debtors may, in consultation with the Reviewing Parties, determine not to commence Phase II.

E. Phase II.

As soon as reasonably practicable after the selection of the Phase II Parties, if any, the Phase II Parties will be given access to an electronic data room containing detailed information about the Assets. The Phase II Parties will also be invited to a management presentation and a site visit and will have the opportunity to submit due diligence questions.

The Debtors will then distribute to all Phase II Parties a form of definitive documentation to effectuate their Final Bids (collectively, the “Phase II Bid Documentation”).

The Debtors will engage in further negotiation with each of the Phase II Parties regarding the Phase II Bid Documentation. Phase II Parties must submit a substantially final draft of their Phase II Bid Documentation to each of the Debtors' Representatives so that it is **actually received** by a date to be determined by the Debtors upon the conclusion of Phase I (the "Final Bid Deadline"), unless such date is extended by the Debtors. The Phase II Bid Documentation should be submitted both as an executed PDF and in word version, along with a marked version of all Phase II Bid Documentation against the form provided by the Debtors.

As soon as reasonably practicable after the Final Bid Deadline, the Debtors will evaluate the Phase II Bid Documentation submitted by each Phase II Party based on the Bid Criteria and engage in additional negotiations to finalize such Phase II Bid Documentation with one or more Phase II Parties in their sole discretion.

Following the additional negotiations to finalize the Phase II Bid Documentation, the Debtors may select one or more Phase II Parties that have submitted the highest or otherwise best Final Bids in accordance with the Bid Criteria to execute a purchase and sale agreement (each Final Bid, a "Successful Bid," and each Phase II Party, a "Successful Bidder") with respect to any or all of the Assets. At such time, the Successful Bidder and the Debtors will execute all Phase II Bid Documentation upon which each Successful Bid was made (each a "Purchase and Sale Agreement") and file a notice with the Bankruptcy Court announcing the Successful Bidder(s).

For the avoidance of doubt, the Debtors may determine not to select any Successful Bid if, in their business judgment, it would not maximize the value of their estates.

F. Obtaining Due Diligence Access.

To conduct due diligence, an Acceptable Bidder must execute a Confidentiality Agreement acceptable to the Debtors. **No Acceptable Bidder will be permitted to conduct any due diligence without entry into a Confidentiality Agreement.** The Debtors will provide each Acceptable Bidder or such Acceptable Bidder's duly-authorized representatives reasonable access to due diligence information with respect to the Assets in accordance with the applicable Confidentiality Agreement. The Debtors and their advisors, in their sole discretion, shall determine the scope, breadth and timing of due diligence information that is provided to each such Acceptable Bidder.

The Debtors and their advisors, in consultation with the Reviewing Parties, shall coordinate all reasonable requests for, and access to, additional due diligence information from such Acceptable Bidders. The Debtors may at any time decline, however, to provide information to any such Acceptable Bidder who, in the Debtors' reasonable business judgment, has not continued to establish that such Acceptable Bidder intends in good faith to, or has the capacity to, consummate the Transaction.

The Debtors have designated the financial advisor to the Debtors listed in section A.2 of these Marketing Process Procedures to coordinate all reasonable requests for additional information and due diligence access. Unless otherwise directed expressly in writing, no Bidder shall directly contact any officer, employee or director of GenOn, its affiliates or any of their respective subsidiaries with respect to due diligence matters.

G. Confidentiality.

Notwithstanding the foregoing and the provisions contained in any applicable Confidentiality Agreement, the Debtors and their advisors and representatives may disclose Bidder Confidential Information: (i) with the prior written consent of such Bidder; (ii) to each other and to the Reviewing Parties and their respective advisors and representatives; and (iii) as otherwise required or allowed by any applicable Confidentiality Agreement or other agreement, law, court or other governmental order, or regulation, including, as appropriate, in consultation with the Reviewing Parties, to regulatory agencies. In conducting the Marketing Process, the Debtors and their advisors and representatives may (a) inform any Acceptable Bidder of the existence or submission of one or more competing Bids and (b) provide Acceptable Bidders and their advisors and representatives with general guidance on improving their Bid in light of the general terms and conditions of competing Bids, either of which may constitute Bidder Confidential Information.

H. Bid Requirements.

Except as otherwise provided below and as otherwise agreed by the Debtors, all Bids must be submitted in writing and satisfy each of the following requirements (the “Bid Requirements”).

1. Consideration and Structure.

- a. **Total Consideration.** The Bid must identify the form and amount of the total consideration to be provided to the Debtors in cash, debt, securities, or similar consideration (the “Bid Value”).
- b. **Sources of Financing.** The Bid, other than an Indicative Bid, must indicate the source of cash consideration and non-cash consideration, including (i) proposed funding commitments with respect to any cash consideration and (ii) any proposals for assuring liquidity and/or value protection in connection with any non-cash consideration, and confirm that such consideration is not subject to any contingencies. The Bid, other than an Indicative Bid, should include a detailed sources and uses schedule.
- c. **Structure.** The Bid must identify the structure proposed for undertaking the Transaction, including the specific Assets and, if applicable, liabilities to be acquired, the proposed steps to accomplish such acquisition and any financial, legal, or tax considerations upon which the Bid’s proposed structure relies.
- d. **Deposit.** Each Bidder must agree, upon entry into definitive documentation regarding the Final Bid, to make a cash deposit in an amount to be

determined, to be held in an interest bearing escrow account to be identified and established by the Debtors (the “Deposit”).

- e. **Authorization.** Each Bid must contain evidence that the Bidder has obtained authorization or approval from its board of directors (or a comparable governing body acceptable to the Debtors), with respect to the submission of its Bid and the consummation of the transactions contemplated in such Bid.
- f. **Tax Structure.** The Bid must specify with particularity its tax structure, including whether it is intended to be structured in a tax-free manner or the extent of any incremental tax liabilities to be incurred by the Debtors under the Bid.
- g. **Debt Incurred at Closing.** The Bid must identify the total amount of debt, if any, proposed to be incurred by any Debtors at closing of the Transaction (the “Closing”).
- h. **Assumption.** The Bid must specify which, if any, of the obligations of the Debtors the Bidder proposes to assume.

2. Other Requirements.

- a. **Demonstrated Financial Capacity.** A Bidder must have, in the Debtors’ business judgment, after consultation with the Reviewing Parties, the necessary financial capacity to consummate the proposed transactions required by its Bid and, if applicable, provide adequate assurance of future performance under all contracts proposed to be assumed by such Bid.
- b. **Time Frame for Closing.** A Bid by a Bidder must be reasonably likely (based on availability of financing, antitrust, or other regulatory issues, experience, and other considerations) to be consummated, if selected as the Successful Bid, within a time frame acceptable to the Debtors.
- c. **Conditions to Closing.** The Bid must identify with particularity each and every condition to Closing.
- d. **Regulatory Approvals and Covenants.** A Bid must set forth each regulatory and third-party approval required for the Bidder to consummate the applicable Transaction, if any, and the time period within which the Bidder expects to receive such regulatory and third-party approvals (and in the case that receipt of any such regulatory or third-party approval is expected to take more than thirty (30) days following execution and delivery of the purchase and sale agreement, those actions the Bidder will take to ensure receipt of such approvals as promptly as possible).

- e. **No Financing, Approval, or Diligence Outs.** The Bid, other than an Indicative Bid, must not be conditioned on obtaining any of the following: (i) financing; (ii) board of directors or other similar approval; or (iii) the outcome or completion of a due diligence review by the Acceptable Bidder.
- f. **Due Diligence Acknowledgement.** The Bid, other than an Indicative Bid, must include a written acknowledgement and representation that the Bidder: (i) has had an opportunity to conduct any and all due diligence regarding the Transaction before making its offer; (ii) has relied solely upon its own independent review, investigation, and/or inspection of any documents and/or the Transaction in making its Bid; and (iii) did not rely upon any written or oral statements, representations, promises, warranties, or guaranties whatsoever, whether express, implied, by operation of law, or otherwise, regarding the Transaction or the completeness of any information provided in connection therewith, except as expressly stated in the Bidder's proposed form of definitive agreement.
- g. **No Collusion.** The Bidder must acknowledge in writing that it has not engaged in any collusion with respect to any Bids or the Transaction and agrees not to engage in any collusion with respect to any Bids or the Transaction.
- h. **Identification Information.** The Bidder must fully disclose the identity of each entity or person that will be bidding for the Transaction or otherwise participating in connection with such Bid, and the complete terms of any such participation, along with sufficient evidence that the Bidder is legally empowered, by power of attorney or otherwise, to complete the transactions on the terms contemplated by the parties.
- i. **Adherence to Marketing Process Procedures.** By submitting its Bid, each Bidder is agreeing to abide by and honor the terms of these Marketing Process Procedures.
- j. **Consent to Jurisdiction.** The Bidder must submit to the jurisdiction of the Bankruptcy Court and waive any right to a jury trial in connection with any disputes relating to Debtors' qualification of Bids, the construction and enforcement of these Marketing Process Procedures, the Transaction documents, and the Closing, as applicable.
- k. **Good Faith Offer.** The Bid must constitute a good faith, bona fide offer to make the Transaction.

I. Bid Criteria.

In evaluating Bids for any purpose under these Marketing Process Procedures, the Debtors may, among other things, in their sole discretion, consider the following criteria (the "Bid Criteria"), each as determined by the Debtors:

1. **Consideration and Value.** The Bid Value, net cash proceeds, implied equity value, implied enterprise value, or any other measure of consideration or value;
2. **Stakeholder Consensus.** The level of support for the Bid among the Debtors' stakeholders, including in particular the Reviewing Parties and any other stakeholders the support of which the Debtors deem critical to the confirmation of one or more value-maximizing plans of reorganization;
3. **Likelihood of Closing.** The likelihood of Closing if the Bid were accepted;
4. **Likelihood of Confirmation.** The likelihood of confirmation of a plan of reorganization by the Debtors if the Bid were accepted, including with respect to feasibility and valuation issues;
5. **Tax Implications.** The tax implications of the Bid, including whether it is intended to be structured in a tax-free manner or the extent of any incremental tax liabilities to be incurred by the Debtors under the Bid, and any related implications for plan confirmation;
6. **Regulatory Approvals.** The likelihood of obtaining any regulatory approvals reasonably required or advisable in connection with the Transaction, including under a plan of reorganization, and the Bidder's willingness to accept conditions imposed by the applicable regulatory authority as a requirement to such approvals;
7. **Conditionality.** The strength and conditionality of the commitment, including the likelihood of closing the Transaction with the Bidder;
8. **Litigation.** The nature and existence of any ongoing litigation between the Bidder and the Debtors; and
9. **Other Factors.** Any other factors that the Debtors, in consultation with the Reviewing Parties, determine are relevant.

J. Reservation of Rights.

The Debtors reserve their rights, following consultation with their advisors and the Reviewing Parties, to modify the Marketing Process Procedures in any manner that they determine will best promote the goals of the bidding process or impose additional customary terms and conditions on the Transaction, including, without limitation, modifying the Bid Requirements, extending the deadlines set forth in the Marketing Process Procedures, and rejecting any or all Bids, in the Debtors' business judgment.

K. Fiduciary Out.

Nothing in these Marketing Process Procedures shall prohibit the board of directors, board of managers, or such similar governing body of a Debtor from taking any action, or to refrain from

taking any action, with respect to these Marketing Process Procedures that is consistent with the fiduciary obligation of the Debtors' board of directors, board of managers, or such similar governing body under applicable law.
