PLEASE TAKE NOTICE that on November 17, 2017, Alexandre R.P. Mechineau, Treasurer and Company Secretary of the above-captioned foreign debtor ("**Artsonig**"), in his capacity as the duly authorized foreign representative of Artsonig (in such capacity, the "**Petitioner**") in respect of a proceeding (the "**Australian Proceeding**") currently pending before the Supreme Court of New South Wales (the "**Australian Court**") for approval of a scheme of arrangement (the "**Artsonig Scheme**") under the Corporations Act 2001 (Commonwealth of Australia), filed a *Verified Petition for Recognition of Foreign Main Proceeding and Related Relief* [Docket No. 2] (the "**Verified Petition**") with the United States Bankruptcy Court for the Southern District of New York (the "**Bankruptcy Court**"), commencing a case under chapter 15 of the Bankruptcy Code.
