- I, David R. Seligman, being duly sworn, state the following under penalty of perjury:
- 1. I am the president of David R. Seligman, P.C., a partner of the law firm of Kirkland & Ellis LLP, located at 300 North LaSalle, Chicago, Illinois 60654, and a partner of Kirkland & Ellis International, LLP (together with Kirkland & Ellis LLP, collectively, "Kirkland"). I am the lead attorney from Kirkland working on the above-captioned chapter 11 cases. I am a member in good standing of the Bars of the State of Illinois and the State of New York. I am an inactive member of the Bar of the State of Florida. I have been admitted to practice *pro hac vice* in the United States Bankruptcy Court for the Southern District of Texas. There are no disciplinary proceedings pending against me.
- 2. On June 14, 2017 (the "Petition Date"), each of the above-captioned debtors and debtors in possession (collectively, the "Debtors") filed a petition with this Court under chapter 11 of title 11 of the United States Code (the "Bankruptcy Code"). On June 23, 2017, the Debtors filed an application to employ and retain Kirkland as counsel for the Debtors [Docket No. 121] (the "Application") pursuant to sections 327(a) and 330 of the Bankruptcy Code, rules 2014(a) and 2016 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), and rules 2014-1 and 2016-1 of the Bankruptcy Local Rules for the Southern District of Texas (the "Bankruptcy Local Rules").
- 3. My declaration in support of the Application (the "Original Declaration") was attached to the Application as Exhibit B. On July 13, 2017, the Court entered the *Order Authorizing the Retention and Employment of Kirkland & Ellis LLP and Kirkland & Ellis International LLP as Attorneys for the Debtors and Debtors in Possession Effective* Nunc Pro Tunc *to the Petition Date* [Docket No. 197] (the "Original Order"), and on July 13, 2017, the Court entered the *Amended Order Authorizing the Retention and Employment of Kirkland & Ellis LLP*

and Kirkland & Ellis International LLP as Attorneys for the Debtors and Debtors in Possession Effective Nunc Pro Tunc to the Petition Date [Docket No. 234] (together with the Original Order, the "Retention Order"). On July 13, 2017, I filed the First Supplemental Declaration of David R. Seligman in Support of the Debtors' Application for Entry of an Order Authorizing the Retention and Employment of Kirkland & Ellis LLP and Kirkland & Ellis International LLP as Attorneys for the Debtors and Debtors in Possession Effective Nunc Pro Tunc to the Petition Date [Docket No. 239] (the "First Supplemental Declaration"). On September 1, 2017, I filed the Second Supplemental Declaration of David R. Seligman in Support of Application of the Debtors' for Entry of an Order Authorizing the Employment and Retention of Kirkland & Ellis LLP as Attorneys for the Debtors and Debtors in Possession Effective Nunc Pro Tunc to the Petition Date [Docket No. 696] (the "Second Supplemental Declaration"). On September 15, 2017, I filed the Third Supplemental Declaration of David R. Seligman in Support of the Debtors' Application for Entry of an Order Authorizing the Retention and Employment of Kirkland & Ellis LLP and Kirkland & Ellis International LLP as Attorneys for the Debtors and Debtors in Possession **Effective** Nunc Tunc Petition [Docket No. Pro the Date 772] to (the "Third Supplemental Declaration") (together with the Original Declaration, the First Supplemental Declaration, Supplemental Declaration, and the Second the "Previous Declarations").

4. In connection with the Application and the Retention Order, I submit this fourth supplemental declaration (this "Fourth Supplemental Declaration") to provide additional disclosures in accordance with rules 2014(a) and 2016(b) of the Bankruptcy Rules and as required under the Retention Order. Unless otherwise stated in this Fourth Supplemental Declaration, all facts set forth herein are based upon my personal knowledge of Kirkland's practices and

Kirkland's representation of the Debtors and information learned from my review of relevant documents and/or information supplied to me by other persons, including partners or employees of K&E. No one individual at Kirkland has personal knowledge of all of the facts set forth in this Fourth Supplemental Declaration.

Additional Disclosures

- 5. As set forth in the Previous Declarations and herein, Kirkland may in the past have represented, currently may represent, and may in the future represent certain of the Debtors' creditors, equity security holders, or other parties in interest in ongoing matters unrelated to the Debtors and these chapter 11 cases. None of the representations described herein or set forth on **Schedule 2** and **Schedule 3** are materially adverse to the interests of the Debtors' estates. Moreover, pursuant to section 327(c) of the Bankruptcy Code, Kirkland is not disqualified from acting as the Debtors' counsel merely because it represents certain of the Debtors' creditors, equity security holders, or other parties in interest in matters unrelated to these chapter 11 cases.
- 6. Kirkland has searched its electronic database of representations for connections to parties in interest in these chapter 11 cases. Certain connections were disclosed in the Previous Declarations. Since the Petition Date, Kirkland has updated those conflicts searches and has searched additional parties as Kirkland has become aware of additional parties in interest in these chapter 11 cases. In addition to the entities searched and disclosed in the Previous Declarations, Kirkland has searched its electronic database for the entities listed on **Schedule 1**, attached hereto. Kirkland will update its disclosures as necessary and when Kirkland becomes

aware of material information. The following is a list of the additional categories that Kirkland has searched:²

Although not relevant in concluding that Kirkland is "disinterested," out of an abundance of caution, I have included the results of Kirkland's conflicts searches of the above-listed entities on <u>Schedule 2</u>, attached hereto, and any new results of Kirkland's conflicts searches of the entities searched in connection with the Previous Declarations on <u>Schedule 3</u>, attached hereto (such entities on <u>Schedule 2</u> and <u>Schedule 3</u>, the "New <u>Results Parties</u>").³ Kirkland also identified certain (a) current confidential clients, (b) confidential bidders in the Debtors' ongoing marketing and sales process, or (c) confidential outsourcing vendors involved in the Debtors' separation from their ultimate non-Debtor parent, NRG Energy, Inc., that may be New Results Parties, the names of which such confidential clients and confidential parties are not set forth on <u>Schedules1-3</u> attached hereto. All current and prior representations of the parties

² Kirkland's inclusion of parties in the following schedules is solely to illustrate Kirkland's conflict search process and is not an admission that any party has a valid claim against the Debtors or that any party properly belongs in the schedules or has a claim or legal relationship to the Debtors of the nature described in the schedules.

As referenced in <u>Schedule 2</u> and <u>Schedule 3</u>, the term "current client" means an entity listed as a client in Kirkland's conflicts search system to whom time was posted in the 12 months preceding June 14, 2017. The term "former client" means an entity listed as a client in Kirkland's conflicts search system to whom time was posted between 12 and 36 months preceding June 14, 2017. The term "closed client" means an entity listed as a client in Kirkland's conflicts search system to whom time was posted in the 36 months preceding June 14, 2017, but for which the client representation has been closed. Whether an actual conflict relationship exists can only be determined by reference to the documents governing Kirkland's representation rather than its potential listing in Kirkland's conflicts search system. The list generated from Kirkland's conflicts search system is over-inclusive. As a general matter, Kirkland discloses connections with "former clients" or "closed clients" for whom time was posted in the last 36 months, but does not disclose connections if time was billed more than 36 months before June 14, 2017.

identified on <u>Schedule 2</u> and <u>Schedule 3</u>, including those related to the confidential parties, and the confidential clients are in matters unrelated to the Debtors and these chapter 11 cases.

A. Connections to Certain Specified Entities.

- 8. As set forth in Schedule 2, affiliates of certain parties that objected to the Debtors' Second Amended Joint Chapter 11 Plan of Reorganization of GenOn Energy, Inc. and Its Debtor Affiliates [Docket No. 832] are current clients of Kirkland. I do not believe that Kirkland's prior representations of the affiliates, subsidiaries, and entities associated with these entities preclude Kirkland from being a disinterested party under the Bankruptcy Code but have disclosed the connections out of an abundance of caution.
- 9. Based on the conflicts searches conducted to date and described in this Fourth Supplemental Declaration and the Previous Declarations, to the best of my knowledge and insofar as I have been able to ascertain, neither Kirkland nor any of its partners or associates has any connection with the Debtors or any party in interest in the chapter 11 cases except as disclosed or otherwise described in this Fourth Supplemental Declaration and in the Previous Declarations.
- 11. Generally, it is Kirkland's policy to disclose entities in the capacity that they first appear in a conflicts search. For example, if an entity already has been disclosed in the Original Declaration in one capacity (e.g., a customer), and the entity appears in a subsequent conflicts search in a different capacity (e.g., a vendor), Kirkland does not disclose the same entity again in supplemental declarations, unless the circumstances are such in the latter capacity that additional disclosure is required.

Affirmative Statement of Disinterestedness

12. Based on the conflicts search conducted to date and described herein, to the best of my knowledge and insofar as I have been able to ascertain, (a) Kirkland is a "disinterested person" within the meaning of section 101(14) of the Bankruptcy Code, as required by section 327(a) of

the Bankruptcy Code, and does not hold or represent an interest adverse to the Debtors' estates, and (b) Kirkland has no connection to the Debtors, their creditors, or other parties in interest, except as may be disclosed herein.

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct to the best of my knowledge, information, and belief.
