In accordance with the General Order M-447 Amended Guidelines for Fees and Disbursements for Professionals in Southern District of New York Bankruptcy Cases, dated January 29, 2013, and the *Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses for Retained Professionals* (the “**Interim Compensation Order**”) [Docket No. 161], Moelis & Company LLC (“**Moelis**”), in its capacity as investment banker and financial advisor to the debtors and debtors in possession in the above-captioned cases (collectively, the “**Debtors**”), hereby submits this second monthly fee statement (this “**Statement**”) for the period February 1, 2019 through April 3, 2019 (the “**Statement Period**”). In support of this Statement, Moelis respectfully represents as follows:

4. Pursuant to the Interim Compensation Order, the amount payable to Moelis for this Statement Period with respect to the amounts sought herein, after adjusting for the twenty percent (20%) holdback for fees, is \$266,329.99.³

³ The amount payable of \$266,329.99 is calculated by multiplying \$300,000.00 (the amount requested for services to the Debtors) by eighty percent (80%) and then adding \$26,329.99 (the amount requested for expenses) (i.e., $(\$300,000.00 \times 0.8) + \$26,329.99 = \$266,329.99$).
