STIPULATION AND SCHEDULING ORDER

IT IS HEREBY STIPULATED AND AGREED, by and between the undersigned counsel for MF Global Holdings Ltd., as Plan Administrator, on behalf of itself and its affiliates (“MF Global”) and William K. Harrington, United States Trustee for Region 2 (the “US Trustee”; collectively with MF Global, the “Parties”), in accordance with the *Order Permitting Filing of Summary Judgment Motion* (Docket No. 2398) entered by this Court on October 8, 2019, as follows:

1. Without conceding that it is necessary to commence an Adversary Proceeding to have this Court determine whether the amendment to 28 U.S.C. § 1930(a)(6) in October 2017 (the “Amendment”) increasing the quarterly fees payable in certain chapter 11 cases applies to MF Global, MF Global agrees to commence an Adversary Proceeding by filing a complaint seeking declaratory and other relief against the US Trustee on or before Tuesday, October 22, 2019 at 5:00 p.m. (the “Complaint”).

¹ The debtors in the chapter 11 cases were MF Global Holdings Ltd.; MF Global Finance USA Inc.; MF Global Capital LLC; MF Global Market Services LLC; MF Global FX Clear LLC; and MF Global Holdings USA Inc. The Court entered an order of final decree closing the chapter 11 cases of MF Global Capital LLC, MF Global FX Clear LLC, and MF Global Market Services LLC on February 11, 2016.

2. The Parties agree to each file a motion for summary judgment (“Opening Motions”) as to any or all claims asserted in the Complaint on or before Thursday, November 21, 2019 at 5:00 p.m.
3. The Parties agree to file any opposition or objection (the “Oppositions”) to the Opening Motions on or before Tuesday, December 17, 2019 at 5:00 p.m.
4. The Parties agree to confer with the Court’s Deputy Clerk to arrange a date for a hearing to be held on or after Monday, January 6, 2020 and on or before Friday, January 10, 2020, subject to the Court’s availability.
5. Within 14 days after the Court rules on the Opening Motions, the US Trustee shall file an answer, if necessary, responding to any counts in the Complaint not resolved by the Court’s ruling. The Parties agree to request that any initial pre-trial conference scheduled with the issuance of the Summons be taken off calendar (and adjourned until after the US Trustee has answered the Complaint, if applicable).
6. Memoranda of law in support of the Opening Motions are limited to 40 pages. Memoranda of law in support of the Oppositions are limited to 30 pages. No reply memoranda shall be submitted absent an order from the Court directing otherwise. Except as provided herein, all briefs are to conform with the Court’s rules, including the requirement that memoranda of 10 pages or more contain a table of contents and a table of authorities.
7. The schedule agreed to in this Stipulation may not be modified or the dates herein extended, except by further Order of this Court. Absent agreement, any application to modify or extend any deadline established herein shall require

good cause shown and shall be made in a written application prior to the
expiration of the date sought to be extended.
