## STIPULATION FURTHER EXTENDING THE TIME TO ASSUME OR REJECT UNEXPIRED LEASES OF NONRESIDENTIAL REAL PROPERTY PURSUANT TO § 365(d)(4) OF THE BANKRUPTCY CODE

WHEREAS, on March 6, 2020, the above-captioned debtors and debtors in possession ("<u>Debtors</u>") each filed a voluntary petition for relief under chapter 11 of title 11 of the United States Code, 11 U.S.C. §§ 101-1532 (the "<u>Bankruptcy Code</u>"), in the United States Bankruptcy Court for the Middle District of North Carolina (the "<u>Bankruptcy Court</u>");

WHEREAS, Debtors and all of their third-party lessors, listed on the attached **Schedule B** (collectively, the "Lessors") are parties to certain leases of nonresidential real properties further described on **Schedule A**;

WHEREAS, on July 6, 2020, the Court entered an order [Docket No. 354] extending the Debtors' time to assume or reject any of the leases, subleases or other agreements to which any of the Debtors are a party that may be considered unexpired leases of nonresidential real property (the "365(d)(4) Period"), pursuant to § 365(d)(4) of the Bankruptcy Code, through

and including October 5, 2020, without prejudice to further extensions of the § 365(d)(4) Period with the prior written consent of Lessors;

WHEREAS, the Debtors and the Lessors have agreed to further extend the Debtors' time to elect to assume or reject all of Debtors' unexpired nonresidential real property leases, pursuant to § 365(d)(4) of the Bankruptcy Code, through and including December 4, 2020.

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, by and between the Debtors and the Lessors, as follows:

 The Debtors' time to elect to assume or reject the Leases listed on Schedule B are hereby extended, pursuant to § 365(d)(4) of the Bankruptcy Code, through and including December 5, 2020.
