1. I am the president of Joshua A. Sussberg, P.C., a partner of the law firm of Kirkland & Ellis LLP, located at 601 Lexington Avenue, New York, New York, 10022, and partner of Kirkland & Ellis International, LLP (together with Kirkland & Ellis LLP, collectively, "<u>Kirkland</u>"). I am the lead attorney from Kirkland working on the above-captioned chapter 11 cases. I am a member in good standing of the Bar of the State of New York. I have been admitted to practice *pro hac vice* in the United States Bankruptcy Court for the Eastern District of Virginia. There are no disciplinary proceedings pending against me.

2. On February 17, 2020 (the "<u>Petition Date</u>"), each of the above-captioned debtors and debtors in possession (collectively, the "<u>Debtors</u>") filed a petition with the United States Bankruptcy Court for the Eastern District of Virginia (the "<u>Court</u>") under chapter 11 of title 11 of the United States Code (the "<u>Bankruptcy Code</u>"). On February 29, 2020, the Debtors filed an application to employ and retain Kirkland as counsel for the Debtors [Docket No. 192] (the "<u>Application</u>") pursuant to sections 327(a) and 330 of the Bankruptcy Code, rules 2014(a) and 2016 of the Federal Rules of Bankruptcy Procedure (the "<u>Bankruptcy Rules</u>"), and rules 2014-1 and 2016-1 of the Local Bankruptcy Rules for the Eastern District of Virginia (the "<u>Bankruptcy Rules</u>").

3. Attached to the Application as <u>Exhibit B</u> was my declaration in support of the Application (the "<u>Original Declaration</u>")² attesting to the disinterestedness of Kirkland, among other things. On March 18, 2020, the Court entered the *Order Authorizing the Retention and Employment of Kirkland & Ellis LLP and Kirkland & Ellis International LLP as Attorneys for the Debtors and Debtors in Possession Effective* Nunc Pro Tunc *to the Petition Date* [Docket No. 386] (the "Retention Order").

4. In connection with the Application and Original Declaration, I submit this supplemental declaration (this "<u>Supplemental Declaration</u>") to provide additional disclosures in accordance with Bankruptcy Rules 2014(a) and 2016(b) and as required under the Retention Order. Unless otherwise stated in this Supplemental Declaration, I have personal knowledge of the facts set forthherein.

Additional Disclosures

5. As set forth in the Original Declaration and herein, Kirkland may in the past have represented, currently may represent, and may in the future represent certain of the Debtors' creditors, equity security holders, or other parties in interest in ongoing matters unrelated to the Debtors and these chapter 11 cases. None of the representations set forth on <u>Schedule 1</u> are materially adverse to the interests of the Debtors' estates. Moreover, pursuant to section 327(c) of the Bankruptcy Code, Kirkland is not disqualified from acting as the Debtors' counsel merely because it represents certain of the Debtors' creditors, equity security holders, or other parties in interest in matters unrelated to these chapter 11 cases.

Specific Disclosures

6. Pamela Corrie and Steven G. Panagos, disinterested directors of Pier 1 Imports, Inc., have served, or may serve from time to time, in various management and director capacities of certain Kirkland clients or affiliates thereof. I do not believe Kirkland's current and prior representations of clients for which Ms. Corrie and Mr. Panagos serve(d) in management and director capacities precludes Kirkland from meeting the disinterestedness standard under the Bankruptcy Code.

Affirmative Statement of Disinterestedness

7. This declaration makes certain additional disclosures. Based on the conflicts searches conducted to date, to the best of my knowledge, neither I, Kirkland, nor any partner, of

10. Except as specifically discussed herein, the client representations identified in this declaration and the attached schedules are not related to the Debtors or these chapter 11 cases. The client representations identified in this declaration and the attached schedules are not materially adverse to the interests of the Debtors' estates. Moreover, pursuant to section 327(c) of the Bankruptcy Code, Kirkland is not disqualified from acting as the Debtors' counsel merely because it represents or represented the Debtors' creditors, equity security holders, or other parties in interest in matters unrelated to these chapter 11 cases.

11. Kirkland will not commence a cause of action in these chapter 11 cases against the entities listed on <u>Schedule 2</u> (including entities in identified in the "<u>Specific Disclosures</u>" section of this Supplemental Declaration) to this declaration that are current clients of Kirkland unless Kirkland has an applicable waiver on file or first receives a waiver from such party allowing Kirkland to commence such an action. To the extent that a waiver does not exist or is not obtained from such client and it is necessary for the Debtors to commence an action against that client, the Debtors will be represented in such particular matter by conflicts counsel or the Debtors' co-counsel, Kutak Rock LLP ("<u>Kutak</u>"). In certain circumstances, Kirkland may ask conflicts counsel or Kutak to handle a matter even where Kirkland believes it can represent the Debtors adversely to such entity.

Continued Vigilance and Affirmative Statement of Disinterestedness

12. Based on the conflicts searches conducted to date and described in the Original Declaration and herein, to the best of my knowledge and insofar as I have been able to ascertain,(a) Kirkland is a "disinterested person" within the meaning of section 101(14) of the Bankruptcy

Date, but for which the client representation has been closed. Whether an actual client relationship exists can only be determined by reference to the documents governing Kirkland's representation rather than its potential listing in Kirkland's conflicts search system. The list generated from Kirkland's conflicts search system is over-inclusive. As a general matter, Kirkland discloses connections with "former clients" or "closed clients" for whom time was posted in the last 36 months, but does not disclose connections if time was billed more than 36 months before the Petition Date.
