**SUPPLEMENTAL DECLARATION OF HELEN MASON OF RIVERON CONSULTING  
LLC PURSUANT TO THE ORDER AUTHORIZING THE RETENTION AND  
COMPENSATION OF CERTAIN PROFESSIONALS UTILIZED IN THE ORDINARY  
COURSE OF BUSINESS**

I, Helen Mason, under penalty of perjury, declare as follows:

1. I am a Managing Director at Riveron Consulting, LLC. I make and submit this supplemental declaration (this “Supplemental Declaration”) on behalf of Riveron to supplement the disclosures contained in the *Declaration of Disinterestedness of Riveron Consulting, LLC Pursuant to the Order Authorizing the Retention and Compensation of Certain Professionals Utilized in the Ordinary Course of Business* (the “Original Declaration”) [Docket No. 1875].<sup>2</sup>

2. I am duly authorized to make and submit this Supplemental Declaration on behalf of Riveron in accordance with section 327(a) of the Bankruptcy Code and Bankruptcy Rule 2014(a).

3. Unless otherwise stated in this Supplemental Declaration, I have personal knowledge, upon information and belief, and upon records kept in the ordinary course of business

that were reviewed by me or other employees of Riveron under my supervision and direction, of the facts set forth herein.

4. On October 30, 2020, Winter Harbor LLC (“Winter Harbor”) was purchased by a subsidiary of Riveron Parent Holdings, LP (“Holdco”, and collectively with its subsidiaries other than the Conway Entities and Winter Harbor LLC, “Riveron”). Holdco is controlled by an investment vehicle that is majority owned by H.I.G. Capital Partners V, L.P. (“LBO Fund V”) and H.I.G. Growth Buyouts & Equity Fund III, L.P. (“Growth Fund III”), investment funds managed by H.I.G. Capital, LLC (together with its affiliates other than Riveron, the Conway Entities<sup>3</sup>, and Winter Harbor, “H.I.G.”). Riveron Consulting, LLC, the Conway Entities, and Winter Harbor are business advisory firms. As a result of the transaction, the Conway Entities, Riveron, Winter Harbor, and H.I.G. are affiliates under applicable law. The following disclosure is made out of an abundance of caution in an effort to comply with the Bankruptcy Code and Bankruptcy Rules.

5. In connection with the combination of the Conway Entities, Winter Harbor, and Riveron and in addition to the procedures set forth in the Original Declaration, Winter Harbor conducted its standard review process of Winter Harbor’s contacts with the Debtors and the Potential Parties-in-Interest that were made known to Riveron by the Debtors. This process entailed the partners of Winter Harbor reviewing the list of Potential Parties-in-Interest for connections to such Potential Parties-in-Interest and an email being sent to all Winter Harbor professionals instructing them to review the Potential Parties-in-Interest list for connections.

6. In addition, Riveron conducted a review of the Potential Parties-in-Interest against a list of Winter Harbor’s clients, referral sources, and vendors. A listing of the Potential Parties-

in-Interest reviewed is reflected on **Schedule A** attached to this Supplemental Declaration. Based on the results of this review, as communicated to me by Winter Harbor and Riveron personnel, Riveron does not have a relationship with the Debtors or any of the Potential Parties-in-Interest as a result of Riveron's acquisition of Winter Harbor, except as disclosed on **Schedule B** hereto.

7. Designees of LBO Fund V and Growth Fund III are members of the Board of Managers of the general partner of Holdco ("Holdco Board Designees"). Holdco wholly owns Riveron Intermediate Holdings, Inc. ("Intermediate Co"), which wholly owns Riveron Acquisition Holdings, Inc. ("Acquisition Co"), which wholly owns Riveron Consulting, LLC, the Conway Entities, and Winter Harbor. No H.I.G. designees are Board members of Riveron Consulting, LLC, Conway MacKenzie, Intermediate Co, Acquisition Co, or Winter Harbor.

8. Further, the Conway Entities, Riveron, Winter Harbor, LBO Fund V, and Growth Fund III have the following precautionary restrictions in place designed to prevent confidential client information, including the names of clients reasonably likely to be involved in reorganization proceedings under the Bankruptcy Code, from being shared with H.I.G. or their Holdco Board Designees (collectively, the "Barrier"): (a) Riveron will not furnish any material nonpublic information about the Debtors or the Committee to LBO Fund V and Growth Fund III, the Holdco Board Designees, or any H.I.G. entity or personnel; (b) no LBO Fund V and Growth Fund III personnel nor any other H.I.G. personnel work on Conway Entities client matters or have access to Conway Entities client information, client files, or client personnel; (c) Conway Entities and Winter Harbor personnel who are not staffed on this engagement do not have access to the Committee's client information or client files; (d) all H.I.G. personnel, Riveron personnel, Winter Harbor personnel, and Conway Entities personnel have been or will be provided a written description of this Barrier and the importance thereof; (e) no LBO Fund V and Growth Fund III

personnel nor any other H.I.G. personnel work in the Conway Entities' offices, Riveron's offices, or Winter Harbor's offices; (f) other than the Holdco Board Designees, the Conway Entities, Riveron, and Winter Harbor operate independently from H.I.G., including that they do not share any employees, officers, or other management with H.I.G., have separate offices in separate buildings, have separate email addresses, and have separate IT systems; and (g) no Conway Entities, Riveron, or Winter Harbor executive or employee is a director, officer, or employee of H.I.G. Capital, LLC or the Funds (or vice versa other than the Holdco Board Designees).

9. Based on the process set forth in the Original Declaration, and this Supplemental Declaration, it is my understanding that the overall design and implementation of Riveron's current procedures provide a reasonable level of comfort that relationships and potential conflicts will be identified. Notwithstanding the foregoing, given the large number of Potential Parties-in-Interest and Fund investments, despite the efforts described in the Original Declaration, and in this Supplemental Declaration to identify and disclose Riveron's relationships with Potential Parties-in-Interest in these Chapter 11 Cases, there may be client relationships or other connections that have not been disclosed. In particular, among other things, the Conway Entities, Riveron, Winter Harbor, or H.I.G. may have relationships with persons who are beneficial owners of Potential Parties-in-Interest and persons whose beneficial owners include Potential Parties-in-Interest or persons who otherwise have relationships with Potential Parties-in-Interest. Moreover, the Conway Entities, Riveron, Winter Harbor, or H.I.G. employees may have relationships with Potential Parties-in-Interest, persons that may become Potential Parties-in-Interest in these cases, and/or persons that have business relationships with the Debtors, are competitors of the Debtors, or that are customers of the Debtors. Continued inquiry will be made following the filing of this Supplemental Declaration by undertaking the same procedures described herein, and in the

Original Declaration, on a periodic basis, except where otherwise specified, with additional disclosures to be filed in this Court if necessary or otherwise appropriate.

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct, to the best of my information, knowledge, and belief.
