SUPPLEMENTAL DECLARATION OF STEVEN N. SERAJEDDINI IN SUPPORT OF THE DEBTORS' APPLICATION FOR ENTRY OF AN ORDER AUTHORIZING THE RETENTION AND EMPLOYMENT OF KIRKLAND & ELLIS LLP AND KIRKLAND & ELLIS INTERNATIONAL LLP AS ATTORNEYS FOR THE DEBTORS AND DEBTORS IN POSSESSION EFFECTIVE AS OF NOVEMBER 13, 2020

I, Steven N. Serajeddini, being duly sworn, state the following under penalty of perjury:

1. I am the president of Steven N. Serajeddini, P.C., a partner of the law firm of Kirkland & Ellis LLP, located at 601 Lexington Avenue, New York, New York 10022, and a partner of Kirkland & Ellis International LLP (together with Kirkland & Ellis LLP, collectively, "<u>Kirkland</u>"). I am one of the lead attorneys from Kirkland working on the above-captioned chapter 11 cases. I am a member in good standing of the Bar of the State of New York and the Bar of the State of Illinois, and I have been admitted to practice in the Northern District of Illinois. There are no disciplinary proceedings pending against me.

2. I submit this supplemental declaration on behalf of Kirkland (the "<u>Supplemental</u> <u>Declaration</u>") in further support of the *Debtors' Application for Entry of an Order Authorizing the Retention and Employment of Kirkland & Ellis LLP and Kirkland & Ellis International LLP as Attorneys for the Debtors and Debtors in Possession Effective as of November 13, 2020* [Docket No. 460] (the "<u>Application</u>")² of the above-captioned debtors and debtors in possession (collectively, the "<u>Debtors</u>") and to supplement the disclosures set forth in the *Declaration of Steven N. Serajeddini in Support of the Debtors' Application for Entry of an Order Authorizing the Retention and Employment of Kirkland & Ellis LLP and Kirkland & Ellis International LLP as Attorneys for the Debtors and Debtors in Possession Effective as of November 13, 2020* (the "<u>Original Declaration</u>") in accordance with Bankruptcy Rules 2014(a) and 2016(b) and as required under the *Order Authorizing the Retention and Employment of Kirkland & Ellis LLP and Kirkland & Ellis International LLP as Attorneys for the Debtors and Debtors in Possession Effective as of November 13, 2020* [Docket No. 607] (the "<u>Retention Order</u>"). Unless otherwise stated in this Supplemental Declaration, I have personal knowledge of the facts set forth herein.

3. As I stated in the Original Declaration, Kirkland has searched its electronic database of representations for connections to parties in interest in these chapter 11 cases. Certain connections were disclosed in the Application. Since the Petition Date, Kirkland has updated those conflicts searches and has searched additional parties as Kirkland has become aware of additional parties in interest in these chapter 11 cases. In addition to the entities searched and disclosed in the Application, Kirkland has searched its electronic database for the entities listed on

4. I have included the results of Kirkland's conflicts searches of the above-listed entities

on <u>Schedule 2</u> to this supplemental declaration.⁴ In addition, Kirkland re-ran searches in its electronic database for the entities that were previously reviewed in the Application and the Original Declaration. Those entities that were re-run are listed on <u>Schedule 3</u>. All current and prior representations of the parties identified on <u>Schedules 2</u> and <u>3</u> are in matters unrelated to the Debtors and these chapter 11 cases.

5. This supplemental declaration is submitted pursuant to section 1746 of title 28 of the United States Code. All facts set forth herein are based upon my personal knowledge of Kirkland's practices and Kirkland's representation of the Debtors and information learned from my review of relevant documents and information supplied to me by other parties, including partners or employees of Kirkland. No one individual at Kirkland has personal knowledge of all of the facts set forth in this supplemental declaration.

Additional Disclosures

6. This supplemental declaration makes certain additional disclosures. Based on the conflicts searches conducted to date, to the best of my knowledge, neither I, Kirkland, nor any partner, of counsel, or associate thereof, insofar as I have been able to ascertain, has any connections with the Debtors, their creditors, or any other entities who may be parties in interest, their respective attorneys or accountants, the U.S. Trustee, any person employed by the U.S. Trustee, or any person employed by the Bankruptcy Court for the Southern District of Texas, the United States District Court for the Southern District of Texas, or the United States Court of Appeals for the Fifth Circuit, except as disclosed or otherwise described herein and in the Original Declaration.

7. As disclosed on <u>Schedules 2</u> and <u>3</u>, certain parties in interest in these chapter 11 cases are current or former Kirkland clients. Kirkland has not represented, nor will Kirkland represent, any of these parties or any of their affiliates in any matter related to these chapter 11 cases. I do not believe these representations preclude Kirkland from being disinterested under the Bankruptcy Code.

8. Generally, it is Kirkland's policy to disclose entities in the capacity that they first appear in a conflicts search. For example, if an entity already has been disclosed in the Original Declaration in one capacity (*e.g.*, a customer), and the entity appears in a subsequent

conflicts search in a different capacity (*e.g.*, a vendor), Kirkland does not disclose the same entity again in supplemental declarations, unless the circumstances are such in the latter capacity that additional disclosure is required.

9. Stefan M. Selig, manager and director of certain of the Debtors, has served, or may serve from time to time, in various management and/or director capacities of certain Kirkland clients or affiliates thereof. I do not believe that Kirkland's current or prior representation of any client for which Mr. Selig serves or served in management and/or director capacities precludes Kirkland from meeting the disinterestedness standard under the Bankruptcy Code.

10. On April 13, 2021, Daniel N. Elizondo joined Kirkland as a corporate partner in Kirkland's Los Angeles, California office. While at his previous law firm, Mr. Elizondo represented parties adverse to the Debtors in transactional matters unrelated to the Debtors' chapter 11 cases. Kirkland has instituted formal screening measures to screen Mr. Elizondo from all aspects of Kirkland's representation of the Debtors. I do not believe that Mr. Elizondo's prior connection to the Debtors creates a conflict of interest, but I have disclosed this connection out of an abundance of caution.

11. On January 1, 2021, Michael J. Conroy joined Kirkland as a tax associate in Kirkland's Chicago, Illinois office. While at his previous law firm, Mr. Conroy represented a party adverse to the Debtors in a transactional matter unrelated to the Debtors' chapter 11 cases. Kirkland has instituted formal screening measures to screen Mr. Conroy from all aspects of Kirkland's representation of the Debtors. I do not believe that Mr. Conroy's prior connection to the Debtors creates a conflict of interest, but I have disclosed this connection out of an abundance of caution.

12. As disclosed on <u>Schedule 2</u>, Kirkland currently represents, and formerly has represented, Exelon Corporation, Murray Energy Corporation, and certain of their subsidiaries, affiliates, and/or employees (collectively, the "<u>Supplemental Royalty Dispute Parties</u>") in a variety of matters. Kirkland's current and former representations of the Supplemental Royalty Dispute Parties have been in matters unrelated to the Debtors or these chapter 11 cases. I do not believe that Kirkland's current or former representation of the Supplemental Royalty Dispute Parties precludes Kirkland from meeting the disinterestedness standard under the Bankruptcy Code.

13. The Committee's financial advisor is Conway MacKenzie, LLC ("<u>Conway</u>"). As disclosed on <u>Schedule 2</u>, Kirkland currently represents, and in the past has represented, certain affiliates of Conway, including H.I.G. Capital Management, Inc., and their affiliates, subsidiaries, and/or related entities (collectively, "<u>HIG</u>") in a variety of matters. Kirkland's current and former representations of HIG have been in matters unrelated to the Debtors and these chapter 11 cases. I do not believe that Kirkland's current or former representation of HIG precludes Kirkland from meeting the disinterestedness standard under the Bankruptcy Code.

14. The Committee's investment banker in these chapter 11 cases is Jefferies LLC ("Jefferies"). As disclosed on <u>Schedule 2</u> attached hereto, Kirkland currently represents, and in the past has represented, Jefferies Hong Kong Limited ("Jefferies HK"), Jefferies Finance LLC ("Jefferies Finance"), and affiliated entities on a variety of matters. All current and prior Kirkland representations of Jefferies HK and Jefferies Finance have been in matters unrelated to the Debtors and these chapter 11 cases. Kirkland has not represented, and will not represent, Jefferies HK nor Jefferies Finance in connection with the Debtors and any matter in these chapter 11 cases. I do not believe that Kirkland's current or prior representations of Jefferies HK and Jefferies Finance preclude Kirkland from meeting the disinterestedness standard under the Bankruptcy Code.

Affirmative Statement of Disinterestedness

15. Based on the conflicts searches conducted to date and described in the Original Declaration and herein, to the best of my knowledge and insofar as I have been able to ascertain, (a) Kirkland is a "disinterested person" within the meaning of section 101(14) of the Bankruptcy Code, as required by section 327(a) of the Bankruptcy Code, and does not hold or represent an interest adverse to the Debtors' estates and (b) Kirkland has no connection to the Debtors, their creditors, or other parties in interest, except as may be disclosed in the Original Declaration and herein.

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct to the best of my knowledge, information, and belief.
