**ORDER GRANTING APPLICATIONS FOR ALLOWANCE  
OF INTERIM COMPENSATION AND REIMBURSEMENT OF EXPENSES**

Upon consideration of (i) the *Twelfth Interim Application of RSR Consulting, LLC, Restructuring Consultant to the Debtors and Debtors-In-Possession, for Compensation for Services Rendered from July 1, 2020 Through October 31, 2020* [ECF No. 2473] (the “**RSR Application**”) filed by RSR Consulting, LLC (“**RSR**”) for professional services rendered and incurred commencing July 1, 2020 through October 31, 2020; (ii) the *First Interim Fee Application of Kroll, LLC f/k/a Duff & Phelps, LLC for Allowance of An Administrative Claim for Compensation and Reimbursement of Expenses Incurred From June 18, 2020 through October 31, 2020* [ECF No. 2474] (the “**Kroll Application**”) filed by Kroll, LLC (“**Kroll**”) for professional services rendered and incurred commencing June 18, 2020 through October 31, 2020, and (iii) the

*Ninth Application of Klestadt Winters Jureller Southard & Stevens, LLP, as Attorneys for Certain Debtors, for Interim Allowance of Compensation for Professional Services Rendered and Reimbursement of Actual and Necessary Expenses Incurred from July 1, 2020 Through and Including October 31, 2020* [ECF No. 2475; refiled at ECF No. 2587] (the “**Klestadt Application**”), filed by Klestadt Winters Jureller Southard & Stevens, LLP (“**Klestadt**”) for professional services rendered and expenses incurred commencing July 1, 2020 through October 31, 2020; and notice having been given pursuant to Federal Rules of Bankruptcy Procedure 2002(a)(6) and (c)(2); and no objections having been filed with respect to the Applications; and a hearing to consider the Applications having been held before the Court on July 20, 2021 (the “**Hearing**”); and due consideration having been given to any responses to the Applications; and it appearing that the amounts set forth on **Schedule A** correctly state the Court’s rulings made on the record at the Hearing; and after due deliberation and sufficient cause appearing therefor,

**IT IS HEREBY ORDERED THAT:**

1. The Applications are granted on an interim basis to the extent set forth in the attached **Schedule A**.
2. The Applicants are authorized to apply the balance of the fees and expenses approved under this Order against the funds each Applicant holds on retainer or seek payment from the Debtors for such fees and expenses pursuant to the *Order Establishing Procedures for Monthly Compensation and Reimbursement of Expenses of Professionals* [ECF No. 199].

3. This Court shall retain jurisdiction to hear and determine all matters arising from or related to this Order.
