## **NOTICE OF CONTINUED NON-COMPLIANCE**

Comes now Ellen Arvin Kennedy, solely in her capacity as the Liquidating Trustee (the “Liquidating Trustee”) of the Cambrian Liquidating Trust (the “Liquidating Trust”), by and through her counsel, as directed by the Court’s Order dated June 25, 2021 [DE 1809], and hereby gives notice of the continued non-compliance of Pristine Clean Energy, LLC (“Pristine”) and Virgie Clean Mining, LLC (“Virgie” collectively with Pristine, the “Pristine Parties”).

The Liquidating Trustee advises the Court that as of this filing the Pristine Parties have paid none of the amounts ordered to be paid (including accrued sanctions) to the Cambrian Liquidating Trust.
