Upon the motion (the "Motion")<sup>1</sup> of Aluminum Shapes, L.L.C., as debtor and debtor in possession in the above-captioned chapter 11 cases ("Debtor"), pursuant to sections 105(a) and 521(a)(1)(B) of the Bankruptcy Code, and Bankruptcy Rule 1007(c), for an order extending the fourteen (14) day period to file its schedules of assets and liabilities and statements of financial affairs (collectively, the "Schedules") by an additional fourteen (14) days, through and including September 12, 2021, without prejudice to the Debtor's right to request additional time should it become necessary, as more fully set forth in the Motion; and the Court having jurisdiction to decide the Motion and the relief requested therein in accordance with 28 U.S.C. §§ 157(a)-(b) and 1334(b) and the Standing Order of Reference to the Bankruptcy Court Under Title 11 of the United States District Court for the District of New Jersey, dated September 18, 2012 (Simandle, C.J.); and consideration of the Motion and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and notice of the Motion having been given as provided in the Motion, and such notice having been adequate and appropriate under the circumstances; and it appearing that no other or further notice of the Motion need be provided; and the Court having held a hearing to consider the relief requested in the Motion (the "Hearing"); and upon the Declaration of Jordan Meyers in Support of Debtor's Chapter 11 Petitions and First Day Pleadings, filed contemporaneously with the Motion, the record of the Hearing, and all of the proceedings had before the Court; and the Court having found and determined that the relief sought in the Motion
