Confidential Information (as defined herein) under seal and (b) granting certain related relief. This Sealing Motion is supported by the *Declaration of Matthew Landess in Support of (A) Debtors' Motion for Entry of an Order Authorizing Debtors To Assume Certain Aircraft Leases and (B) Related Pleadings* (the "Landess Declaration") filed contemporaneously herewith and incorporated herein by reference. In further support of this Sealing Motion, the Debtors respectfully state as follows:

Jurisdiction and Venue

1. The United States Bankruptcy Court for the Southern District of New York (the "**Court**") has jurisdiction over this Sealing Motion pursuant to 28 U.S.C. §§ 157 and 1334 and the *Amended Standing Order of Reference M-431*, dated January 31, 2012 (Preska, C.J.). This is a core proceeding pursuant to 28 U.S.C. § 157(b). In addition, the Debtors confirm their consent, pursuant to Rule 7008 of the Federal Rules of Bankruptcy Procedure (the "**Bankruptcy Rules**"), to entry of a final order by the Court in connection with this Sealing Motion to the extent that it is later determined that the Court, absent consent of the parties, cannot enter a final order or judgment in connection herewith consistent with Article III of the United States Constitution.

2. Venue of the Chapter 11 Cases and related proceedings is proper in this district pursuant to 28 U.S.C. §§ 1408 and 1409.

Relief Requested

3. By this Sealing Motion, and pursuant to sections 105(a) and 107(b) of chapter 11 of title 11 of the United States Code (the "**Bankruptcy Code**") and Bankruptcy Rule 9018, the Debtors respectfully request entry of an order, substantially in the form attached hereto as **Exhibit** Δ (the "**Proposed Order**" and, if entered, the "**Order**"), (a) authorizing the Debtors to (i) partially redact the filed version of Schedule 1 and (ii) submit an unredacted version of the Confidential

Information (as defined herein) under seal, and (b) granting certain related relief, as further detailed herein and in the Proposed Order.

Background

4. On June 30, 2020, each of the Debtors filed in this Court voluntary petitions for relief under chapter 11 of the Bankruptcy Code. The Debtors have continued to operate and manage their businesses and have continued to possess their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.

5. The Chapter 11 Cases are being jointly administered for procedural purposes only pursuant to Bankruptcy Rule 1015(b) and the *Order Directing Joint Administration of Chapter 11 Cases* [ECF No. 30] entered by the Court on July 1, 2020 in Grupo Aeroméxico's Chapter 11 Case.²

6. On July 13, 2020, the Office of the United States Trustee for the Southern District of New York (the "**U.S. Trustee**") appointed an Official Committee of Unsecured Creditors (the "**Committee**") pursuant to section 1102 of the Bankruptcy Code. *See Notice of Appointment of Official Committee of Unsecured Creditors* [ECF No. 92]. No trustee or examiner has been appointed in the Chapter 11 Cases.

7. Detailed information regarding the Debtors' businesses and affairs, capital structure, and the circumstances leading to the commencement of the Chapter 11 Cases can be found in the *Declaration of Ricardo Javier Sánchez Baker in Support of the Debtors' Chapter 11 Petitions and First Day Pleadings* [ECF No. 20], which is incorporated herein by reference.

The Confidential Information

8. As the Court is aware, the Debtors have been engaged in a multi-step process to (a) analyze their anticipated, long-term fleet and equipment needs, (b) make corresponding adjustments to the size and composition of their current operating fleet, and (c) obtain the most favorable terms for agreements relating to aircraft equipment.

9. As part of these efforts, the Debtors seek to assume the Aircraft Leases,³ as they believe that the Aircraft fit within the Debtors' long-term business plan and fleet needs. While the Debtors recognize the need to disclose sufficient information and details when seeking the relief requested in the Assumption Motion, the Debtors must ensure that they protect certain very limited, but sensitive, key economic and commercial terms of the Aircraft Leases, which could be extrapolated from the proposed cure costs set forth on Schedule 1 (the "**Confidential Information**"). As a result, by this Sealing Motion, the Debtors seek to partially redact Schedule 1.

10. Disclosure of the Confidential Information could reasonably be expected to cause harm to the Debtors and jeopardize their goals at a critical juncture in the Chapter 11 Cases in various ways.

11. <u>First</u>, disclosing the Confidential Information would provide other aircraft counterparties insight into the Debtors' cost structure, negotiating positions, and fleet strategy, as it would allow industry participants to reverse-engineer certain terms of the Aircraft Leases. Counterparties that are currently negotiating with the Debtors over new long-term leases, some for aircraft or equipment similar to the Aircraft under the Assumption Motion, will insist on obtaining

the most favorable economic terms provided to any other lessor. Moreover, the Debtors anticipate further negotiations with equipment and aircraft counterparties (and potential new counterparties) regarding the terms of long-term lease agreements, and the Debtors' negotiating position would be harmed if equipment and aircraft counterparties know the details of terms in the Aircraft Leases. Further, if the Debtors are not successful in protecting sensitive information, it would hinder the Debtors' ability to enter into further agreements with, and obtain beneficial economic terms from, the Lessors and other counterparties necessary to the Debtors' ongoing business. Accordingly, the Debtors cannot publicize the proposed cure costs for each of the Aircraft Leases, as it could result in the disclosure of certain terms under the Aircraft Leases and, thereby, disadvantage the Debtors when negotiating with equipment and aircraft counterparties.

12. <u>Second</u>, disclosure of the Confidential Information would allow industry competitors to extrapolate rarely disclosed information. Given that fleet strategy and costs are core components of any commercial airline's business model, disclosure of the Confidential Information would allow competitors to reverse-engineer certain terms of the Aircraft Leases and gain unique insight into the Debtors' business strategy, which insight the Debtors themselves do not have respecting their competition. In an already challenging marketplace, this informational asymmetry would leave the Debtors at a competitive disadvantage relative to their peers.

13. Based on the foregoing, since disclosure of the Confidential Information would likely harm the Debtors and their estates, the Debtors should be permitted to redact such information from Schedule 1 and submit an unredacted version of the Confidential Information to the Court under seal.

Basis for Relief

14. Section 105(a) of the Bankruptcy Code codifies the Court's inherent equitable powers to "issue any order, process, or judgment that is necessary or appropriate to carry out the

provisions of this title." 11 U.S.C. § 105(a). Furthermore, pursuant to section 107(b)(1) of the Bankruptcy Code, the Court may authorize the Debtors to redact the Confidential Information from the filed version of Schedule 1 and file an unredacted version thereof with the Court under seal. *See* 11 U.S.C. § 107(b). Specifically, section 107(b) of the Bankruptcy Code provides, in relevant part, that:

On request of a party in interest, the bankruptcy court shall, and on the bankruptcy court's own motion, the bankruptcy court may—(1) protect an entity with respect to a trade secret or confidential research, development, or commercial information

11 U.S.C. § 107(b).

15. Similarly, Bankruptcy Rule 9018 sets forth the procedures by which a party may obtain a protective order authorizing the filing of a document under seal. Bankruptcy Rule 9018 provides, in relevant part, that "[o]n motion, or on its own initiative, with or without notice, the court may make any order which justice requires (1) to protect the estate or any entity in respect of a trade secret or other confidential research, development, or commercial information" Fed. R. Bankr. P. 9018.

16. The Debtors respectfully submit that a balance must be found between the need to protect sensitive and confidential commercial information with the goal of transparency in the bankruptcy process. Indeed, the Second Circuit has acknowledged that section 107(b) of the Bankruptcy Code creates an exception to the general rule that court records are open to examination by the public. *See Video Software Dealers Ass 'n v. Orion Pictures Corp. (In re Orion Pictures Corp.)*, 21 F.3d 24, 28 (2d Cir. 1994); *In re Georgetown Steel Co., LLC*, 306 B.R. 542, 546 (Bankr. D.S.C. 2004) (recognizing that "the public right to access is not absolute"). However, the Second Circuit has also acknowledged that, unlike its counterpart Rule 26(c) of the Federal Rules of Civil Procedure, section 107(b) of the Bankruptcy Code does not require the entity

seeking protection to demonstrate "good cause." *In re Orion Pictures Corp.*, 21 F.3d at 28. Rather, if the material sought to be protected satisfies one of the categories identified in section 107(b) of the Bankruptcy Code, a court is required to protect the requesting party and has no discretion to deny the request. *Id.* at 27 (holding that, once the court determines that a party is seeking protection of information that falls within the ambit of section 107(b) of the Bankruptcy Code, "the court is required to protect a requesting interested party and has no discretion to deny the application"). Thus, under section 107(b) of the Bankruptcy Code, an interested party only has to show that the information it wishes to protect is "confidential' and 'commercial' in nature." *Id.* Such information, however, need not rise to the level of a trade secret to be protected under section 107(b) of the Bankruptcy Code. *Id.* at 28.

17. Courts have also held that the sealing order under section 107(b) should be as broad as "justice requires." *In re Glob. Crossing, Ltd.*, 295 B.R. 720, 724 (Bankr. S.D.N.Y. 2003). Indeed, a court's "authority goes not just to the protection of confidential documents, but to other confidentiality restrictions that are warranted in the interests of justice." *Id.; see also In re Kaiser Aluminum Corp.*, 327 B.R. 554, 560 (D. Del. 2005) ("Courts have supervisory powers over their records and files and may deny access to those records and files to prevent them from being used for an improper purpose.").

18. The Debtors respectfully submit that the Confidential Information is both "commercial" and "confidential;" thus, falling squarely within the scope of information that is protected by section 107(b)(1) of the Bankruptcy Code and Bankruptcy Rule 9018. In granting motions to seal "commercial information," courts have defined this term as "information which would result in 'an unfair advantage to competitors by providing them information as to the commercial operations of the debtor." *In re Alterra Healthcare Corp.*, 353 B.R 66, 75 (Bankr. D.

Del. 2006); *see also Glob. Crossing, Ltd.*, 295 B.R. at 725 (finding that the purpose of Bankruptcy Rule 9018 is to "protect business entities from disclosure of information that could reasonably be expected to cause the entity commercial injury").

19. As detailed above, disclosure of the Confidential Information could reasonably be expected to cause harm to the Debtors and jeopardize their goals in the Chapter 11 Cases by permitting the Debtors' aircraft and engine counterparties and competitors to gain insight into the Debtors' cost structure, thereby allowing them to pressure the Debtors' aircraft and engine lenders and lessors for matching commercial terms with respect to other long-term leases or stipulations. If the Debtors are not successful in protecting the Confidential Information, competitors and counterparties could reverse-engineer the terms of the Aircraft Leases and it would severely impair the Debtors' leverage when negotiating new and amended agreements by creating a competitive disadvantage in relation to their industry competitors.

20. In fact, courts in similar situations to the instant matter regularly allow the sealing of information which, if disclosed, could assist the Debtors' competitors or counterparties in negotiations against the Debtors. *See, e.g., In re Grupo Aeroméxico, S.A.B. de C.V.*, Case No. 20-11563 (SCC) (Bankr. S.D.N.Y.) [ECF Nos. 397, 649, 983, 1093, 1146, 1159, 1569, 1570, 1571, 1576] (granting sealing motions in connection with aircraft transaction documents and usage stipulations for leased aircraft equipment); *In re LATAM Airlines Group S.A.*, Case No. 20-11254 (JLG) (Bankr. S.D.N.Y. Jul. 10, 2020) [ECF No. 514]; *In re Avianca Holdings S.A.*, Case No. 20-11133 (MG) (Bankr. S.D.N.Y. Jul. 7, 2020) [ECF No. 390]; *In re Republic Airways Holdings Inc.*, Case No. 16-10429 (Bankr. S.D.N.Y. Dec. 8, 2016) (SHL) [ECF Nos. 1031, 1271] (granting sealing motions with respect to section 1110 aircraft stipulation and amendments to loan agreement on the basis that the information contained therein would be highly valuable to the debtors' aircraft

lenders and lessors who may seek to use the information to gain a commercial advantage over the debtors); *In re Northwest Airlines Corp.*, Case No. 05-17930 (Bankr. S.D.N.Y. Nov. 10, 2005) (ALG) [ECF No. 1003] (order establishing procedures for filing section 1110 stipulations with aircraft counterparties under seal); *In re Delta Air Lines, Inc.*, Case No. 05-17923 (Bankr. S.D.N.Y. Nov. 1, 2005) (PCB) [ECF No. 994] (same). Therefore, the Debtors submit that the Confidential Information should be filed under seal pursuant to section 107(b) of the Bankruptcy Code.

21. Finally, and very importantly, the proposed redactions are limited and tailored to protect only specific information whose publication could reasonably be expected to adversely affect the Debtors' ongoing and future negotiations or competition with their peers. The narrowly-tailored nature of the redactions will serve to both minimize the quantity of redacted information while maximizing value for the Debtors' estates and economic stakeholders.

22. Accordingly, the Debtors propose to file with the Court an unredacted copy of Schedule 1 under seal and to share an unredacted version, on a strictly confidential basis, with the U.S. Trustee, each party listed on Schedule 1, and the respective advisors to the Committee, the DIP Lenders, and the Ad Hoc Group of Senior Noteholders on a "Professionals Eyes Only" basis.

<u>Notice</u>

23. Notice of this Sealing Motion will be provided to the following parties: (a) the entities on the Master Service List (as defined in the *Order Establishing Certain Notice, Case Management, and Administrative Procedures* [ECF No. 79], which is available on the Debtors' case website at https://dm.epiq11.com/case/aeromexico/info); (b) the U.S. Trustee; (c) counsel to the Committee; (d) counsel to Apollo Management Holdings, L.P.; (e) counsel to the Ad Hoc Group of Senior Noteholders; (f) each party listed on Schedule 1; and (g) any person or entity with a particularized interest in the subject matter of this Sealing Motion. The Debtors respectfully

Upon the motion (the "Sealing Motion")² of the Debtors for entry of an order (this "Order"), authorizing the Debtors to file a portion of Schedule 1 under seal, as set forth more fully in the Sealing Motion and the Landess Declaration; and the Court having jurisdiction to consider the Sealing Motion and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334 and the Amended Standing Order of Reference M-431, dated January 31, 2012 (Preska, C.J.); and consideration of the Sealing Motion and the relief requested therein being a core proceeding under 28 U.S.C. § 157(b); and venue of the Chapter 11 Cases and related proceedings being proper in this district pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Sealing Motion having been provided to the notice parties identified in the Sealing Motion; such notice having been adequate and appropriate under the circumstances, and it appearing that no other or further notice need be provided; and the Court having reviewed the Sealing Motion [and held a hearing to consider the relief requested in the Sealing Motion on September 20, 2021 (the

"Hearing")]; and upon [the record of the Hearing, and upon] all of the proceedings had before the Court; and after due deliberation the Court having determined that the legal and factual bases set forth in the Sealing Motion establish just cause for the relief granted herein; and the Court having found that the relief granted herein is in the best interests of the Debtors, their creditors, and all other parties in interest; and after due deliberation and sufficient cause appearing therefor,

IT IS HEREBY ORDERED THAT:

1. The Sealing Motion is granted as set forth herein.

2. The Debtors are authorized to (a) file a partially redacted version of Schedule 1 on the public docket of the Chapter 11 Cases and (b) submit an unredacted version of Schedule 1 to the Clerk of the Court, along with a copy of this Order, clearly labeled "TO BE FILED UNDER SEAL."

3. The unredacted copy of Schedule 1 shall remain confidential and shall not be made available to anyone without the prior written consent of the Debtors other than the U.S. Trustee, each party listed on Schedule 1, and the respective advisors to the Committee, the DIP Lenders, and the Ad Hoc Group of Senior Noteholders on a "Professionals Eyes Only" basis.

4. The Debtors and any party authorized to receive an unredacted copy of Schedule 1 pursuant to this Order shall be authorized and directed, subject to Rule 9018-1(c) of the Local Rules of the United States Bankruptcy Court for the Southern District of New York, to redact specific references to information included in Schedule 1 from any pleadings filed on the public docket of the Chapter 11 Cases.

5. Entry of this Order is without prejudice to the rights of any party in interest in the Chapter 11 Cases or the U.S. Trustee to seek an order of this Court unsealing all or part of Schedule 1 or the Confidential Information.

6. The Clerk of the Court is authorized to destroy Schedule 1 at the conclusion of the Chapter 11 Cases.

7. The Debtors are authorized to take, or refrain from taking, any action necessary or appropriate to implement and effectuate the terms of, and the relief granted in, this Order without seeking further order of the Court.

8. While the above referenced Chapter 11 Cases are pending, this Court shall retain the exclusive jurisdiction over any and all matters arising from or related to the implementation, interpretation, and enforcement of this Order.
