ORDER GRANTING EMERGENCY MOTION OF THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS TO FILE UNDER SEAL THE EMERGENCY MOTIONS OF THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS FOR (I) LEAVE, STANDING, AND AUTHORITY TO COMMENCE AND PROSECUTE CERTAIN CLAIMS AND CAUSES OF ACTION ON BEHALF OF THE DEBTORS' ESTATES AND (II) EXCLUSIVE SETTLEMENT AUTHORITY, AND RELATED COMPLAINTS [Relates to Dkt. No. 1543]

Upon the Emergency Motion of the Official Committee of Unsecured Creditors to File Under Seal the Emergency Motions of the Official Committee of Unsecured Creditors for (I) Leave, Standing, and Authority to Commence and Prosecute Certain Claims and Causes of Action on behalf of the Debtors' Estates and (II) Exclusive Settlement Authority, (the "Motion to Seal");<sup>2</sup> and the Court having jurisdiction to consider the Motion to Seal and the relief requested therein pursuant to 28 U.S.C. § 1334; and consideration of the Motion to Seal and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and the Court having determined that the legal and factual bases set forth in the Motion to Seal establish just cause

it is hereby ORDERED that

1. Pursuant to 11 U.S.C. §§ 105(a) and 107(b) and Fed. R. Bankr. P. 9018, the

Committee is authorized to file the Standing Motions and all exhibits to the Standing Motions

under seal.

2. The sealed Standing Motions shall not be disseminated to anyone other than:

(a) the Court; (b) the Debtors; (c) the other parties to the Confidentiality Agreement or

Bylaws; and (d) the Office of the U.S. Trustee, without further order of the Court.

3. The terms and conditions of this Order shall be immediately effective and

enforceable upon its entry.

4. The Committee is authorized to take all actions necessary to effectuate the relief

granted in this Order in accordance with the Motion to Seal.

5. The Court shall retain jurisdiction to resolve any dispute regarding the terms of

this Order.
