**ORDER GRANTING EMERGENCY MOTION OF THE OFFICIAL COMMITTEE OF
UNSECURED CREDITORS TO FILE UNDER SEAL OBJECTION OF THE OFFICIAL
COMMITTEE OF UNSECURED CREDITORS TO THE DEBTORS' SECOND
AMENDED JOINT CHAPTER 11 PLAN OF REORGANIZATION
OF CHESAPEAKE ENERGY CORPORATION AND ITS DEBTOR AFFILIATES**

Upon the *Emergency Motion Of The Official Committee Of Unsecured Creditors To File Under Seal Objection Of The Official Committee of Unsecured Creditors To The Debtors' Second Amended Joint Chapter 11 Plan of Reorganization of Chesapeake Energy Corporation and its Debtor Affiliates* (the "**Motion to Seal**");² and the Court having jurisdiction to consider the Motion to Seal and the relief requested therein pursuant to 28 U.S.C. § 1334; and consideration of the Motion to Seal and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and the Court having determined that the legal and factual bases set forth in the Motion to Seal establish just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefor, it is hereby **ORDERED** that

1. Pursuant to 11 U.S.C. §§ 105(a) and 107(b) and Fed. R. Bankr. P. 9018, the Committee is authorized to file the Confirmation Objection under seal.

2. The sealed Confirmation Objection shall not be disseminated to anyone other than: (a) the Court; (b) the Debtors; (c) the other parties to the Confidentiality Agreement or Bylaws; and (d) the Office of the U.S. Trustee, without further order of the Court.

3. The terms and conditions of this Order shall be immediately effective and enforceable upon its entry.

4. The Committee is authorized to take all actions necessary to effectuate the relief granted in this Order in accordance with the Motion to Seal.

5. The Court shall retain jurisdiction to resolve any dispute regarding the terms of this Order.
