ORDER GRANTING TRUSTEE'S *EMERGENCY* MOTION FOR AUTHORITY TO <u>OPERATE PURSUANT TO 11 U.S.C. § 721 AS OF JUNE 21, 2021</u> [Related to Docket No. 736]

On this day came on to be considered the *Trustee's Emergency Motion For Authority to Operate Pursuant to 11 U.S.C. § 721 as of June 21, 2021* (the "**Motion**")¹ by Janet Northrup, Chapter 7 Trustee of the bankruptcy estate of Country Fresh Holding Company, Inc., *et. al.* ("**Trustee**"). The Court having considered the same is of the opinion that it should be in all things granted; it is therefore

ORDERED that the Trustee is authorized to operate and take any actions necessary or advisable in accordance with or as contemplated by the Sale Order, APA, TSA, Stipulations and Agreed Orders, and the Conversion Order. It is further

ORDERED that the Trustee is authorized to take all actions necessary or advisable to carry out the actions contemplated in the Sale Order, APA, TSA, Stipulations and Agreed Orders, and the Conversion Order, including but not limited to the following actions:

- (i) Hiring current or former employees to assist with the Wind-down Process and any actions contemplated by the Sale Order, APA, TSA, Stipulations and Agreed Orders, and the Conversion Order;
- (ii) Taking any actions necessary to maintain such employees such as making certain tax withholdings and employing Debtors' former payroll service provider Ceridian;
- (iii) Transferring Buyer's accounts receivable to Buyer;
- (iv) Approving transfers of funds related to the Carve Out Reserve and Buyer's pre-funding of obligations under the TSA, including those related to Contracts, Leases, Insurance Policies, and Permits (each as defined in the APA);
- (v) Preparing and filing any necessary post-conversion monthly operating reports and assisting with any pre-conversion monthly operating reports as necessary.

It is further

ORDERED in accordance with the Conversion Order, the Trustee is authorized to use cash collateral in accordance with a budget to be agreed between the Ad Hoc Group of Secured

Lenders and the Trustee.

ORDERED that to the extent applicable, Rules 6004(h) and 6006(d) of the Federal Rules

of Bankruptcy Procedure are waived and this Order shall be effective and enforceable immediately upon entry. It is further

ORDERED that this Court retains exclusive jurisdiction with respect to all matters, claims, rights or disputes arising from or related to the implementation, interpretation, and enforcement of this Order and any other orders entered in these cases. It is further
