Upon consideration of the First and Final Fee Application of Ankura Consulting Group, LLC for Allowance and Payment of Compensation for Services Rendered and Reimbursement of Expenses Incurred During the Period from February 15, 2021 through June 21, 2021 (the "Application") and it appearing that this Court has jurisdiction to consider the Application pursuant to 28 U.S.C. § 1334; and it appearing that the venue of these chapter 11 cases in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and it appearing that this matter is a core proceeding pursuant to 28 U.S.C. § 157(b); and, after due deliberation, the Court having determined that the relief requested in the Application is in the best interests of the Debtors; their

estates, their creditors and other parties in interest; and it appearing that proper and adequate notice of the Application has been given and that no other further notice is necessary; with the objection filed by Janet S. Northrup (the "Chapter 7 Trustee"), the Chapter 7 Trustee for the bankruptcy estates of the Debtors in the above-referenced case, having been resolved, and good and sufficient cause appearing therefore;

It is hereby ORDERED, ADJUDGED, AND DECREED that:

1. The Ankura Consulting Group, LLC is allowed an administrative expenses claim in the amount of \$3,430,659.25 in fees and \$2,722.33 in expenses for a total of \$3,433,381.58, incurred from February 15, 2021 through June 21, 2021 pursuant to section 330 of the Bankruptcy Code.

2. Ankura Consulting Group, LLC previously received \$2,401,085.33 from the Debtors for payment of fees and expenses pursuant to the Interim Compensation Order [Dkt. No. 598].

3. The Chapter 7 Trustee is authorized and directed to pay to Ankura Consulting Group, LLC \$1,032,296.25 as an allowed administrative expense claim from the Carve-Out (as defined in the Final DIP Order [Dkt. No. 335]).

4. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order.
