**STIPULATION AND AGREED ORDER REGARDING THE APPLICATION AND
REQUEST FOR ALLOWANCE AND PAYMENT OF ADMINISTRATIVE EXPENSE
CLAIM OF ARAMARK UNIFORM & CAREER APPAREL, LLC**

(Related to Docket No. 898)

This stipulation and agreed order (“Stipulation and Agreed Order”) regarding the Application and Request for Allowance and Payment of Administrative Expense Claim of ARAMARK Uniform & Career Apparel, LLC (“Application”) is by and between Janet S. Northup, chapter 7 Trustee (“Trustee”) for the bankruptcy estate of Country Fresh Holding Company Inc., *et al.* (“Debtors”), and ARAMARK Uniform & Career Apparel, LLC (ARAMARK Uniform & Career Apparel, LLC and the Trustee on behalf of the Debtors are the “Parties”). The Parties hereby stipulate and agree as follows:

RECITALS

WHEREAS, between the period of March 24, 2021 and April 29, 2021 ARAMARK Uniform & Career Apparel, LLC dba ARAMARK Uniform Services provided clean uniforms and/or supplies to the Debtors in the ordinary course of the Debtors' business.

WHEREAS, on February 15, 2021 (the "Petition Date"), each Debtor filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code;

WHEREAS, on June 21, 2021, the Court entered an *Order (I) Authorizing and Approving the Conversion of the Chapter 11 Cases, (II) Extending the Designation Rights Period, and (III) Granting Related Relief* at Docket No. 719;

WHEREAS, on June 21, 2021, the Trustee was appointed as the Chapter 7 Trustee in the above-referenced case;

WHEREAS, on August 30, 2021, ARAMARK Uniform & Career Apparel, LLC filed its Application, asserting that it was entitled to an administrative expense claim for services provided to the Debtors post-petition in the amount of \$34,716.86;

WHEREAS, ARAMARK Uniform & Career Apparel, LLC attached to its Application a list of the invoices comprising its administrative claim (the "Invoices");

WHEREAS, the Parties have reached an agreement regarding the Application;

NOW, THEREFORE, IT IS HEREBY STIPULATED, AGREED, AND ORDERED AS FOLLOWS:

1. ARAMARK Uniform & Career Apparel, LLC shall have an allowed administrative expense claim pursuant to 11 U.S.C. § 503(b)(9) against Country Fresh LLC in the amount of \$34,716.86; and

2. Payment of ARAMARK Uniform & Career Apparel, LLC's allowed administrative claim shall be made at such time as distributions are made to other administrative creditors, and in accordance with the priorities under the Bankruptcy Code.

IT IS SO ORDERED.
