**ORDER AUTHORIZING THE DEBTORS
TO FILE CERTAIN 2015.3 REPORTS UNDER SEAL**

Upon the motion, dated January 15, 2021 (the “**Motion**”), of CBL & Associates Properties, Inc. (“**CBL**”) and its debtor affiliates, as debtors and debtors in possession in the above-captioned chapter 11 cases (collectively, the “**Debtors**”), for entry of an order pursuant to sections 105(a) and 107(b) of the Bankruptcy Code and Bankruptcy Rule 9018 (i) authorizing the Debtors to file under seal the Confidential JV Reports,³ and (ii) directing that such Confidential JV Reports remain under seal and confidential and not be made available to anyone other than as set forth herein, all as more fully set forth in the Motion; and this Court having jurisdiction to consider the Motion and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334; and consideration of the Motion and the requested relief being a core proceeding pursuant to 28 U.S.C. § 157(b); and it appearing that venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Motion having been provided; and such notice having been adequate and appropriate under the circumstances, and it appearing that no other or further notice need be

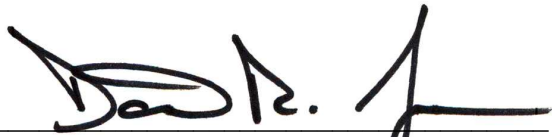
provided; and this Court having reviewed the Motion; and upon any hearing held on the Motion; and all objections, if any, to the Motion having been withdrawn, resolved, or overruled; and this Court having determined that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein; and it appearing that the relief requested in the Motion is in the best interests of the Debtors and their respective estates and creditors; and upon all of the proceedings had before this Court and after due deliberation and sufficient cause appearing therefor,

IT IS HEREBY ORDERED THAT

1. The Motion is granted as set forth herein.
2. Pursuant to sections 105(a) and 107(b) of the Bankruptcy Code and Bankruptcy Rule 9018, the Debtors are authorized to file under seal the Confidential JV Reports, which shall remain under seal and confidential and shall not be made available to anyone without the consent of the Debtors or further order from this Court (after notice and hearing); *provided, however*, that unredacted copies of such Confidential JV Reports shall be provided on a strictly confidential basis to (i) the U.S. Trustee, (ii) on a “professional eyes’ only” basis to the advisors to the Creditors’ Committee, and (iii) any additional party who, upon good faith review of a request, the Debtors consent to receiving the Confidential Information.
3. Any party who receives the Confidential Information in accordance with this Order shall not disclose or otherwise disseminate such Confidential Information to any other person or entity.
4. Notwithstanding the provisions of Bankruptcy Rule 6004(h), this Order shall be immediately effective and enforceable upon its entry.
5. The Debtors are authorized to take all actions necessary or appropriate to carry out the relief granted in this Order.

6. This Court shall retain jurisdiction to hear and determine all matters arising from or related to the implementation, interpretation, or enforcement of this Order.
