Dear Mr. Gibson,

You filed Proof of Claim No. 24594 in the Ditech bankruptcy on November 5, 2019. The claim was related to an escrow surplus check in the amount of \$2,417.24 which had expired before you had the opportunity to cash it. You noted that Ditech informed you that you needed to file a Proof of Claim in order to have the funds reissued.

An objection was filed to your claim on January 17, 2020 because there was insufficient documentation in order to sustain a legal claim. 
