**AMENDED
UNITIZATION AGREEMENT**

BILL HILL OIL AND GAS PRODUCTION - NOBLES #2 OIL UNIT

STATE OF TEXAS }

COUNTY OF SHELBY }

WHEREAS BILL Hill (dba) BILL HILL OIL AND GAS PRODUCTION, is the owner of the oil, gas, and mineral leases described in Exhibit "A: attached hereto covering lands in Shelby County, Texas; and,

WHEREAS, the owner of said leases desires to form a unit for the production of oil, gas, casinghead gas, and other minerals,

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS: That in consideration of the terms and conditions of said leases and the promises herein made, the leases described in Exhibit "A" and the lands covered thereby are hereby pooled and unitized into one unit comprising the lands shown in the plat attached hereto as Exhibit "B" and made a part hereof for the production of oil, gas, casinghead gas, and other minerals from all formations from the surface to a subsurface depth of 3,000 feet.

The parties hereto commit all of their respective interests in the lands described in Exhibit "C" attached hereto so that the unitization shall have the following effect:

1. The unit shall be operated as an entirety for the exploration, development, and production of oil, gas, casinghead gas, and other minerals, rather than as separate tracts under the above described leases.

2. For the purpose of computing the royalty, there shall be allocated to each lease above described that pro rata portion of the oil, gas, casinghead gas, and other minerals produced from the unit which the number of surface acres covered by each such lease bears to the total number of surface acres included in the unit established hereby.

3. All drilling operations, reworking, or other operations on any portion of the land within the unitized area shall be considered as though the same were on each separate tract in the unit, regardless of the actual location of the well or wells thereon, for all purposes under the term of the respective leases.

4. Production of oil, gas, casinghead gas, and other minerals from the unit allocated to each separate tract, respectively as herein provided, shall be deemed to have been produced from each such separate tract in the unit, regardless of the actual location of the well or wells thereon, for all purposes under the terms of the respective leases.

5. All rights to the production of oil, gas, casinghead gas, and other minerals from the unit, including royalties and other payments shall be determined and governed by the lease pertaining to each separate tract, respectively, based upon the production so allocated to such tract only, and in lieu of the actual production of oil, gas, casinghead gas, and other minerals therefrom.

8. Should the unit terminate for any cause, in whole or in part, the leases affecting the lands within the unit, if not then otherwise maintained in force and effect, shall remain and may be maintained in force and effect under their respective terms and conditions in the same manner as though there had been production or operations under said leases and the same had ceased on the date of the termination of this unit.

9. The unit created hereby shall become effective on the date of first production.

10. The unit shall remain in effect so long as oil, gas, casinghead gas, or other minerals are produced therefrom, or so long as drilling or reworking operations are being prosecuted thereon with no more than sixty (60) days between the cessation of either production or such operations and the beginning or resumptions of either of them, as the case may be, from time to time thereafter, or so long as all existing leases are maintained in force by the payment or tender of shut-in gas well royalties, or by other means, in accordance with the terms of said leases.

The unit created hereby may be dissolved by the owners of said leases by an instrument filed for record in Shelby County, Texas, at any time after the cessation of production of oil, gas, casinghead gas, or other minerals from said land.

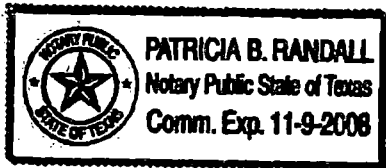

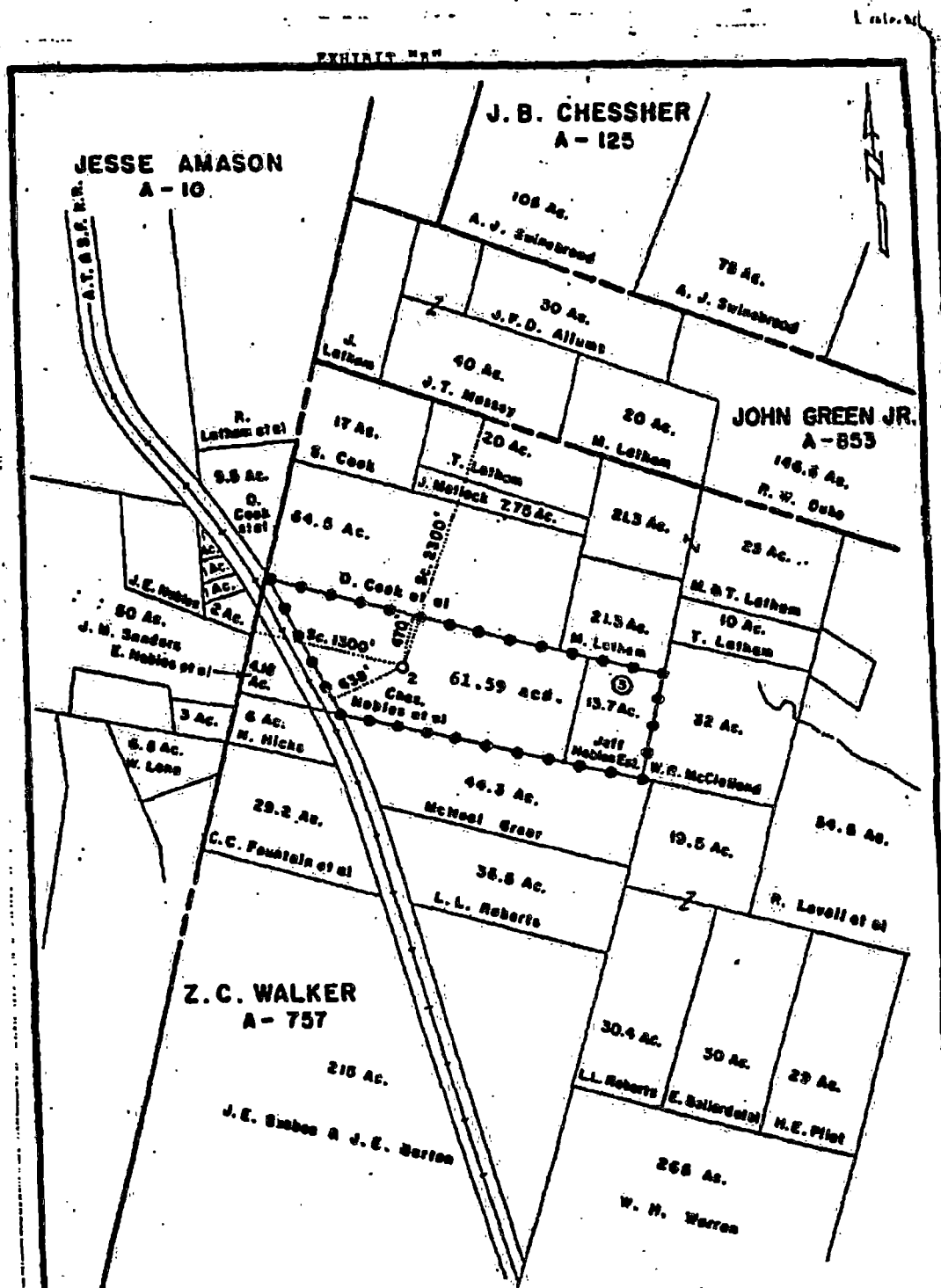

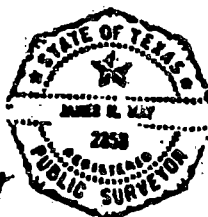

FIRST TRACT: Being 13-7/10ths acres of land in the Z. C. WALKER H. R. SURVEY, Shelby County, Texas, located about 1-3/4 miles Southeast from the City of Center, Texas; and being the same land described in deed from O. H. WALKER SURVEY, Shelby County, Texas, a part of Subdivision No. 2 as per map of said subdivision filed for record in the office of the County Clerk of Shelby County, Texas; and being described as 70 acres, less 4.96 acres, less 3.45 acres, leaving 61.59 acres as follows, to-wit;

BEGINNING at a stake in the West line of this League for the Southwest corner of this tract from which Red Oak 5 in. diameter South 16° East 6 varas, Sweet Gum 24" in diameter South 89° West 4 varas, said stake being 1060 varas South 16° West from the Northwest corner of this league;

THENCE North 16° East 372 varas to a Sweet Gum the Northwest corner of this tract;

THENCE South 74° East 1020 varas to a stake in road at corner of fence the Northeast corner of this tract from which Dogwood marked X 8 inches in diameter bears South 84-1/2 East 20 varas; Dogwood marked X 8 inches in diameter bears North 55 East 11-1/2 varas;
