**STIPULATION AND AGREED ORDER REGARDING THE APPLICATION AND
REQUEST FOR ALLOWANCE AND PAYMENT OF ADMINISTRATIVE EXPENSE
CLAIM OF PACKER SANITATION SERVICES, INC., LTD
(Related to Docket No. 947)**

This stipulation and agreed order (“Stipulation and Agreed Order”) regarding the Application and Request for Allowance and Payment of Administrative Expense Claim of Packers Sanitation Services, Inc., Ltd (“Application”) is by and between Janet, Northup, chapter 7 Trustee (“Trustee”) for the bankruptcy estate of Country Fresh Holding Company Inc., *et al.* (“Debtors”), and Packers Sanitation Services, Inc., Ltd (Packers Sanitation Services, Inc., Ltd and the Trustee on behalf of the Debtors are the “Parties”). The Parties hereby stipulate and agree as follows:

RECITALS

WHEREAS, between the period of April 19, 2021, and April 29, 2021 Packers Sanitation Services, Inc., Ltd provided post-petition sanitation service and chemicals to the Debtors in the ordinary course of the Debtors' business.

WHEREAS, on February 15, 2021 (the "Petition Date"), each Debtor filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code;

WHEREAS, on June 21, 2021, the Court entered an *Order (I) Authorizing and Approving the Conversion of the Chapter 11 Cases, (II) Extending the Designation Rights Period, and (III) Granting Related Relief* at Docket No. 719;

WHEREAS, on June 21, 2021, the Trustee was appointed as the Chapter 7 Trustee in the above-referenced case;

WHEREAS, on September 9, 2021, Packers Sanitation Services, Inc., Ltd filed its Application, asserting that it was entitled to an administrative expense claim for services provided to the Debtors on a post-petition in the amount of \$73,119.46;

WHEREAS, Packers Sanitation Services, Inc., Ltd attached to its Application copies of (a) the invoices comprising its administrative claim (the "Invoices");

WHEREAS, the Parties have reached an agreement regarding the Application;

**NOW, THEREFORE, IT IS HEREBY STIPULATED, AGREED, AND ORDERED
AS FOLLOWS:**

1. Packers Sanitation Services, Inc., Ltd shall have an allowed administrative expense claim pursuant to 11 U.S.C. § 503(b)(9) against Country Fresh LLC in the amount of \$73,119.46; and

2. Payment of Packers Sanitation Services, Inc., Ltd.'s allowed administrative claim shall be made at such time as distributions are made to other administrative creditors, and in accordance with the priorities under the Bankruptcy Code.

IT IS SO ORDERED.
