STIPULATION AND AGREED ORDER REGARDING THE APPLICATION AND REQUEST FOR ALLOWANCE AND PAYMENT OF ADMINISTRATIVE EXPENSE CLAIM OF BOXLEY GROUP LLC

(Related to Docket No.876)

This stipulation and agreed order ("Stipulation and Agreed Order") regarding the Application and Request for Allowance and Payment of Administrative Expense Claim of Boxley Group, LLC ("Application") is by and between Janet, Northup, chapter 7 Trustee ("Trustee") for the bankruptcy estate of Country Fresh Holding Company Inc., *et al.* ("Debtors"), and Boxley Group, LLC) (Boxley Group, LLC and the Trustee on behalf of the Debtors are the "Parties"). The Parties hereby stipulate and agree as follows:

RECITALS

WHEREAS, between the period of May 10, 2021, and July 11, 2021, Boxley Group LLC provided financial transition services to the Debtors in the ordinary course of the Debtors' business.

The Debtors in these Chapter 11 cases, along with the last four digits of each Debtor's federal tax identification number, are: Country Fresh Holding Company Inc. (7822), Country Fresh Midco Corp. (0702), Country Fresh Acquisition Corp. (5936), Country Fresh Holdings, LLC (7551), Country Fresh LLC (1258), Country Fresh Dallas, LLC (7237), Country Fresh Carolina, LLC (8026), Country Fresh Midwest, LLC (0065), Country Fresh Orlando, LLC (7876), Country Fresh Transportation LLC (8244), CF Products, LLC (8404), Country Fresh Manufacturing, LLC (7839), Champlain Valley Specialty of New York, Inc. (9030), Country Fresh Pennsylvania, LLC (7969), Sun Rich Fresh Foods (NC) Inc. (5526), Sun Rich Fresh Foods (USA) Inc. (0429), Sun Rich Fresh Foods (PA) Inc. (4661). The Debtors' principal place of business is 3200 Research Forest Drive, Suite A5, The Woodlands, TX, 77381.

WHEREAS, on February 15, 2021 (the "Petition Date"), each Debtor filed a voluntary

petition for relief under chapter 11 of the Bankruptcy Code;

WHEREAS, on June 21, 2021, the Court entered an Order (I) Authorizing and Approving

the Conversion of the Chapter 11 Cases, (II) Extending the Designation Rights Period, and (III)

Granting Related Relief at Docket No. 719;

WHEREAS, on June 21, 2021, the Trustee was appointed as the Chapter 7 Trustee in the

above-referenced case;

WHEREAS, on August 20, 2021, Boxley Group LLC filed its Application, asserting that

it was entitled to an administrative expense claim for services provided to the Debtors on a post-

petition in the amount of \$68,071.21;

WHEREAS, Boxley Group LLC attached to its Application copies of (a) the invoices

comprising its administrative claim (the "Invoices"); and

WHEREAS, the Parties have reached an agreement regarding the Application.

NOW, THEREFORE, IT IS HEREBY STIPULATED, AGREED, AND ORDERED

AS FOLLOWS:

1. Boxley Group, LLC shall have an allowed administrative expense claim pursuant

to 11 U.S.C. § 503(b)(9) against Country Fresh LLC in the amount of \$68,071.21; and

2. Payment of Boxley Group, LLC's allowed administrative claim shall be made at

such time as distributions are made to other administrative creditors, and in accordance with the

priorities under the Bankruptcy Code.
