**AGREED ORDER EXTENDING THE DEADLINES FOR (I) THE LIQUIDATING TRUSTEE TO OBJECT TO THE ARH ENTITIES' APPLICATION FOR ALLOWANCE AND PAYMENT OF ADMINISTRATIVE CLAIM AND (II) THE ARH ENTITIES TO FILE ANY ARH PREPETITION CLAIM**

This matter is before the Court by agreement of Ellen Kennedy, solely in her capacity as the Liquidating Trustee (the "Liquidating Trustee") of the Cambrian Liquidating Trust (the "Liquidating Trust"), and Appalachian Regional Healthcare, Inc., ARH Mary Breckinridge Health Services, Inc., and ARH Tug Valley Health Services, Inc. (collectively the "ARH Entities") to extend the deadlines set forth in the prior Agreed Order [*See* Docket No. 1816] (i) for the Liquidating Trustee to object to the ARH Entities' Application for Allowance and Payment of Administrative Claim and Reservation of Rights [Docket No. 1424] (the "ARH Administrative Claim") and (ii) for the ARH Entities to file a claim against the Debtors and their successors for ARH Claims (as defined in the ARH Order [Docket No. 1452]) incurred before the Petition Date (an "ARH Prepetition Claim"); the parties being in agreement, as evidenced by the signatures of undersigned counsel, and the Court being otherwise sufficiently advised;
