PLEASE TAKE NOTICE that, on September 2, 2021, Janet S. Northrup, the Chapter 7 Trustee (the "Trustee") of the bankruptcy estate of Country Fresh Holding Company, Inc et. al. (the "Debtors") filed her Trustee's Motion to for Authority (A) to Pay All Remaining Pre-Closing PACA Claims from the PACA Escrow Reserve, (B) to Release Any Remaining Escrowed Funds in the PACA Escrow Reserve to the Trustee, (C) to Expunge All Other PACA Claims and (D) for Related Relief [Dkt. No. 915] (the "PACA Motion"), which was filed with a proposed order at Docket No. 915-5 (the "Original Proposed Order") attaching at Exhibit 1 thereto a list of Remaining Unpaid PACA Claims (the "Original Remaining Unpaid PACA Schedule"). Since the filing of the PACA Motion, one PACA invoice was paid pursuant to the Stipulation and Agreed
