RECITALS

WHEREAS, Brothers Produce, Inc. attached to its Application copies of (a) the invoices comprising its administrative claim (the "<u>Invoices</u>");

WHEREAS, the Parties have reached an agreement regarding the Application;

NOW, THEREFORE, IT IS HEREBY STIPULATED, AGREED, AND ORDERED AS FOLLOWS:

1. Brothers Produce, Inc. shall have an allowed administrative expense claim pursuant to 11 U.S.C. § 503(b)(9) against Country Fresh LLC in the amount of \$10,128.00; and

2. Payment of Brothers Produce, Inc. is allowed administrative claim shall be made at such time as distributions are made to other administrative creditors, and in accordance with the priorities under the Bankruptcy Code.
