**CERTIFICATE OF COUNSEL WITH RESPECT TO REORGANIZED DEBTORS’
TWENTY-SECOND OMNIBUS OBJECTION TO CERTAIN PROOFS OF CLAIM
(AMENDED CLAIMS)**

Pursuant to the *Procedures for Complex Chapter 11 Cases in the Southern District of Texas*, the undersigned counsel for the above-captioned reorganized debtors (before the Effective Date of the Plan, the “Debtors,” and after the Effective Date of the Plan, the “Reorganized Debtors”) certifies as follows:

1. On September 10, 2021, the Reorganized Debtors filed their *Twenty-Second Omnibus Objection to Certain Proofs of Claim (Amended Claims)* [Docket No. 4011] (the “Objection”).

2. The deadline for parties to file responses to the relief requested in the Objection was October 12, 2021 (the “Objection Deadline”). The Reorganized Debtors received an informal response to the Objection from counsel for the Pennsylvania Department of Revenue (Claim 4799) indicating that the Pennsylvania Department of Revenue does not oppose the relief requested in the Objection.
