- 2. Pursuant to the Final Fee Applications, objections to each of the Final Fee Applications, if any, were to be filed and served no later than September 23, 2021 at 4:00 p.m. (prevailing Eastern Time) (the "**Objection Deadline**"). The Applicants received no responses or objections to the Final Fee Applications prior to the Objection Deadline. The hearing to consider approval of the Final Fee Applications is currently scheduled for October 27, 2021 at 11:30 a.m. (prevailing Eastern Time).
- 3. Given the lack of objections to the approval of the Final Fee Applications, the Debtors prepared a proposed form of order (the "Final Fee Order") approving the Final Fee Applications. A copy of the Final Fee Order is attached hereto as **Exhibit A**. The Final Fee Order has been circulated without objection to the Office of the United States Trustee for the District of Delaware. The Final Fee Order has also been circulated to counsel to the Liquidation Trustee (as defined in the *Debtors' Combined Disclosure Statement and Joint Chapter 11 Plan of Liquidation* [Docket No. 508-1]) and each Applicant, and the aforementioned parties do not object to the Bankruptcy Court's entry of the Final Fee Order.

WHEREFORE, the Debtors respectfully request that the Final Fee Order, substantially in the form attached hereto as **Exhibit A**, be entered at the earliest convenience of the Bankruptcy Court.
