ORDER GRANTING TRUSTEE'S FIRST INTERIM APPLICATION FOR COMPENSATION AND EXPENSES FOR JUNE 21, 2021 THROUGH AUGUST 31, 2021

The Court has considered the *Trustee's First Interim Application for Compensation and Expenses to Trustee for June 21, 2021 through August 31, 2021* (the "Application") filed by Janet S. Northrup, chapter 7 trustee (the "<u>Trustee</u>"). With all due and proper notice of the Application having been provided, it appears that no opposition to the Application has been filed. With good cause therefore having been shown, the Court hereby determines that interim compensation to the Trustee in the total amount of \$259,394.35, which includes \$258,649.14 of statutory compensation and \$745.21 of expenses, should be authorized.
