**ORDER DENYING J. FLEET OIL & GAS PRODUCTION  
COMPANY, L.L.C. AND MARTIN PRODUCING, L.L.C.'S MOTION  
FOR RELIEF FROM THE AUTOMATIC STAY AS TO THE DEBTORS  
CHESAPEAKE LOUISIANA, L.P., CHESAPEAKE OPERATING, INC., CHESAPEAKE  
ENERGY CORPORATION, AND CHESAPEAKE ENERGY MARKETING, INC.**

On October 22, 2020, the Court held a hearing on *J. Fleet Oil & Gas Production Company, L.L.C. and Martin Producing, L.L.C.'s Motion for Relief from the Automatic Stay as to the Debtors Chesapeake Louisiana, L.P., Chesapeake Operating, Inc., Chesapeake Energy Corporation, and Chesapeake Energy Marketing, Inc.* [Docket No. 1238] (the "Motion") and considered the Motion, objections, and arguments of counsel and found the Motion was properly noticed. Pursuant to Federal Civil Rule 52, made applicable in bankruptcy proceedings by Bankruptcy Rule 7052, the Court stated its findings of fact and conclusions of law on the record.

For the reasons set forth by the Court in its oral ruling, the Court finds and concludes that the Motion should be denied without prejudice. It is, therefore **HEREBY ORDERED THAT:**

1. The Motion is denied without prejudice.
