1. - 3. The Objection Deadline has passed for all parties other than the U.S. Trustee, and no objections to the Application appear on the docket or were served upon undersigned counsel. However, the U.S. Trustee informally raised concerns regarding the Application (the "Informal Objections").
- 4. The Debtors and the U.S. Trustee have negotiated in good faith to resolve the Informal Objections, and the Debtors have amended the proposed form of order approving the Application to reflect the agreement of the parties (the "Revised Order"). Moreover, at the request of the U.S. Trustee, McDermott Will & Emery LLP has filed a supplemental declaration in support of the Application [Docket No. 295] (the "Supplemental Declaration"). Counsel to the U.S. Trustee has reviewed the Revised Order and the Supplemental Declaration, and does not object to the entry of the Revised Order, which is attached hereto as <u>Exhibit A</u>. A blackline version of the Revised Order reflecting all changes from the form of final order submitted with the Application is attached hereto as <u>Exhibit B</u>.
